**CHAPTER G-5.1 REG 126**  
*The Government Organization Act*

**Title**

1 These regulations may be cited as *The Department of Environment Regulations, 2006*.

**Department continued**

2 The department of the Government of Saskatchewan called the Department of Environment is continued.

**Objects and purposes**

3(1) The objects and purposes of the Department of Environment are to provide the structure wherein and whereby the powers, responsibilities and functions of the Minister of Environment may be exercised and carried out and, with respect to those objects and purposes, to do the following:

(a) to co-ordinate, develop, promote and enforce policies and programs of the Government of Saskatchewan to protect and enhance the environment in a manner that promotes the physical, economic and social well-being of the people of Saskatchewan today and in the future;

(b) to co-ordinate, develop, promote and enforce policies and programs of the Government of Saskatchewan relating to the conservation, preservation, management, protection and development of fish, wildlife, air, water, forests, resource lands, parks and other renewable resources in Saskatchewan; and

(c) to co-ordinate, develop, promote and implement policies and programs of the Government of Saskatchewan relating to urban parks.
