MIDALE CENTRAL MIDALE BEDS POOL — CARBON DIOXIDE FLOOD PROJECT — HORIZONTAL WELL

MRO 114/92. The application submitted by Shell Canada Limited to drill a horizontal well as part of the carbon dioxide flood project in The Midale Unit is approved pursuant to section 17.1 of *The Oil and Gas Conservation Act*.
