CHAPTER R-20.3

An Act respecting Representation in the Legislative Assembly

(Assented to May 12, 1994)

HER MAJESTY, by and with the advice and consent of the Legislative Assembly of Saskatchewan, enacts as follows:

Short title

1 This Act may be cited as *The Representation Act, 1994*.

Composition of Assembly

2 Notwithstanding subsection 23(1) of *The Constituency Boundaries Act, 1993*, the Legislative Assembly shall consist of 58 members to be elected to represent the constituencies described in the Schedule to this Act.

3 *The Representation Act, 1989* is repealed.

Coming into force

4 Notwithstanding subsection 23(2) of *The Constituency Boundaries Act, 1993*, this Act comes into force on the day following the day the twenty-second Legislative Assembly is dissolved or is determined by effluxion of time.

SCHEDULE

Interpretation of Constituency Boundaries

Boundaries of constituencies

- 1 In the following descriptions, where “**meridians**” and “**boundaries of townships**” or “**boundaries of sections**” are referred to as the boundaries of constituencies, these expressions mean the meridians, boundaries of townships or boundaries of sections, as the case may be, in accordance with the dominion land survey system and include the extensions of the meridians, boundaries of townships or boundaries of sections in accordance with that system.

Dividing line

- 2 Where a dividing line between two ranges is mentioned as the boundary of a constituency, the expression means the surveyed line on the east boundary of the west range and the extension of that line southerly to intersect the north boundary of each township that lies to the south of a correction line and thence easterly along the north boundary of that township to the east boundary of that township.

North boundary

- 3 Where the north boundary of a township is mentioned as the boundary of a constituency and a jog exists between the north boundaries of a township on either side of a dividing line, the expression means that the boundary of the constituency follows along the portion of the dividing line that extends between the respective north boundaries of the township.

Section boundaries

- 4 Where boundaries of sections are mentioned as the boundary of a constituency and a correction line or jog exists between two section boundaries described, the expression means that the boundary of the constituency follows along the portion of the north boundary of a township or dividing line that extends between the respective section boundaries described.

Left bank boundary

- 5 Where the left bank of any river or creek is mentioned as the boundary of a constituency, the expression means the bank of that river or creek on the left side of a person going in the direction in which the water flows.

References as defined in *The Land Surveys Act*

- 6 Where in the following descriptions reference is made to “**meridian**”, “**township**” or “**range**” and the meridian, township or range lies outside the portion of the province subdivided in accordance with the provisions of *The Land Surveys Act*, the reference is taken to be in accordance with the projection of the meridian, township or range as defined in the Act.

Inclusion of hamlet, village or town cut by constituency boundary

- 7 When a constituency boundary cuts through a hamlet, village or town, and that hamlet, village or town has not been specifically mentioned in the constituency description, the boundary is to include the area of lesser population as lying within the constituency in which the part with the greater population lies.

References to limits of village, town or city

- 8 Where reference in descriptions of boundaries is made to limits or incorporated limits of any village, town or city, the reference means those limits defined as of July 1, 1993.

ARM RIVER

The constituency of Arm River is bounded as follows: Commencing at the intersection of the dividing line between ranges twenty-one and twenty-two, west of the second meridian and the north boundary of township eighteen; thence westerly along the north boundary of township eighteen to the dividing line between ranges six and seven, west of the third meridian; thence northerly along the said dividing line between ranges six

and seven to the north boundary of township nineteen; thence westerly along the north boundary of township nineteen to the dividing line between ranges seven and eight, west of the third meridian; thence northerly along the said dividing line between ranges seven and eight to the west limit of the full supply level of the reservoir known as Lake Diefenbaker; thence northerly along the west limit of the full supply level of the reservoir known as Lake Diefenbaker and continuing northerly along the left bank of the South Saskatchewan River to the south corporate limits of the Town of Outlook; thence westerly, northerly and easterly along the south, west and north corporate limits of the Town of Outlook to the left bank of the South Saskatchewan River; thence northerly along the left bank of the South Saskatchewan River to the north boundary of township thirty-four; thence easterly along the north boundary of township thirty-four to the dividing line between ranges three and four, west of the third meridian; thence southerly along the said dividing line between ranges three and four to the north boundary of township thirty-three; thence easterly along the north boundary of township thirty-three to the dividing line between ranges two and three, west of the third meridian; thence southerly along the said dividing line between ranges two and three to the north boundary of township thirty; thence easterly along the north boundary of township thirty to the third meridian; thence southerly along the third meridian to the north boundary of township twenty-seven; thence easterly along the north boundary of township twenty-seven to the east bank of Last Mountain Lake; thence southerly and easterly along the east and north bank of Last Mountain Lake to the north boundary of section five, township twenty-one, range twenty-one, west of the second meridian; thence westerly along the north boundary of sections five and six in township twenty-one, range twenty-one, west of the second meridian to the dividing line between ranges twenty-one and twenty-two, west of the second meridian; thence southerly along the said dividing line between ranges twenty-one and twenty-two to the point of commencement.

ATHABASCA

The constituency of Athabasca is bounded as follows: Commencing at the intersection of the north boundary of Meadow Lake Provincial Park and the west boundary of the province; thence northerly along the west boundary of the province to the north boundary of the province; thence easterly along the north boundary of the province to the meridian through the one hundred and fifth degree of west longitude; thence southerly along the said meridian of longitude to the fifty-ninth parallel of north latitude; thence westerly along the fifty-ninth parallel of north latitude to the third meridian; thence southerly along the third meridian to the north boundary of Prince Albert National Park; thence westerly and southerly along the north and west boundaries of Prince Albert National Park to the north boundary of township sixty; thence westerly along the north boundary of township sixty to the dividing line between ranges thirteen and fourteen, west of the third meridian; thence northerly along the said dividing line between ranges thirteen and fourteen to the north boundary of township sixty-four; thence westerly along the north boundary of township sixty-four to the east boundary of Meadow Lake Provincial Park; thence northerly and westerly along the east and north boundaries of Meadow Lake Provincial Park to the point of commencement.

BATTLEFORD - CUT KNIFE

The constituency of Battleford - Cut Knife is bounded as follows: Commencing at the intersection of the dividing line between ranges fifteen and sixteen, west of the third meridian and Whiteshore Lake; thence westerly along the north boundary of Whiteshore Lake to the north boundary of township thirty-six; thence westerly along the north boundary of township thirty-six to Tramping Lake; thence northerly along the west bank of Tramping Lake to the east boundary of section twenty, township thirty-eight, range twenty, west of the third meridian; thence northerly along the east boundary of sections twenty, twenty-nine and thirty-two, in township thirty-eight, range twenty, west of the third meridian and continuing northerly along the east boundary of sections four, nine, sixteen, twenty-one, twenty-eight and thirty-three, in township thirty-nine, range twenty, west of the third meridian to the north boundary of township thirty-nine; thence westerly along the north boundary of township thirty-nine to the dividing line between ranges twenty-five and twenty-six, west of the third meridian; thence southerly along the said dividing line between ranges twenty-five and twenty-six to the north boundary of township thirty-eight; thence westerly along the north boundary of township thirty-eight to the west boundary of the province; thence northerly along the west boundary of the province to the left bank of the Battle River; thence northeasterly along the left bank of the Battle River to the north boundary of township forty-six, range twenty four, west of the third meridian; thence easterly along the north boundary of township forty-six to the dividing line between ranges twenty-two and twenty-three,

west of the third meridian; thence southerly along the said dividing line between ranges twenty-two and twenty-three to the left bank of the Battle River; thence easterly along the left bank of the Battle River to the west boundary of the Little Pine and Lucky Man Indian Reserve No. 116; thence northerly, easterly and southerly along the west, north and east boundaries of Little Pine and Lucky Man Indian Reserve No. 116 to the left bank of the Battle River; thence easterly along the left bank of the Battle River to the dividing line between ranges nineteen and twenty, west of the third meridian; thence northerly along the said dividing line between ranges nineteen and twenty to the left bank of the North Saskatchewan River; thence southeasterly along the left bank of the North Saskatchewan River to the west corporate limit of the City of North Battleford; thence southerly and easterly along the west and south corporate limits of the City of North Battleford to the left bank of the North Saskatchewan River on the north boundary of section twenty-eight, township forty-three, range sixteen, west of the third meridian; thence southeasterly along the left bank of the North Saskatchewan River to the north boundary of township forty-two; thence westerly along the north boundary of township forty-two to the dividing line between ranges sixteen and seventeen, west of the third meridian; thence southerly along the said dividing line between ranges sixteen and seventeen to the north boundary of Grizzly Bear's Head and Lean Man's Indian Reserve No's 110 and 111; thence easterly and southerly along the north and east boundaries of Grizzly Bear's Head and Lean Man's Indian Reserve No's 110 and 111 to the north boundary of the Red Pheasant Indian Reserve No. 108; thence easterly, southerly and westerly along the north, east and south boundaries of Red Pheasant Indian Reserve No. 108 to the dividing line between ranges fifteen and sixteen, west of the third meridian; thence southerly along the said dividing line between ranges fifteen and sixteen to the point of commencement.

CANNINGTON

The constituency of Cannington is bounded as follows: Commencing at the southeast corner of the province; thence westerly along the south boundary of the province to the dividing line between ranges three and four, west of the second meridian; thence northerly along the said dividing line between ranges three and four to the north boundary of township three; thence westerly along the north boundary of township three to the dividing line between ranges six and seven, west of the second meridian; thence northerly along the said dividing line between ranges six and seven to the north boundary of township six; thence westerly along the north boundary of township six to the dividing line between ranges nine and ten, west of the second meridian; thence northerly along the said dividing line between ranges nine and ten to the north boundary of township twelve; thence easterly along the north boundary of township twelve to the second meridian; thence southerly along the second meridian to the north boundary of township eight; thence easterly along the north boundary of township eight to the east boundary of the province; thence southerly along the east boundary of the province to the point of commencement.

CANORA - PELLY

The constituency of Canora - Pelly is bounded as follows: Commencing at the intersection of the east boundary of the province and the north boundary of township thirty; thence westerly along the north boundary of township thirty to the east boundary of the Cote Indian Reserve No. 64; thence northerly and westerly along the east and north boundaries of the Cote Indian Reserve No. 64 to the east boundary of the Keeseekoose Indian Reserve No. 66; thence northerly along the east boundary of the Keeseekoose Indian Reserve No. 66 to the north boundary of township thirty-one; thence westerly along the north boundary of township thirty-one to the west boundary of the Keeseekoose Indian Reserve No. 66; thence southerly along the west boundary of the Keeseekoose Indian Reserve No. 66 and continuing southerly along the west boundary of the Cote Indian Reserve No. 64 to the north boundary of township thirty; thence westerly along the north boundary of township thirty to the second meridian; thence southerly along the second meridian to the north boundary of township twenty-seven; thence westerly along the north boundary of township twenty-seven to the dividing line between ranges twelve and thirteen, west of the second meridian; thence northerly along the said dividing line between ranges twelve and thirteen to the south boundary of Fishing Lake Indian Reserve No 89; thence easterly and northerly along the south and east boundaries of the Fishing Lake Indian Reserve No. 89 and continuing easterly and southeasterly along the north and northeast banks of Fishing Lake to the east boundary of section ten, township thirty-three, range eleven, west of the second meridian; thence southerly along the east boundary of sections ten and three, township thirty-three, range eleven, west of the second meridian, to the north boundary of township thirty-two; thence easterly along the north boundary of township thirty-two to the dividing line between ranges nine and ten, west of the second meridian; thence northerly along the said dividing line between ranges nine and ten to the north boundary of township thirty-three; thence easterly along the north boundary of township thirty-three to the dividing line between ranges six and seven, west of the second meridian; thence northerly along the said dividing line between ranges six and seven to the north boundary of township thirty-six; thence easterly along the north boundary of township thirty-six to the dividing line between ranges three and four, west of the second meridian; thence northerly along the said dividing line between ranges three and four to the north boundary of township forty-two; thence easterly along the north boundary of township forty-two to the east boundary of the province; thence southerly along the east boundary of the province to the point of commencement.

CARROT RIVER VALLEY

The constituency of Carrot River Valley is bounded as follows: Commencing at the intersection of the east boundary of the province and the north boundary of township forty-two; thence westerly along the north boundary of township forty-two to the east corporate limit of the Hamlet of Clemenceau; thence southerly, westerly and northerly along the east, south and west corporate limits of the Hamlet of Clemenceau to the north boundary of township forty-two; thence westerly along the north boundary of township forty-two to the dividing line between ranges nine and ten, west of the second meridian; thence southerly along the said dividing line between ranges nine and ten to the north boundary of section thirteen, township forty-one, range ten, west of the second meridian; thence westerly along the north boundary of sections thirteen to eighteen inclusive, township forty-one, range ten, west of the second meridian to the dividing line between ranges ten and eleven, west of the second meridian; thence southerly along the said dividing line between ranges ten and eleven to the north boundary of township forty; thence westerly along the north boundary of township forty to the dividing line between ranges twelve and thirteen, west of the second meridian; thence northerly along the said dividing line between ranges twelve and thirteen to the south corporate limit of the Village of Zenon Park; thence easterly, northerly and westerly along the south, east and north corporate limits of the Village of Zenon Park to the dividing line between ranges twelve and thirteen, west of the second meridian; thence northerly along the said dividing line between ranges twelve and thirteen to the north boundary of township forty-eight; thence westerly along the north boundary of township forty-eight to the dividing line between ranges fourteen and fifteen, west of the second meridian; thence northerly along the said dividing line between ranges fourteen and fifteen to the left bank of the Saskatchewan River; thence westerly along the left bank of the Saskatchewan River to the dividing line between ranges sixteen and seventeen, west of the second meridian; thence northerly along the said dividing line between ranges sixteen and seventeen to the north boundary of township fifty-one; thence easterly along the north boundary of township fifty-one to the dividing line between ranges fourteen and fifteen, west of the second meridian; thence northerly along the said dividing line between ranges fourteen and fifteen to the left bank of the Torch River; thence northwesterly along the left bank of the Torch River to the dividing line between ranges fifteen and sixteen, west of the second meridian; thence northerly along the said dividing line between ranges fifteen and sixteen to the north boundary of township fifty-five; thence easterly along the north boundary of township fifty-five to the dividing line between ranges eleven and twelve, west of the second meridian; thence southerly along the said dividing line between ranges eleven and twelve to the north limit of the full supply level of the reservoir known as Tobin Lake; thence easterly along the north limit of the full supply level of the reservoir known as Tobin Lake and continuing easterly along the right bank of the Saskatchewan River to the dividing line between ranges seven and eight, west of the second meridian; thence southerly along the said dividing line between ranges seven and eight to the north boundary of township fifty-four; thence easterly along the north boundary of township fifty-four to the east boundary of the province; thence southerly along the east boundary of the province to the point of commencement.

CUMBERLAND

The constituency of Cumberland is bounded as follows: Commencing at the intersection of the north boundary of township fifty-four and the east boundary of the province; thence westerly along the north boundary of township fifty-four to the dividing line between ranges seven and eight, west of the second meridian; thence northerly along the said dividing line between ranges seven and eight to the right bank of the Saskatchewan River; thence westerly along the right bank of the Saskatchewan River and continuing westerly along the north limit of the full supply level of the reservoir known as Tobin Lake to the dividing line between ranges eleven and twelve, west of the second meridian; thence northerly along the said dividing line between ranges eleven and twelve to the north boundary of township fifty-five; thence westerly along the north boundary of township fifty-five to the dividing line between ranges twenty-one and twenty-two, west of the second meridian; thence northerly along the said dividing line between ranges twenty-one and twenty-two to the north boundary of township fifty-seven; thence westerly along the north boundary of township fifty-seven to the third meridian; thence northerly along the third meridian to the fifty-ninth parallel of north latitude; thence easterly along the fifty-ninth parallel of north latitude to the meridian through the one hundred and fifth degree of west longitude; thence northerly along the said meridian of longitude to the north boundary of the province; thence easterly along the north boundary of the province to the east boundary of the province; thence southerly along the east boundary of the province to the point of commencement; and including therein that part of the Little Red River Indian Reserve No. 106 lying south of the north boundary of township fifty-seven.

CYPRESS HILLS

The constituency of Cypress Hills is bounded as follows: Commencing at the intersection of the dividing line between ranges eighteen and nineteen, west of the third meridian and the south boundary of the province; thence westerly along the south boundary of the province to the west boundary of the province; thence northerly along the west boundary of the province to the left bank of the Red Deer River; thence southeasterly along the left bank of the Red Deer River to the left bank of the South Saskatchewan River; thence easterly along the left bank of the South Saskatchewan River and continuing easterly along the north limit of the full supply level of the reservoir known as Lake Diefenbaker to the dividing line between ranges fifteen and sixteen, west of the third meridian; thence southerly along the said dividing line between ranges fifteen and sixteen to the north boundary of township eleven; thence westerly along the north boundary of township eleven to the dividing line between ranges eighteen and nineteen, west of the third meridian; thence southerly along the said dividing line between ranges eighteen and nineteen to the point of commencement.

ESTEVAN

The constituency of Estevan is bounded as follows: Commencing at the intersection of the dividing line between ranges three and four, west of the second meridian and the south boundary of the province; thence westerly along the south boundary of the province to the dividing line between ranges eighteen and nineteen, west of the second meridian; thence northerly along the said dividing line between ranges eighteen and nineteen to the north boundary of township three; thence easterly along the north boundary of township three to the dividing line between ranges fifteen and sixteen, west of the second meridian; thence northerly along the said dividing line between ranges fifteen and sixteen to the north boundary of township six; thence easterly along the north boundary of township six to the dividing line between ranges six and seven, west of the second meridian; thence southerly along the said dividing line between ranges six and seven to the north boundary of township three; thence easterly along the north boundary of township three to the dividing line between ranges three and four, west of the second meridian; thence southerly along the said dividing line between ranges three and four to the point of commencement.

HUMBOLDT

The constituency of Humboldt is bounded as follows: Commencing at the intersection of the dividing line between ranges twenty-one and twenty-two, west of the second meridian, and the north boundary of township thirty-six; thence westerly along the north boundary of township thirty-six to the east corporate limit of the City of Saskatoon; thence northerly and westerly along the east and north corporate limits of the City of Saskatoon to the left bank of the South Saskatchewan River; thence northeasterly along the left bank of the South Saskatchewan River to the north boundary of township forty-five A, range twenty-seven, west of the second meridian; thence easterly on the north boundary of township forty-five A, and continuing easterly on the north boundary of township forty-five to the dividing line between ranges twenty-four and twenty-five, west of the second meridian; thence southerly along the said dividing line between ranges twenty-four and twenty-five to the north boundary of township forty-two; thence easterly along the north boundary of township forty-two to the dividing line between ranges twenty and twenty-one, west of the second meridian; thence southerly along the said dividing line between ranges twenty and twenty-one to the north boundary of township thirty-eight; thence westerly along the north boundary of township thirty-eight to the dividing line between ranges twenty-one and twenty-two, west of the second meridian; thence southerly along the said dividing line between ranges twenty-one and twenty-two to the point of commencement.

INDIAN HEAD - MILESTONE

The constituency of Indian Head - Milestone is bounded as follows: Commencing at the intersection of ranges nine and ten, west of the second meridian and the north boundary of township nine; thence westerly along the north boundary of township nine to the dividing line between ranges twenty-one and twenty-two, west of the second meridian; thence northerly along the said dividing line between ranges twenty-one and twenty-two to the north boundary of township fifteen; thence easterly along the north boundary of township fifteen to the dividing line between ranges sixteen and seventeen, west of the second meridian; thence northerly along the said dividing line between ranges sixteen and seventeen to the north boundary of township eighteen; thence westerly along the north boundary of township eighteen to the dividing line between ranges eighteen and nineteen, west of the second meridian; thence northerly along the said dividing line between ranges eighteen and nineteen and continuing northerly along the west boundary of the Piapot Indian Reserve No. 75 to the left bank of the Qu'Appelle River; thence easterly along the left bank of the Qu'Appelle River to Pasqua Lake; thence easterly along the north bank of Pasqua Lake to the left bank of the Qu'Appelle River; thence easterly along the left bank of the Qu'Appelle River to Echo Lake; thence easterly and southerly along the north and east banks of Echo Lake to the left bank of the Qu'Appelle River; thence easterly along the left bank of the Qu'Appelle River to Mission Lake; thence easterly and southerly along the north and east banks of Mission Lake to the left bank of the Qu'Appelle River; thence easterly along the left bank of the Qu'Appelle River to Katepwa Lake; thence easterly and southerly along the north and east banks of Katepwa Lake to the left bank of the Qu'Appelle River; thence southeasterly along the left bank of the Qu'Appelle River to dividing line between ranges ten and eleven, west of the second meridian; thence southerly along the said dividing line between ranges ten and eleven and continuing southerly along the east boundary of the Assiniboine Indian Reserve No. 76 to the north boundary of township fifteen; thence easterly along the north boundary of township fifteen to the dividing line between ranges nine and ten, west of the second meridian; thence southerly along the said dividing line between ranges nine and ten to the point of commencement; excluding all that portion contained within the corporate limits of the Resort Village of Katepwa South.

KELVINGTON - WADENA

The constituency of Kelvington - Wadena is bounded as follows: Commencing at the intersection of the dividing line between ranges nine and ten, west of the second meridian and the north boundary of township thirty-two; thence westerly along the north boundary of township thirty-two to the east boundary of section three, township thirty-three, range eleven, west of the second meridian; thence northerly along the east boundary of sections three and ten, township thirty-three, range eleven, west of the second meridian to Fishing Lake; thence northwesterly and westerly along the northeast and north banks of Fishing Lake to the east boundary of Fishing Lake Indian Reserve No. 89; thence southerly, westerly northerly and easterly along the east, south, west and north boundaries of Fishing Lake Indian Reserve No. 89 to the dividing line between ranges twelve and thirteen, west of the second meridian; thence northerly along the said dividing line between ranges twelve and thirteen to the north boundary of township thirty-three; thence westerly along the north boundary of township thirty-three to the dividing line between ranges fifteen and sixteen, west of the second meridian; thence northerly along the said dividing line between ranges fifteen and sixteen to the north boundary of township thirty-six; thence westerly along the north boundary of township thirty-six to the dividing line between ranges twenty-one and twenty-two, west of the second meridian; thence northerly along the said dividing line between ranges twenty-one and twenty-two to the north boundary of township thirty-eight; thence easterly along the north boundary of township thirty-eight to the dividing line between ranges twenty and twenty-one, west of the second meridian; thence northerly along the said dividing line between ranges twenty and twenty-one to the north boundary of township forty-two; thence easterly along the north boundary of township forty-two to the dividing line between ranges twelve and thirteen, west of the second meridian; thence southerly along the said dividing line between ranges twelve and thirteen to the north boundary of township forty; thence easterly along the north boundary of township forty to the dividing line between ranges ten and eleven, west of the second meridian; thence northerly along the said dividing line between ranges ten and eleven to the north boundary of section eighteen, township forty-one, range ten, west of the second meridian; thence easterly along the north boundary of sections eighteen to thirteen inclusive, township forty-one, range ten, west of the second meridian, to the dividing line between ranges nine and ten, west of the second meridian; thence northerly along the said dividing line between ranges nine and ten to the north boundary of township forty-two; thence easterly along the north boundary of township forty-two to the west corporate limit of the Hamlet of Clemenceau; thence southerly, easterly and northerly along the west, south and east corporate limits of the Hamlet of Clemenceau to the north boundary of township forty-two; thence easterly along the north boundary of township forty-two to the dividing line between ranges three and four, west of the second meridian; thence southerly along the said dividing line between ranges three and four to the north boundary of township thirty-six; thence westerly along the north boundary of township thirty-six to the dividing line between ranges six and seven, west of the second meridian; thence southerly along the said dividing line between ranges six and seven to the north boundary of township thirty-three; thence westerly along the north boundary of township thirty-three to the dividing line between ranges nine and ten, west of the second meridian; thence southerly along the said dividing line between ranges nine and ten to the point of commencement.

KINDERSLEY
