CHAPTER 27

An Act to make consequential amendments resulting from the
enactment of *The Small Claims Act, 2016*

(Assented to November 30, 2016)

HER MAJESTY, by and with the advice and consent of the Legislative Assembly of Saskatchewan, enacts as follows:

Short title

1 This Act may be cited as *The Small Claims Consequential Amendments Act, 2016*.

R.S.S. 1978, c.D-28, section 36.2 amended

2(1) Section 36.2 of *The Direct Sellers Act* is amended in the manner set forth in this section.

(2) Subsection (1) is amended in the portion preceding clause (a) by striking out “*The Small Claims Act*” and substituting “*The Small Claims Act, 2016*”.

(3) Subsection (2) is amended by striking out “*The Small Claims Act*” and substituting “*The Small Claims Act, 2016*”.

S.S. 1990-91, c.L-10.1, new section 73.1

3 Section 73.1 of *The Legal Profession Act, 1990* is repealed and the following substituted:

“Action pursuant to *The Small Claims Act, 2016* for fees and disbursements

73.1(1) If, in an action pursuant to *The Small Claims Act, 2016* respecting a bill of fees and disbursements with respect to services performed by a member, an issue arises respecting the amount of the bill and no application has been made pursuant to section 67, the judge, notwithstanding section 67, has jurisdiction to determine the amount of the bill.

(2) Subject to an appeal pursuant to *The Small Claims Act, 2016*, a determination by a judge pursuant to subsection (1) is final”.

Further consequential amendments

4 The provisions of the Acts set out in Table 1 of the Schedule are amended by striking out “*The Small Claims Act, 1997*” wherever it appears and in each case substituting “*The Small Claims Act, 2016*”.

Coming into force

5 This Act comes into force on the day on which section 1 of *The Small Claims Act, 2016* comes into force.
