**CHAPTER 94**

**An Act concerning the City of Weyburn and the Grand Trunk Pacific  
Saskatchewan Railway**

(Assented to December 19, 1913)

**Preamble**

WHEREAS the line of the Grand Trunk Pacific Saskatchewan Railway Company from the city of Regina to Northgate on the international boundary passes the city of Weyburn about twenty miles to the east;

And whereas it is deemed by the council of the city of Weyburn to be in the interests of the said city that the said Grand Trunk Pacific Saskatchewan Railway Company should construct and operate a line of railway from Talmage or some other point on the said line, to the city of Weyburn and to that end that the said city of Weyburn should be authorised to enter into an agreement with the said Grand Trunk Pacific Saskatchewan Railway Company and to expropriate and grant to the said Grand Trunk Pacific Saskatchewan Railway Company certain lands for the purposes of the said company;

And whereas the city of Weyburn has presented a petition to the Legislature of the Province of Saskatchewan praying that a Bill be passed for the said purposes;

And whereas it is expedient to grant the prayer of the said petition:

Now therefore His Majesty by and with the advice and consent of the Legislative Assembly of Saskatchewan enacts as follows:

**City may enter agreement**

**1** It shall be lawful for the city of Weyburn through the council thereof to enter into an agreement with the Grand Trunk Pacific Saskatchewan Railway Company concerning the construction and operation of a line of railway from Talmage, or some other point on the Regina-Northgate line of the Grand Trunk Pacific Saskatchewan Railway to the said city of Weyburn and the transfer by the said city to the said company for the purposes of the railway of such lands as may be agreed upon.

**City may acquire necessary real estate**

**2** The city of Weyburn shall be empowered to acquire real property within or without the city as may be requisite to enable the city to fulfil the terms of any agreement that may be made in pursuance of the provisions of section 1 hereof and to transfer such property when so acquired to the said Grand Trunk Pacific Saskatchewan Railway Company.

**Expropriation**

**3** In case the council of the said city cannot acquire the land at a fair price by agreement with the owners or occupiers thereof or the persons interested therein the provisions of sections 244 to 258 inclusive of *The City Act* and the amendments thereof shall be deemed to be and shall be applicable to the provisions of this Act.
