CHAPTER 115

An Act to incorporate The District Advisory Board of the Manitoba-Saskatchewan Church of the Nazarene

(Assented to April 4, 1946)

Preamble

WHEREAS the members of the Church of the Nazarene from the Province of Manitoba and Saskatchewan have a District Advisory Board consisting of the District Superintendent and four members elected at the District Assembly of the Church from the members thereof; and

Whereas the members of the District Advisory Board are Alfred G. Blacklock, District Superintendent, Arnold E. Airhart, James O. Clark, Arthur W. Bowsby and Ralph L. Morris; and

Whereas the function of the said District Advisory Board is to supervise all of the business and the affairs of the Church of the Nazarene within the Province of Saskatchewan on behalf of the District Assembly of the Manitoba-Saskatchewan District Church of the Nazarene between sessions of the said assembly and as such supervisory organization is required to do everything necessary to extend the Kingdom of God through the instrumentality of the churches located in the Province of Saskatchewan, in accordance with the manual of the Church of the Nazarene, as contained in its Church Constitution, Special Rules, and government for the local Churches and District Assemblies; and to provide for means for the convenient carrying on of the financial activities of the church, to handle real estate acquired for the benefit and in the interest of the church and to administer trust funds acquired by or on behalf of the church in the interests of the church and its work; and

Whereas the said Advisory Board believing that it would tend greatly to assist its work on behalf of the Church of the Nazarene in the Province of Saskatchewan if the said Advisory Board was incorporated has presented a petition praying to be vested with corporate powers; and

Whereas it is expedient to grant the prayer of the said petition:

Therefore His Majesty, by and with the advice and consent of the Legislative Assembly of Saskatchewan, enacts as follows:

Incorporation

1 Alfred G. Blacklock, District Superintendent, Arnold E. Airhart, James O. Clark, Arthur W. Bowsby and Ralph L. Morris, the members of the District Advisory Board of the Manitoba-Saskatchewan Church of the Nazarene and their successors in office are constituted a body corporate under the name of The District Advisory Board of the Manitoba-Saskatchewan Church of the Nazarene.

Head office

2 The head office of the corporation shall be at Saskatoon in the Province of Saskatchewan, or at such other place as may be determined by bylaw.

Powers

3 In addition to the powers, rights and privileges conferred upon or vested in corporations by the laws of Saskatchewan, the corporation shall have full power and authority:

Acquisition of property

(a) to acquire, have, hold possess and enjoy lands, tenements, hereditaments, rents, annuities and other property, movable and immovable, real and personal of any kind whatsoever, either absolutely or in trust for the Church of the Nazarene; provided that the corporation shall not acquire or hold as purchaser any land except for the actual use and occupation of the corporation or a branch thereof, or for the purposes of the corporation or for the actual use and occupation of the Church of the Nazarene in the Province of Saskatchewan, exceeding in the whole at any time the annual value of \$10,000 and that lands, tenements, hereditaments acquired by gift, devise or bequest and not required for the purpose of the corporation the annual value of which together with the land of the corporation exceed \$10,000 shall not be held by the corporation for a longer period than seven years and within such period the same shall be absolutely disposed of by the corporation and in case of failure to dispose of the same within such seven years such land shall be forfeited to the Crown in the right of the province;

Disposal of property

(b) to sell, transfer, mortgage, hypothecate, lease, exchange, or otherwise deal with or dispose of any of its real or personal property or any estate or interest therein or part thereof and with the proceeds thereof to acquire other real and personal property to such extent as may be deemed advisable or desirable or to use such proceeds in the carrying on of its ordinary activities on behalf of the Church of the Nazarene;

Investments

(c) to invest all of any sums of money belonging to the corporation in any property or security whatsoever for the use and purposes of the corporation;

Lending

(d) to lend or give any of its property, funds or moneys for or to assist in the erection or maintenance of any building or buildings deemed necessary for any church, college, manse, school or hospital, or for any other religious, charitable, educational congregational or social purpose related to the work of the Church of the Nazarene upon such terms and securities as to repayment as it may deem expedient;

Acquisition of pledged property

(e) to acquire, take possession of and hold as the corporation may deem proper all such property (real, personal or mixed) as may at any time be mortgaged, hypothecated or pledged to the corporation by way of security or conveyed to it in satisfaction of obligations or debts due or owing to it from any person, firm or corporation:

provided that any real estate acquired in satisfaction of any debts due to itself and not required for the actual use and occupation of the corporation or a branch thereof or for the purposes of the corporation or for the actual use and occupation of the Churches of the Nazarene in the Province of Saskatchewan the annual value of which together with the other lands of the corporation exceeds \$10,000 shall be sold by the corporation within seven years after such acquisition or within such further period to which the term shall be extended by order of the Lieutenant Governor in Council, otherwise such real estate shall be forfeited to the Crown in the right of the province;

Collections

(f) to exercise all rights and remedies for the collection or repayment of moneys owing to it in the same manner and to the same extent as any individual may do;

Borrowing

(g) to borrow from any person, firm or corporation such sum or sums of money as may be found necessary for the purposes of the corporation and to secure any loan to the lender or lenders by bonds, debentures, bills of exchange, promissory notes, mortgages or any other instrument or instruments that may be required or deemed necessary or advisable by the lender or lenders;

Buildings, etc.

(h) to acquire by gift, purchase or otherwise or to build, erect and enlarge, and to manage and conduct all such halls, houses and other buildings as may be found or deemed necessary or convenient for carrying on the objects of the corporation, and to do all such things as may be deemed necessary to attain all such objects;

Fees

(i) to fix, charge and collect fees for any services rendered by the corporation and for the board and lodging of students and patients;

Affiliation

(j) to make and enter into treaties, contracts and arrangements for affiliating with the corporation any other corporation having similar objects;

Corporate seal

(k) to adopt a corporate seal and to change it at will;

Bylaws

(l) to make bylaws, rules, orders and regulations for the government and proper administration of its property, affairs and interests, and generally for the internal government of its affairs and from time to time to repeal and amend the same;

Guarantees

(m) to guarantee, as joint maker, endorser, covenanter or otherwise, loans secured by bonds, debentures, bills of exchange, promissory notes, mortgages or other instruments of any church of the Church of the Nazarene in the Province of Saskatchewan or of any society or corporation formed for the religious, charitable, educational, congregational or social purpose of the Church of the Nazarene in the Province of Saskatchewan;

Publishing and printing establishments

(n) to publish and print or cause to be published and printed books, pamphlets and literature of a religious nature pertaining to the work of the Church of the Nazarene and for such purpose to erect plants, purchase machinery and generally to enter into all and any contracts required for the accomplishment of such purpose;

General

(o) to do any and all other things that are incidental or conducive to the attainment of the objects for which the corporation is established, namely, to further the missionary, educational, benevolent and religious work of the Church of the Nazarene and to promote and advance charity and benevolence.

Branches

4 The corporation may from time to time establish branches and in connection therewith may appoint subordinate officers with such powers and tenure of office as may be deemed advisable.

Attorneys

5 The corporation may appoint one or more attorneys for the transaction of its business.

Execution of documents

6 Unless and until the bylaws of the corporation otherwise provide, all transfers, deeds of sale, leases, mortgages and other documents shall be executed with the seal of the corporation attested by the signature of the chairman and the secretary.

Industries

7 The corporation may operate any industry that may help to maintain its institutions and may bargain and sell the products of the same provided it conforms to the laws of the province.

Returns

8 The corporation shall at all times, when called upon to do so by the Lieutenant Governor in Council, render an account of its property and affairs.
