CHAPTER 113

An Act to incorporate the Grand Chapter of Saskatchewan,
Order of the Eastern Star

(Assented to March 24, 1952)

Preamble

WHEREAS the Grand Chapter of Saskatchewan, Order of the Eastern Star has existed in the Province of Saskatchewan since May 16, 1916, and is composed of a number of constituent or subordinate chapters, each of which is a separate entity; and

Whereas the persons hereinafter named have by their petition prayed for an Act incorporating them and such others as are now or may hereafter be associated with them in the said Grand Chapter, under the name of Grand Chapter of Saskatchewan, Order of the Eastern Star; and

Whereas it is expedient to grant the prayer of the said petition:

Therefore Her Majesty, by and with the advice and consent of the Legislative Assembly of Saskatchewan, enacts as follows:

Incorporation

1 Ethel E. Carss of Kamsack, Charles Ellis-Toddington of Moose Jaw, Blanche O. Gardner of Moose Jaw, John Rogers of Rouleau, Caroline Smith of Rosetown, John Murdoch McLeod of Indian Head, John McIntosh and S. Oswell Robinson of Regina, all in the Province of Saskatchewan, together with such other persons as now are or may hereafter from time to time become members of the said Grand Chapter, shall be and are hereby constituted and declared to a body corporate and politic under the name of Grand Chapter of Saskatchewan, Order of the Eastern Star, hereinafter called the Grand Chapter.

Powers

2(1) The Grand Chapter shall have full power and authority to establish constituent or subordinate chapters in the Province of Saskatchewan, and the name of each chapter now existing or hereafter regularly constituted shall be as follows: "_____ Chapter No._____, Order of the Eastern Star".

(2) The Grand Chapter and each constituent or subordinate chapter shall have the powers, rights and privileges conferred upon or vested in corporations by the laws of Saskatchewan and in addition thereto shall have full power and authority:

Acquisition of property

(a) to hold, possess or acquire by purchase, lease, exchange, donation, devise, bequest, endowment, or otherwise, property both equal and personal necessary or useful for the carrying out of its purposes and objects and may sell, lease, mortgage, pledge, hypothecate or alienate such property in any manner;

Investments

(b) to invest all or any of its moneys in such manner and in such securities as may be deemed expedient and to sell, vary and transpose such securities or investments;

Borrowing

(c) to borrow on its credit and assets such sum or sums of money as may be necessary and expedient for carrying out its purposes and objects and to secure any such loan by bonds, debentures, bills of exchange, promissory notes, mortgages or otherwise, and to pledge its personal property, present or future, and hypothecate, mortgage or pledge its real property, present or future, as such security;

Bylaws

(d) to make from time to time rules, regulations and bylaws not contrary to this Act or repugnant to the laws of the province for its constitution and government and for the guidance of its officers and to alter, amend and annul such rules, regulations and bylaws;

Application of property

(e) to apply and appropriate exclusively to its purposes and to no other object, institution or establishment whatever all the property, real or personal, which shall at any time belong to it as well as the revenues thereof;

Provided that none of the powers of a constituent or subordinate chapter shall be exercised in a manner inconsistent with rules, regulations or bylaws from time to time made by the Grand Chapter.

Registration

3 The real property of any constituent or subordinate chapter may be registered in the proper land titles office in the name of Grand Chapter of Saskatchewan, Order of the Eastern Star, or in the name of the constituent or subordinate chapter, as the constituent or subordinate chapter may deem expedient.

Execution of documents

4 All deeds, bonds, debentures, mortgages, transfers, assurances, conveyances, contracts and other instruments, shall be executed:

(a) in the case of instruments to be executed by the Grand Chapter, under its common seal attested by the signatures of its proper officers in that behalf, according to its rules, regulations and bylaws; and

(b) in the case of instruments to be executed by a constituent or subordinate chapter, under its common seal attested by the signatures of its Worthy Matron and secretary for the time being, unless and until its rules, regulations and bylaws otherwise provide.

Liability of members for debts of corporation

5 No member or officer of the Grand Chapter or of a constituent or subordinate chapter shall be liable for the debts of the Grand Chapter or of the constituent or subordinate chapter, as the case may be, beyond the amount of his annual dues remaining unpaid.
