CHAPTER 74

An Act respecting the merger and amalgamation of Saskatchewan
Farmers' Union with others to constitute National Farmers Union

(Assented to April 16, 1971)

Preamble

WHEREAS United Farmers of Canada, Saskatchewan Section, Limited, was incorporated by chapter 84 of the *Statutes of Saskatchewan, 1927*; and

Whereas the name of United Farmers of Canada, Saskatchewan Sections, Limited, was changed to Saskatchewan Farmers' Union by chapter 108 of the *Statutes of Saskatchewan, 1950*; and

Whereas Saskatchewan Farmers' Union together with others has petitioned to the Parliament of Canada for an enactment merging and amalgamating Saskatchewan Farmers' Union with other persons and bodies corporate, upon the consent of the Legislatures of the respective provinces having jurisdiction with respect to the bodies corporate, into a national organization to be known as National Farmers Union; and

Whereas Saskatchewan Farmers' Union has by petition prayed for an Act of the Legislature of Saskatchewan giving the consent of the Legislature to Saskatchewan Farmers' Union to so merge and amalgamate and has further prayed for the repeal of certain enactments; and Whereas it is expedient to grant the prayer of the said petition:

Therefore Her Majesty, by and with the advice and consent of the Legislative Assembly of Saskatchewan, enacts as follows:

Authorization to merger and amalgamation

1 Saskatchewan Farmers' Union is hereby authorized to enter into a merger and amalgamation with such other persons as are mentioned in section 2 of *An Act to incorporate National Farmers Union (Canada)* to constitute National Farmers Union.

Vesting of property, etc.

2 Upon certification by the Provincial Secretary that proof has been filed with him of the coming into force of *An Act to incorporate National Farmers Union (Canada)*:

(a) all property, real and personal, within the province of Saskatchewan, belonging to Saskatchewan Farmers' Union shall be vested in National Farmers Union;

(b) all trust funds or trust property of whatsoever nature held by Saskatchewan Farmers' Union or over which it exercises control and authority shall vest in National Farmers Union; and

c. 74 NATIONAL FARMERS UNION, MERGER AND AMALGAMATION

(c) subject to *An Act to incorporate National Farmers Union (Canada)*, members of Saskatchewan Farmers' Union shall become and be members of National Farmers Union.

Debts and obligations continued

3 Upon the vesting of the property of Saskatchewan Farmers' Union in National Farmers Union, National Farmers Union shall hold any trust property subject to the same conditions of trust under which Saskatchewan Farmers' Union held the property.

Land titles records to be altered

4 The registrar of each Land Titles Office in the province in which land or any document is registered or filed in respect of Saskatchewan Farmers' Union shall, upon the filing with him of a certificate from the Deputy Provincial Secretary setting out that proof of the coming into force of *An Act to incorporate National Farmers Union (Canada)* has been filed with the Provincial Secretary, substitute the words "National Farmers Union" for the words "Saskatchewan Farmers' Union" in such documents and records in the Land Titles Office as are specified by National Farmers Union.

Rights of creditors preserved

5 Nothing in this Act affects the rights of any creditor of, or any person having a claim against, Saskatchewan Farmers' Union, or impairs, modifies or affects the liability of Saskatchewan Farmers' Union; but all such rights may be asserted and continued against National Farmers Union which shall be responsible for all debts, liabilities and obligations of Saskatchewan Farmers' Union.

Saving

6 This Act applies only as far as the Legislature has jurisdiction to enact; and it is declared that the purpose and intent of the Legislature is to confine the provisions of this Act within the competence of the Legislature and every provision thereof shall be construed so as to give effect to that purpose and intent.

Repeal

7 Upon the coming into force of *An Act to incorporate National Farmers Union (Canada)*, Saskatchewan Farmers' Union shall file with the Provincial Secretary proof of the enactment and the coming into force thereof and on the date of the filing of such proof:

- (a) chapter 84 of the *Statutes of Saskatchewan, 1927*;
 - (b) chapter 90 of the *Statutes of Saskatchewan, 1928*; and
 - (c) chapter 108 of the *Statutes of Saskatchewan, 1950*;
- are repealed.
