**CHAPTER 107**

**An Act to provide for Exemption from Taxation of Certain Property of  
Prairie Christian Training Centre (United Church of Canada)**

(Assented to March 18, 1958)

**Preamble**

WHEREAS Prairie Christian Training Centre (United Church of Canada) is established by The United Church of Canada and is incorporated under *The Benevolent Societies Act* of the Province of Saskatchewan for the purposes of religious and educational leadership training; and

Whereas the said Prairie Christian Training Centre (United Church of Canada) has by petition prayed for exemption from taxation as hereinafter set forth of certain lands in the Rural Municipality of North Qu'Appelle No. 187; and

Whereas the Council of the Rural Municipality of North Qu'Appelle No. 187 has by resolution granted consent to the exemption of certain property of the said Prairie Christian Training Centre (United Church of Canada) from certain taxes; and

Whereas it is expedient to grant the prayer of the said petition:

Therefore Her Majesty, by and with the advice and consent of the Legislative Assembly of Saskatchewan, enacts as follows:

**Exemption from taxation**

1 The real property of Prairie Christian Training Centre (United Church of Canada) being all that portion of Legal Subdivision Thirteen (13) of Section Eighteen (18) in Township Twenty-one (21) in Range Thirteen (13) West of the Second Meridian, in the Vicinity of Fort Qu'Appelle in the Province of Saskatchewan, in the Dominion of Canada, containing Fifteen and Six one-tenths (15.6) acres, more or less, shown as Parcel "G" on a Plan of Record in the Land Titles Office for the Regina Land Registration District as No. FS 3530; and all that portion of Legal Subdivision Thirteen (13), in Section Eighteen (18), in Township Twenty-one (21), in Range Thirteen (13), West of the Second Meridian, in the Province of Saskatchewan, in the Dominion of Canada, described as follows:

Commencing at a point on the North boundary of the said legal subdivision distant Westerly thereon Three Hundred (300) feet from the North East corner of the said Legal Subdivision, thence Easterly along the said North boundary to the said North East corner, thence South Westerly along the North Westerly limit of Parcel G as shown on the Plan of Record in the Land Titles Office for the Regina Land Registration District as No. FS 3530 to the most Westerly corner of the said Parcel, thence North Westerly along the North Easterly limit of the unnamed road as shown on the Plan of Echomere of record in the said Land Titles Office as No. FB 4643 to the South Easterly limit of the lane South East of Block Three (3) as the said lane and block are shown on the said Plan No. FB 4643, thence North Easterly along the said South Easterly limit of the lane to the most Easterly corner of the said lane, thence North Westerly along the North Easterly limit of the said

lane Two Hundred and Seventy and one-tenths (270.1) feet more or less to an iron post, thence North Easterly in a straight line to the point of commencement; on record in the Land Titles Office, Regina, together with all buildings erected or to be erected thereon, shall, while owned by the said Corporation and used for religious and educational purposes, be exempt from all taxation, except for local improvement taxes, which the Rural Municipality of North Qu'Appelle No. 187 has the power to impose.
