CHAPTER G-5.1 REG 98

The Government Organization Act

Title

1 These regulations may be cited as *The Department of Industry and Resources Regulations*.

Department continued

2 The department of the Government of Saskatchewan called the Department of Energy and Mines is continued as the Department of Industry and Resources.

Objects and purposes

3(1) The objects and purposes of the Department of Industry and Resources are:

(a) to provide the structure wherein and whereby the powers, responsibilities and functions of the Minister of Industry and Resources may be exercised and carried out;

(b) to co-ordinate, develop, promote and implement policies and programs of the Government of Saskatchewan relating to:

(i) the exploration for and the development, management and conservation of non-renewable resources; and

(ii) the development, management and conservation of energy;

(c) to co-ordinate, develop, promote and implement policies and programs of the Government of Saskatchewan relating to encouraging the growth and expansion of the Saskatchewan economy; and

(d) to co-ordinate, develop, promote and implement policies and programs of the Government of Saskatchewan that support and encourage the development and growth of co-operatives;
