1 Pursuant to sections 53, 56, 57, 59, and 61 of *The Municipalities Act*, the Council of the Town of Esterhazy has submitted an application to alter its boundaries to the Minister of Government Relations.

2 Upon consideration of the application, the Minister is of the opinion that the municipalities affected will be viable entities following the alteration of boundaries. Therefore, the undersigned hereby orders, pursuant to sections 61, 62, and 63 of *The Municipalities Act*, that:

- (a) the boundaries of the Town of Esterhazy and the Rural Municipality of Fertile Belt No. 183 be altered by withdrawing from the rural municipality and adding to the town the territory described in Schedule A;
- (b) Schedule B is conclusively deemed to be the legal description of the boundary of the Town of Esterhazy; and
- (c) the alteration shall take effect on and from the date of this Order.
