**THE CATTLE DEVELOPMENT PLAN REGULATIONS – LEVY COLLECTION**

**Order No. 06/18.** The SASKATCHEWAN CATTLEMEN'S ASSOCIATION, pursuant to the provisions of *The Cattle Development Plan Regulations* and *The Agri-Food Act, 2004*, hereby determines and orders as follows:

**1(1)** Subject to section 4, every cattle producer shall:

- (a) for every head of cattle that the cattle producer sells in Saskatchewan; and
- (b) for every head of cattle raised or fed in Saskatchewan that the cattle producer delivers for sale outside Saskatchewan;

pay to the Commission a levy in the amount of \$4.50 per head of cattle made up of a \$2.00 refundable levy and a \$2.50 non-refundable levy.

**(2)** If the levy is not deducted and remitted by a buyer pursuant to section 2 the cattle producer shall:

- (a) pay the levy to the Commission; and
- (b) account to the Commission for the levy, in the form prescribed by the Commission by the 25th day of the month next following the month in which the cattle were sold in Saskatchewan or delivered for sale outside of Saskatchewan.

**2** Subject to section 4, when cattle are sold in Saskatchewan, the buyer:

- (a) shall deduct the levy from the proceeds of the sale for each head of cattle sold;
- (b) remit the levy to the Commission, in the form prescribed by the Commission, by the 25th day of the month next following the month in which the cattle were sold; and
- (c) provide to the cattle producer a document that clearly shows:
  - (i) the number of head of cattle sold;
  - (ii) the amount of the levy that was deducted;
  - (iii) the name, address and phone number of the buyer; and
  - (iv) the date of the transaction in respect of which the deduction was made.

**3** Subject to section 4, when cattle raised or fed in Saskatchewan are delivered to a livestock dealer or livestock agent for sale outside Saskatchewan, the livestock dealer or livestock agent shall:

- (a) deduct the levy from the proceeds of the sale for each head of cattle sold outside of Saskatchewan;
- (b) remit the levy to the Commission, in the form prescribed by the Commission, by the 25th day of the month next following the month in which the cattle were sold outside of Saskatchewan; and
- (c) provide to the cattle producer a document that clearly shows:
  - (i) the number of head of cattle sold;
  - (ii) the amount of the levy that was deducted;
  - (iii) the name, address and phone number of the buyer; and
  - (iv) the date of the transaction in respect of which the deduction was made.

4 This Order does not apply to any sale of cattle for which a levy is to be paid pursuant to the federal levies order.

5 Every buyer is entitled to receive an amount of five cents per head of cattle for which a levy is deducted and remitted in accordance with this Order.

6 Order No. 05/12 – Levy Collection is hereby wholly revoked.

7 This Order will remain in effect for a period no longer than ten years from the date this Order is approved by the Agri-Food Council.

4 Only one offer may be submitted by a production limit owner.

### Eligibility Requirements

5 An existing production limit owner must be in good standing pursuant to Article 11 of Board Order No. 41/06 – The Industry Management Order, and must meet the requirements of and be in compliance with *The Agri-Food Act, 2004*, *The Commercial Egg Marketing Plan Regulations*, and all Orders of SEP.

6 An existing production limit owner must also be in compliance with Board Order No. 54/11 – Start Clean-Stay Clean before production limits will be issued to that owner.

### Opening of Offers

7 After the closing date for receipt of offers, all offers will be opened privately by an independent party appointed by SEP in the presence of a scrutineer appointed by SEP who is not an employee, officer or director of SEP, nor a production limit owner.

### Award of Production Limits

8 Production limits will be awarded in accordance with the bids to a maximum of three point zero nine nine seven percent (3.0997 %) of the production limit currently owned by the bidding licensed producer. The successful bid price for each 25.44 dozen eggs (equivalent of one hen) will be twenty-five dollars (\$25).

### Terms of Purchase

9 Acceptance of an offer to purchase a production limit will create a binding contract between SEP and the purchaser.

10 The full purchase price offered must be delivered to SEP within 14 days of the offer being accepted. Payment must be in the form of a cheque, certified cheque, bank draft or money order payable to the Commercial Egg Producers' Trust Fund.

11 A production limit purchased under this Order must be put into production within one year of the purchaser receiving written notice of acceptance of the purchaser's offer, or in such longer period of time as SEP, in its sole discretion, may allow.

**12** A production limit may be put into production either directly in the facilities owned and operated by the purchaser, on land owned by the purchaser, or indirectly through a SEP-approved lease arrangement established in accordance with the Regulations.

**13** A production limit purchased under this Order shall be forfeited and cancelled if:

- (a) it has not been put into production in accordance with this Order; or
- (b) it is subsequently determined by the Board that the purchaser does not satisfy the eligibility or other requirements outlined in this Order.

**14** A production limit purchased under this Order may not be transferred by the production limit owner in accordance with the provisions of the Regulations prior to the fifth anniversary of the production limit being awarded.

**15** Production limits purchased under this Order are also subject to all applicable provisions and restrictions set out in the Regulations or SEP Orders.

### Withdrawal of Production Limits

**16** SEP reserves the right to withdraw any or all production limits offered for sale under the Order at any time before or after the closing time for receipt of offers. Unless and until SEP has accepted in writing an offer from a purchaser, a contractual relationship (either expressed or implied) is not created with any person submitting an offer in response to this Order.
