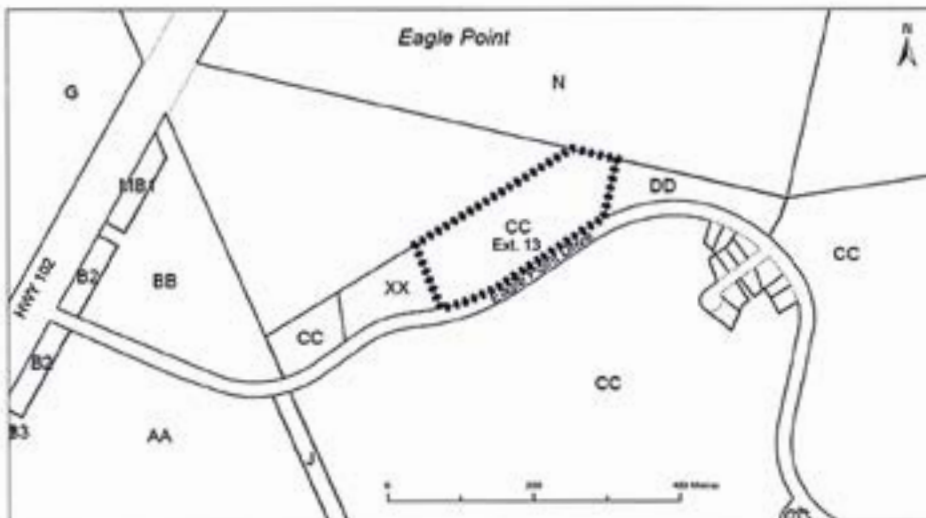

**2019 PROVISIONAL ASSESSMENT RATES**

**Background to Saskatchewan's Compensation System**

Saskatchewan's system of workers' compensation was founded in 1930 by a coalition of business and labour. Workers gave up the right to sue their employers for workplace injuries and losses resulting from those injuries. In turn, employers agreed to pay the cost of the compensation system. This working partnership provides fairness, protection, and economic stability when workplace injuries or illnesses occur.

The WCB and its Board Members act as trustees of this agreement between employers and workers. The agreement is based on five principles: no-fault compensation; security of benefits; collective employer liability; independence of the Board; and exclusive jurisdiction. These principles are the basis of a compensation system regarded as one of the most successful in North America.

The WCB's obligations are set out in *The Workers' Compensation Act, 2013*.

**Covering the Cost of the Compensation System**

The WCB has two sources of revenue: employer assessments based on payroll, and return on its investments.

Employer assessments, or premium rates, are set annually for each of the 50 industry rate codes. Premium rates are determined based on the claims costs and payroll within each industry rate code.

The premium rate setting process is based on the premise that today's employers are responsible for the cost of today's injuries. The WCB holds discussions with employers and associations regarding premium rates each year. This year, two public sessions were held with employers and associations.

**Notification of Rates**

In December, all Saskatchewan employers covered by the WCB are notified by letter of the 2019 rates. As required under subsection 134(4) of *The Workers' Compensation Act, 2013*, the WCB publishes the preliminary premium rates for any industry rate code that exceeds the 2018 premium rate by more than 10.5 percent.

Five rate codes will see a premium rate increase for 2019 greater than 10.5 percent:
