# The Provincial Lands Act, 2016 [section 2-5]

### [O.C. 624/2018] 13 DECEMBER 2018

On the recommendation of the undersigned, the Lieutenant Governor, by and with the advice and consent of the Executive Council, orders that:

(a) the Minister of Environment is authorized to withdraw the land identified below from the "Northern Provincial Forest"; and

(b) the Minister of Environment is approved to sell the provincial land identified below, for recreational purposes, to *Tim Shankowsky and Barrie Sorrell* of Norquay SK, for the total sale price of \$25,000 and to execute any required agreements related to the sale, on behalf of the Government of Saskatchewan:

Purchasers:
