SASKATCHEWAN REGULATIONS 98/2018*The Traffic Safety Act*

Subsection 287(5)

Minister's Order, dated December 5, 2018

(Filed December 19, 2018)

Title

1 These regulations may be cited as *The Vehicle Inspection Procedures Amendment Regulations, 2018*.

RRS c T-18.1 Reg 6 amended

2 *The Vehicle Inspection Procedures Regulations, 2007* are amended in the manner set forth in these regulations.

Section 2 amended

3 Subsection 2(1) is amended:

(a) by repealing clause (i) and substituting the following:

“(i) ‘instructions’ means any manual published by the administrator respecting inspection stations or vehicle inspections conducted pursuant to the Act and these regulations”; and

(b) by adding the following clause after clause (n):

“(n.1) ‘signing officer certificate’ means a signing officer certificate issued pursuant to section 9”.

Section 6 amended

4(1) Subsection 6(5) is repealed and the following substituted:

“(5) To be eligible for a stage 1 inspection station certificate, a repair facility must meet the equipment and station requirements set out in the instructions”.

(2) Subsection 6(6) is amended by striking out “The equipment, facilities and tools” and substituting “The equipment and station”.

Section 7 amended

5(1) Subsection 7(5) is repealed and the following substituted:

“(5) To be eligible for a stage 2 inspection station certificate, a repair facility must meet the equipment and station requirements set out in the instructions”.

(2) Subsection 7(6) is repealed.

(3) Subsection 7(7) is amended by striking out “The equipment, facilities and tools” and substituting “The equipment and station”.

Section 8 amended

6(1) Clause 8(1)(e) is repealed and the following substituted:

“(e) is able to complete the stage 1 inspection requirements in accordance with the instructions”.

(2) Clause 8(2)(f) is repealed and the following substituted:

“(f) is able to complete the stage 2 inspection requirements in accordance with the instructions”.

Section 9 amended

7 Section 9 is amended:

(a) by repealing the portion preceding clause (a) and substituting the following:

“The administrator may designate a signing officer for an inspection station and issue a signing officer certificate to an individual who:”; **and**

(b) in clause (d) by striking out “four working hours” and substituting “two working hours”.

Section 10 amended

8 Section 10 is amended:

(a) by repealing clause (c) and substituting the following:

“(c) maintain in good order all decals and documentation supplied by the administrator”;

(b) by striking out “and” after clause (h);

(c) by adding “and” after clause (i); and

(d) by adding the following clause after clause (i):

“(j) follow the instructions as published by the administrator”.

New section 11

9 Section 11 is repealed and the following substituted:

“Duties of a signing officer

11 A signing officer of an inspection station must:

(a) have on hand a supply of current vehicle inspection certificate forms for all types or classes of vehicles for which the station is authorized to perform vehicle safety inspections;

(b) on completion of a vehicle safety inspection and if a vehicle meets inspection requirements, provide a vehicle inspection certificate to the customer;

(c) ensure that the type of inspection indicated on a vehicle inspection certificate has been performed and completed on the date entered on the certificate and on the premises of the inspection station, unless otherwise authorized by the administrator;

(d) retain all documentation respecting vehicle inspections in the manner and for the periods set out in the instructions; and

(e) validate completed inspections in the manner set out in the instructions”.

New section 13

10 Section 13 is repealed and the following substituted:

“Inspections

13 In performing an inspection, an inspection mechanic must, in the manner set out in the instructions:

- (a) inspect all items specified for the applicable type of vehicle;
- (b) record whether all items inspected meet, exceed or do not meet the standards set out in the instructions; and
- (c) validate completed inspections”.

New section 14

11 Section 14 is repealed and the following substituted:

“Decal

14 On completion of a vehicle inspection, the inspection mechanic must affix a decal to the vehicle in the manner described in the instructions”.

Section 15 amended

12 Subsection 15(1) is amended:

- (a) in clause (b) by striking out “a taxi or”; and
- (b) in clause (d) by striking out the portion preceding subclause (i) and substituting:

“for a total loss vehicle, a taxi, a first-time registered vehicle or a vehicle that provides vehicle-for-hire services.”.

New section 15.1

13 The following section is added after section 15:

“Invoice

15.1 Subject to section 15, the owner of an inspection station that is open to the public must provide customers with an invoice itemizing the services performed and the products purchased, including the fees charged for the shop charge out rate, shop supplies and decals”.

Section 16 amended

14 Subsection 16(6) is repealed and the following substituted:

“(6) If a vehicle is not reinspected within the 30-day period or fails to meet the standards mentioned in section 3 on reinspection within the 30-day period, the inspection station shall, in the manner described in the instructions, advise the administrator that the vehicle is not properly certified”.

Section 17 amended

15 Clause 17(1)(b) is amended:

- (a) by striking out “and” after subclause (v); and
- (b) by adding the following after subclause (vi):

“(vii) in the case of a Class LV vehicle that provides vehicle-for-hire services as defined in *The Vehicles for Hire Act*; and

“(viii) in the case of a Class PT vehicle”.

New section 18**16 Section 18 repealed and the following substituted:****“Period of validity B inspection stations certificates**

18(1) An inspection station must hold a valid inspection station certificate in order to complete inspections on behalf of the administrator.

(2) An inspection station certificate is valid until a repair facility no longer meets the requirements of an inspection station pursuant to the Act and these regulations or until the certificate is revoked by the administrator”.

Coming into force

17 These regulations come into force on the day on which they are filed with the Registrar of Regulations.
