### CHAPTER C-43.1 REG 1

# The Court Officials Act, 1984

#### Title

1 These regulations may be cited as The Court Officials Regulations.

#### Interpretation

2 In these regulations, "Act" means The Court Officials Act, 1984.

#### Court reporters' fees

- **3**(1) The fees payable to court reporters who are not employees of the Government of Saskatchewan are the fees set out in Table 1.
- (2) All fees mentioned in subsection (1) are payable in advance unless other arrangements are made with the court reporter to whom the fees are payable.

#### Sheriff's seal

4 The seal of the sheriff is the seal set out in Table 2 and may be used to certify and authenticate the documentation of the sheriff.

#### Oath of office

5 The oath of office required to be taken by court officials is the oath set out in Form A and is to be taken before a person entitled to administer oaths in Saskatchewan.

#### Registry offices

**6** The Registrar of Courts and every local registrar shall attend his office and keep it open at the times set out in Table 3.

#### Sheriffs' offices

7 Each sheriff shall attend his office and keep it open from 8:00 a.m. to 5:00 p.m. on the days specified in the Act.
