**CHAPTER C-50.11 REG 1**  
*The Crown Employment Contracts Act*

**Title**

**1** These regulations may be cited as *The Crown Employment Contracts Regulations*.

**Interpretation**

**2** In these regulations, “**Act**” means *The Crown Employment Contracts Act*.

**Application form**

**3** Form A in the Appendix to these regulations is prescribed as the form for the purposes of clause 4(4)(a) of the Act.

**Fee**

**4** Every person who applies for access to Crown employment contracts under the Act shall pay a fee equal to:

(a) \$5 for every Crown employment contract applied for, to a maximum of \$50 for each application; and

(b) if the person wishes to receive a copy of any Crown employment contract, \$0.25 for each page of the contract.
