SASKATCHEWAN REGULATIONS 131/2005

The Hospital Standards Act

Sections 5 and 29

Order in Council 897/2005, dated December 6, 2005

(Filed December 7, 2005)

Title

1 These regulations may be cited as *The Hospital Standards Amendment Regulations, 2005*.

2 *The Hospital Standards Regulations, 1980*, being Saskatchewan Regulations 331/79, are amended in the manner set forth in these regulations.

- (c) by repealing clause (gg); and
- (d) by repealing clauses (mm), (nn), (oo), (pp) and (qq).

Coming into force

(2) If section 45 of *The Regional Health Services Act* comes into force before these regulations are filed with the Registrar of Regulations, these regulations come into force on the day on which they are filed with the Registrar of Regulations.

Order in Council 898/2005, dated December 6, 2005

Title

1 These regulations may be cited as *The Housing and Special-care Homes Amendment Regulations, 2005*.

2 The Housing and Special-care Homes Regulations, being Saskatchewan Regulations 34/66, are amended in the manner set forth in these regulations.

4 Subclause (a)(i) of section 4 of Part II is amended by striking out “Nursing staff shall be provided on a 24-hour basis” and substituting “Nursing care by a registered nurse or registered psychiatric nurse shall be provided on a 24-hour basis”.

Coming into force

5(1) Subject to subsection (2), these regulations come into force on the day on which *The Facility Designation Regulations* come into force.

(2) If these regulations are filed with the Registrar of Regulations after the day on which *The Facility Designation Regulations* come into force, these regulations come into force on the day on which they are filed with the Registrar of Regulations.
