The Municipal Board Act

Title

1 These regulations may be cited as *The Municipal Board Member Qualification Regulations*.

Interpretation

- 2 In these regulations:
 - (a) "Act" means The Municipal Board Act;
 - (b) **"board member"** means a person appointed to the board pursuant to section 4 of the Act;
 - (c) "rural municipal administrator's certificate" means a certificate of qualification at the A level or superior A level for a rural municipal administrator that is issued by a board of examiners appointed pursuant to section 11 of *The Department of Rural Development Act* in conformance with the requirements prescribed pursuant to that section or sections 9 and 11 of *The Rural Municipal Administrators Act*;
 - (d) "school division secretary-treasurer's certificate" means a certificate of qualification at the A level or advanced A level for a school division secretary-treasurer or superintendent of administration that is issued by a board of examiners appointed pursuant to regulations made under sections 106 and 372 of *The Education Act* in conformance with the requirements prescribed pursuant to those sections or by a board of examiners appointed pursuant to *The Larger School Unit Act*;
 - (e) "urban municipal administrator's certificate" means a certificate of qualification at the A level or superior A level for an urban municipal administrator that is issued by a board of examiners appointed pursuant to section 10 of *The Department of Urban Affairs Act* in conformance with the requirements prescribed pursuant to that section.

Qualifications

- **3** For the purposes of subsection 4(1) of the Act, a person shall possess the following qualifications in order to be appointed a board member:
 - (a) at least one of:
 - (i) a rural municipal administrator's certificate;
 - (ii) a school division secretary-treasurer's certificate;
 - (iii) an urban municipal administrator's certificate;

MUNICIPAL BOARD MEMBER QUALIFICATION

- (iv) membership in good standing in:
 - (A) the Institute of Chartered Accountants of Saskatchewan;
 - (B) the Certified General Accountants Association of Saskatchewan;
 - (C) the Society of Management Accountants of Saskatchewan;
 - (D) the Law Society of Saskatchewan;
 - (E) the Association of Professional Community Planners of Saskatchewan; or
 - (F) the National Fire Protection Association;
- (v) a certificate in assessment or appraisal from:
 - (A) a university acceptable to the Lieutenant Governor in Council;
 - (B) the Appraisal Institute of Canada;
 - (C) the International Association of Assessing Officers; or
 - (D) the Saskatchewan Assessors Association; or
- (vi) a degree from a university acceptable to the Lieutenant Governor in Council in a field of study that is relevant to some or all of the matters within the board's jurisdiction;
- (b) experience in conducting public hearings, appeals or meetings that involve hearing representations from local authorities and the public; and
- (c) in the opinion of the Lieutenant Governor in Council:
 - (i) an ability to analyze issues, to impartially consider arguments and to write decisions;
 - (ii) good communication and interpersonal skills;
 - (iii) a familiarity with the board's jurisdiction and with the relationship of the board to local authorities and to the Government of Saskatchewan; and
 - (iv) technical or substantive:
 - (A) knowledge; and
 - (B) experience;

that will assist the board in determining matters within the board's jurisdiction.
