## CHAPTER N-1 REG 1

# The Names of Homes Act

## Title

1 These regulations may be cited as *The Names of Homes Regulations*.

## Interpretation

- 2 In these regulations:
  - (a) "Act" means The Names of Homes Act;
  - (b) "certificate of status" means a certificate stating whether or not, at any time:
    - (i) a name is or was registered under the Act; or
    - (ii) a registration was amended or relinquished under the Act.

#### Fees

- **3**(1) The fee payable under the Act:
  - (a) for a certificate of registration is \$50;
  - (b) for a certificate of status is \$15;
  - (c) for a copy of a document is \$1 per page;
  - (d) for inspection of a document is \$2;
  - (e) for each computer printout of information respecting a registered name is \$10;
  - (f) subject to subsection (2), for a report containing a listing of names of homes is \$200 plus \$0.50 for each name in excess of 100 names;
  - (g) for verbally providing information from the register with respect to a name resgistered pursuant to the Act in respnse to a telephone request is \$8;
  - (h) for each enquiry to the register using computerized remote access:
    - (i) is \$2 for a name search; and
    - (ii) is \$3 for a profile report;
  - (i) for sending documents by electronic transmission is \$5.
- (2) Only one fee pursuant to clause (1)(f) or a comparable provision of *The Business Corporations Regulations*, *The Business Names Registration Regulations*, *The Co-operatives Regulations*, *1989*, *The Credit Union Regulations* or Saskatchewan Regulations 260/79 made pursuant to *The Non-profit Corporations Act* shall be charged where a report is prepared that includes names registered pursuant to *The Business Corporations Act*, *The Business Names Registration Act*, *The Co-operatives Act*, *1989*, *The Credit Union Act*, *1985* or *The Non-profit Corporations Act* in addition to names registered pursuant to the Act.
