CHAPTER N-5.1 REG 7

The Northern Municipalities Act

Title

1 These regulations may be cited as *The Northern Village of Beauval Boundary Designation Regulations*.

Boundaries

2 The boundaries described in the Appendix are designated as the boundaries of the Northern Village of Beauval.

3 The effect of the designation of the boundaries pursuant to section 2 is to add an area of unsurveyed land in the Northern Saskatchewan Administration District to the Northern Village of Beauval.

Appendix

The boundaries of the Northern Village of Beauval shall comprise the territory in the Province of Saskatchewan in the vicinity of latitude 55°, 09', longitude 107°, 37' bounded by a line described as follows:

Commencing at the iron post marked BI shown on Plan 87B01363; thence south westerly along the surveyed line shown on the said Registered Plan to the iron post marked BVI; thence south westerly parallel with the centre line of the driving surface of the unsurveyed road known as Highway Number 165 to its intersection with the north easterly limit of Parcel G shown on Plan 84B08019; thence north westerly, south westerly, north westerly and south westerly along the limits of said Parcel G to the most westerly corner of said Parcel G; thence south easterly along the south western limit of said Parcel G a distance of 1460 metres; thence south westerly and perpendicular to the south western limit of said Parcel G a distance of 700 metres; thence south easterly and perpendicular to the last described course a distance of 1250 metres; thence north easterly in a straight line to the iron post marked BX shown on Plan 87B01363; thence south easterly along the surveyed line shown on Plan 87B01363 to its intersection with the left bank of the Beaver River; thence north easterly and northerly along the left bank of the Beaver River to the point of commencement;
