CHAPTER Q-3 REG 1

The Queen's Printer Act

Title

1 These regulations may be cited as *The Queen's Printer Fees Regulations*.

Interpretation

2 In these regulations, "Act" means The Queen's Printer Act.

4 For the purposes of section 7 of the Act, persons on whose behalf a notice mentioned in Column 1 of Part 1 of the Tariff of Charges is required to be published in the Gazette are designated as persons who are required to pay the charge set out in Column 2 opposite the notice.
