## CHAPTER R-16.2 REG 1

### *The Regulations Act, 1995*

#### Title

- 1 These regulations may be cited as *The Regulations Act Regulations, 1997*.

#### Interpretation

- 2 In these regulations:

“**Act**” means *The Regulations Act, 1995*; («*Loi*»)

“**amending regulation**” means a regulation that amends another regulation, whether revised or unrevised, and that is part of the Saskatchewan Regulations; («*règlement modificateur*»)

“**revised regulation**” means a regulation that is part of *The Revised Regulations of Saskatchewan*; («*règlement révisé*»)

“***The Revised Regulations of Saskatchewan***” means the body of regulations that consists of all regulations that are:

- (a) enacted on or after December 5, 1980;
- (b) published in Part II of the Gazette; and
- (c) numbered in accordance with section 3; («*Règlements révisés de la Saskatchewan*»)

“**Saskatchewan Regulations**” means the body of regulations that consists of:

- (a) all regulations enacted before December 5, 1980; and
- (b) all regulations enacted on or after December 5, 1980 that are numbered in accordance with section 5 and that:
  - (i) are published in Part III of the Gazette; or
  - (ii) amend a revised regulation and are published in Part II of the Gazette; («*Règlements de la Saskatchewan*»)

“**unrevised regulation**” means any regulation that is part of the Saskatchewan Regulations and that is not an amending regulation. («*règlement non révisé*»)

#### Numbering revised regulations

3(1) Subject to subsection (2), the registrar shall number revised regulations by using the chapter number of the Act pursuant to which the regulations are made, followed by the abbreviation “Reg” and a number that corresponds with the order in which the regulations pursuant to that Act are made.

(2) The registrar may assign regulation numbers to revised regulations before the regulations are enacted.

(3) Where, as a result of the assignment of regulation numbers pursuant to subsection (2), the number of a revised regulation deviates from the order of enactment of regulations pursuant to an Act, that deviation does not constitute an error in assigning a number to the regulation for the purposes of section 7.

#### Citing revised regulations

4(1) A revised regulation that is enacted in English only may be cited:

- (a) by using its title, as set out in section 1 of the regulation, in English;
- (b) by using the expression “*The Revised Regulations of Saskatchewan*”, followed by the word “chapter”, the chapter number of the Act and the number of the regulation as printed in the Gazette; or
- (c) by using the abbreviation “R.R.S.”, followed by the abbreviation “c.”, the chapter number of the Act and the number of the regulation, using the abbreviation “Reg”, as printed in the Gazette.

**Examples:**

*The Crown Foundations Regulations*  
*The Revised Regulations of Saskatchewan*, chapter C-50.12 Reg 1  
 R.R.S. c.C-50.12 Reg 1

(2) A revised regulation that is enacted in both English and French may be cited:

- (a) by using its title, as set out in section 1 of the regulation, in English or in French;
- (b) in the manner described in clause (1)(b) or (c);
- (c) by using the expression “*Règlements Révisés de la Saskatchewan*”, followed by the word “chapitre”, the chapter number of the Act and the number of the regulation as printed in the Gazette; or
- (d) by using the abbreviation “R.R.S.”, followed by the abbreviation “ch.”, the chapter number of the Act and the number of the regulation, using the abbreviation “Règl.”, as printed in the Gazette.

**Examples:**

*Règlement de 1988 sur les juges de paix*  
*Les Règlement Révisés de la Saskatchewan*, chapitre J-5,1 Règl. 1  
 R.R.S. ch.J-5,1 Règl. 1

#### Numbering Saskatchewan Regulations

5(1) With respect to Saskatchewan Regulations, the registrar shall:

- (a) begin a new series of regulation numbers in each year; and
- (b) number regulations in the order in which they are filed.

(2) Subject to subsection (3), a Saskatchewan Regulations number consists of the number assigned pursuant to clause (1)(b), an oblique stroke and the last two figures of the calendar year in which the regulation was filed.

(3) In the case of Saskatchewan Regulations enacted on or after January 1, 1999, the Saskatchewan Regulations number consists of the number assigned pursuant to clause (1)(b), an oblique stroke and all figures of the calendar year in which the regulation was filed.

#### **Citing Saskatchewan Regulations**

**6(1)** An amending regulation or an unrevised regulation enacted in English only may be cited:

(a) by using the expression “Saskatchewan Regulations” or the abbreviation “Sask. Reg.”, followed by the Saskatchewan Regulations number of the regulation; or

**Examples:**

Saskatchewan Regulations 7/95  
Sask. Reg. 7/95

(b) in the case of a regulation enacted after the coming into force of the Act, by using its title, as set out in section 1 of the regulation, in English.

(2) An amending regulation or an unrevised regulation enacted in English and French may be cited:

(a) in the manner described in subsection (1);

(b) by using the expression “Règlements de la Saskatchewan” or the abbreviation “Règl. de la Sask.”, followed by the Saskatchewan Regulations number of the regulation; or

**Examples:**

Règlements de la Saskatchewan 7/95  
Règl. de la Sask. 7/95

(c) in the case of a regulation enacted after the coming into force of the Act, by using its title, as set out in section 1 of the regulation, in English or in French.

#### **Correction of numbering errors**

**7** Where an error occurs in assigning a number to a regulation, the registrar shall:

(a) cancel the incorrect number assigned to the regulation;

(b) assign a new number to the regulation; and

(c) publish a notice in the Gazette stating the new number that has been assigned.

**Fees**

8(1) Subject to subsections (2), (4) and (5), a person who wishes to obtain copies of regulations that have been exempted from publication in the Gazette pursuant to clause 7(1)(a) or (b) of the Act or that have been published in the Gazette shall pay to the registrar a fee equal to the total of:

- (a) \$0.15 for each page reproduced; and
- (b) the registrar's cost of mailing the copies.

(2) The minimum fee payable to obtain a copy of regulations mentioned in subsection (1) is \$3.

(3) Subject to subsections (4) and (5), a person who wishes to obtain copies of parts of regulations that are exempted from publication in the Gazette pursuant to subsection 7(2) of the Act shall pay to the registrar a fee equal to the total of:

- (a) the registrar's cost of reproducing those parts; and
- (b) the registrar's cost of mailing the copies.

(4) The registrar may waive payment of a fee prescribed in this section where, in the opinion of the registrar, the person requesting the regulation or part of a regulation requires it to administer or implement the regulation.

(5) The following persons are exempt from paying any fee prescribed in this section:

- (a) the Provincial Auditor;
- (b) the Clerk of the Legislative Assembly;
- (c) the Provincial Comptroller; or
- (d) any Member of the Legislative Assembly.

**Addition to Schedule 1**

9 The following item is added to Schedule 1 of the Act:

**Schedule 1**

- (a) all orders prescribing fees made by the Lieutenant Governor in Council pursuant to section 17 of *The Court of Appeal Act*;
- (b) all orders made by the Lieutenant Governor in Council pursuant to section 9 of *The Reciprocal Enforcement of Judgments Act, 1996* listing the jurisdictions to which that Act applies.

**Coming into force**

**12(1)** Subject to subsection (2), these regulations come into force on the day on which *The Regulations Act, 1995* comes into force.

(2) If *The Regulations Act, 1995* comes into force before these regulations are filed with the Registrar of Regulations, these regulations come into force on the day on which they are filed with the Registrar of Regulations.
