## **CHAPTER U-11 REG 2**

### *The Urban Municipality Act, 1984*

#### **Title**

- 1** These regulations may be cited as *The Urban Municipality Regulations (No. 2)*.

#### **Interpretation**

- 2** In these regulations:

- (a) “**Act**” means *The Urban Municipality Act, 1984*;
- (b) “**minister**” means the Minister of Municipal Government.

#### **Petition for incorporation of resort village**

- 3** Form A is the form to be used as the petition to incorporate a resort area as a resort village pursuant to section 4 of the Act.

#### **Notice re objections against incorporation of resort village**

- 4** Form B is the form to be used as the notice stating the time by which objections are to be filed with the minister against the incorporation of a resort village pursuant to subsection 4(4) of the Act.

#### **Petition for incorporation of village**

- 5** Form C is the form to be used as the petition to incorporate an organized hamlet as a village pursuant to section 5 of the Act.

- 6(1)** Form D is the form to be used as the notice stating a time by which objections are to be filed with the minister against the incorporation of an organized hamlet as a village pursuant to subsection 5(3) of the Act.

- (a) published at least once each week for two successive weeks in a newspaper circulating in the area of the proposed village;
- (b) posted in a conspicuous location in the building in which the offices of the rural municipality in which the proposed village is located are contained; and
- (c) posted in at least three conspicuous places within the boundaries of the organized hamlet.

**Listing of property by council members**

**7.1** Form E.1 is the form to be used pursuant to subsection 32(3) of the Act for the listing of all land and building owned by a member of council.

**7.2** Form E.2 is the form to be used pursuant to subsection 36(2) of the Act for the listing of all land and buildings that are owned by every:

- (b) municipal employee that may be designated by a council;
- (c) employee of a board, association, commission or other organization established pursuant to this Act by a council that may be designated by the council;
- (d) person appointed by a council as a member of a municipal planning commission or district planning commission within the meaning of *The Planning and Development Act, 1983*; and
- (e) person appointed by a council as a member of any board, association, commission or other organization established pursuant to the Act by a council that may be designated by the council.

**Assessment of railway roadway**

**8** Pursuant to subsection 238(7) of the Act, the value of a railway roadway owned or occupied by a railway company is to be assessed at:

- (a) \$18,000 per mile or \$11,187.07 per kilometer in cities;
- (b) \$15,000 per mile or \$9,322.56 per kilometer in towns;
- (c) \$9,000 per mile or \$5,593.54 per kilometer in villages and resort villages.

**Assessment of improvements**

**9** Pursuant to subsections 239(5) and (6) of the Act, improvements are to be assessed at:

- (a) 60% of their fair value, in the case of improvements that are:
  - (i) assessed at the 1947 level of values;
  - (ii) assessed at the 1965/66 level of values and located in municipalities in the Northern Saskatchewan Administration District; or
  - (iii) assessed at the 1950 level of values and located in the City of Saskatoon; or
- (b) 50% of their fair value, in the case of improvements, other than those described in subclause (a)(ii), that are assessed at the 1965/66 level of values.

**Statement of account of school taxes**

**15** Form K is the form to be used as the statement of the account of an urban municipality with a school division that is required to be submitted by the treasurer of every urban municipality to the board of education of each school division within the municipality pursuant to section 292 of the Act.

**Maximum discount for the prompt payment of taxes and assessments**

**16.1(1)** The maximum percentage discount rate that may be allowed pursuant to section 294 of the Act by a council for the prompt payment of:

- (a) current year's taxes on land;
- (b) current year's taxes on improvements; or
- (c) local improvement special assessments;

is 15% per annum.

(2) Where a council provides for any of the taxes or the assessments mentioned in subsection (1) to be paid in instalments, the cumulative discount that may be allowed for the payment of the instalments shall not exceed 15% per annum.

**Maximum discount for the prepayment of taxes and assessments**

**16.2** The maximum discount rate that may be allowed pursuant to section 295 of the Act by a council for the payment of:

- (a) taxes on land;
- (b) taxes on improvements; or
- (c) local improvement special assessments;

in advance of the day that may be fixed by bylaw for payment of those taxes or assessments is 15% per annum.

**Maximum discount for the payment of arrears and penalties**

**16.3** The maximum percentage discount rate that may be allowed pursuant to section 296 of the Act by a council for the payment of the whole or a portion of the arrears of taxes and penalties on:

- (a) land;

- (c) local improvement special assessments;

is 15% per annum.

**Maximum rebate for the payment of arrears and penalties**

**16.4** The maximum rebate that may be allowed by a council pursuant to section 296 of the Act for the payment of the whole or a portion the arrears of taxes and penalties on:

is an amount equal to the amount of the penalty.
