Application of Act

4 This Act applies to any school, school system, school district or larger school unit which has been established pursuant to *The School Act*, *The Secondary Education Act*, *The Larger School Units Act*, *The Education of Blind and Deaf Persons Act*, or any former Act under which schools within the meaning of those Acts have been established, and to any school system or school administrative units established pursuant to this Act.

Validity of certain orders

363.1 Notwithstanding *The Regulations Act*, as that Act existed on the day before the coming into force of *The Regulations Act, 1989*, the fact that an order of the minister made pursuant to clause 10(1)(m) or section 19, 20, 27, 29 or 31 was not:

(a) filed with the Registrar of Regulations in accordance with *The Regulations Act*, as that Act existed on the day before the coming into force of *The Regulations Act, 1989*; and

(b) published in the Gazette in accordance with *The Regulations Act*;

does not alone render the order invalid.
