**CHAPTER C-3 REG 2**  
*The Cattle Marketing Deductions Act*

TITLE

**Title**

**1** These regulations may be cited as *The Cattle Marketing Deductions Regulations*.

**Interpretation**

**2** In these regulations:

- (a) “**Act**” means *The Cattle Marketing Deductions Act*;
- (b) “**department**” means the Department of Agriculture;
- (c) “**livestock manifest**” means the livestock manifest issued by the department pursuant to “The Livestock Inspection and Transportation Regulations, 1978”.

DEDUCTIONS

**Amount of deduction**

**3** The amount to be deducted pursuant to section 3 of the Act from the purchase price of each head of cattle purchased is \$1.

**Returns and deductions**

**4(1)** A return pursuant to section 4 of the Act for monies required to be deducted is to be in Form A of the Appendix and is to be prepared by the department on the basis of information submitted on livestock manifests pursuant to “The Livestock Inspection and Transportation Regulations, 1978”.

**(2)** A return pursuant to section 4 of the Act by an inspector is to be in Form B of the Appendix.

**Commissions for deductions**

**5** Every livestock dealer is entitled to receive a commission of 3¢ per each head of cattle with respect to which he deducts or collects the amount to be deducted pursuant to section 3 of the Act.

## CATTLE MARKETING DEDUCTIONS

**Out-of-province inspection points**

**6(1)** For the purposes of section 5 of the Act, the approved inspection points for Manitoba are stockyards:

- (a) with respect to which the department has negotiated agreements for the collection of statutory deductions from Saskatchewan livestock owners; and
- (b) where cattle are inspected prior to sale.

(2) For the purposes of section 5 of the Act, the approved inspection points for Alberta are inspected auction markets licensed pursuant to *The Livestock and Livestock Products Act (Alberta)*, and *The Licensing and Bonding of Livestock Dealers and Livestock Dealers' Agents Regulations* made pursuant to that Act.

**Forms**

**7** The forms prescribed in these regulations are to be issued by the department.

## FUND

**Voucher for expenditure**

**8** All vouchers for expenditures from the fund shall be signed by the secretary of the committee.

**Fiscal year**

**9** The fiscal year for administration of the fund is the period commencing on April 1 in one year and ending on March 31 in the following year.

**Investments**

**10** The Minister of Finance may invest any part of the fund not presently required for expenditure in any security or class of securities authorized for the investment of moneys in the consolidated fund pursuant to *The Department of Finance Act, 1983*.

## COMMITTEE

**Payments to members of the committee**

**11(1)** Payments to members of the committee for services performed are:

- (a) \$155 for the chairman; and
- (b) \$110 for each member of the committee other than the chairman;

for each day spent in attending to the affairs of the committee.

## C-3 REG 2

(2) Each member of the committee, including the chairman, is entitled to reimbursement for expenses that he incurs while attending to the affairs of the committee for travel, sustenance and accommodation, calculated in accordance with the amounts approved from time to time for employees in the classified division of the public service of Saskatchewan.

**12** The committee shall hold at least two meetings in each fiscal year.
