## **CHAPTER C-47 REG 1**

### *The Criminal Injuries Compensation Act*

#### **Title**

**1** These regulations may be cited as *The Criminal Injuries Compensation Regulations*.

#### **Interpretation**

**2** In these regulations, “**Act**” means *The Criminal Injuries Compensation Act*.

#### **Amount of compensation**

**3(1)** Subject to subsection (2), the maximum amount of compensation that may be awarded by the board pursuant to the Act in respect of any one case before it is \$7,500.

**(2)** The board shall obtain the prior approval of the Lieutenant Governor in Council before making an award of compensation that exceeds \$7,500.
