## **CHAPTER C-47 REG 2**

### *The Criminal Injuries Compensation Act*

#### **Title**

**1** These regulations may be cited as *The Criminal Injuries Compensation Regulations, 1989*.

#### **Interpretation**

**2** In these regulations, “**Act**” means *The Criminal Injuries Compensation Act*.

#### **Amount of compensation**

**3(1)** Subject to subsection (2), the maximum amount of compensation that may be awarded by the board pursuant to the Act with respect to any one case before it is \$10,000.

(2) If the board has obtained the prior approval of the Lieutenant Governor in Council, it may make an award of compensation that exceeds \$10,000.

**4** The offences for which an award of compensation may be made are as follows:
