## CHAPTER E-0.1 REG 8

### *The Education Act*

#### TITLE AND INTERPRETATION

##### Title

1 These regulations may be cited as *The School Grant 1988 Regulations*.

##### Interpretation

2(1) In these regulations:

- (a) **“ability to pay factor”** means the difference between one and the ratio of a school division’s basic grant to its net recognized expenditure;
- (b) **“Act”** means *The Education Act*;
- (c) **“approved”** means approved by the minister;
- (d) **“basic grant”** means the difference between a school division’s total recognized expenditure and total recognized revenue;
- (e) **“basic program”** means the sum of the expenditures set out for a school division in clause 4(a);
- (f) **“city school division”** means a school division that includes a city wholly or substantially within its boundaries;
- (g) **“computational mill rate”** means the mill rate fixed by the minister for the purposes of clause 304(3)(a) of the Act and as specified in Table 3;
- (h) **“downpayment”** means the contribution to capital from revenue required of a school division by the Local Government Board in connection with authorization for capital borrowing for capital projects;
- (i) **“enrolment”** or **“enrolled”** means:
  - (i) in the case of kindergarten pupils in a kindergarten program commencing for the first time in the fall of any year, 40% of the number of kindergarten pupils reported to the minister in the Principal’s September Statistical Report; and
  - (ii) in the case of a category of pupils other than high-cost disabled pupils and kindergarten pupils described in subclause (i) and as reported in the Principal’s September Statistical Report, the recognized enrolment with respect to the school year for which the recognition applies;
- (j) **“Established Program Fund Pupil”** means:
  - (i) a low-cost disabled pupil; or
  - (ii) a high-cost disabled pupil determined by the special education branch of the department as meeting the criteria of clause 49(d) or (g) of *The Education Regulations, 1986*;

- (k) **“full-time equivalent pupils”** means the number determined in accordance with subsections (3) and (4);
- (l) **“high-cost disabled pupil”** means a high-cost disabled pupil as defined in section 48 of *The Education Regulations, 1986*;
- (m) **“home attendance area”** means the area from which a pupil attends a certain school, as determined by the board of education that is fiscally responsible for the provision of educational services for the pupil;
- (n) **“language program”** means a course of educational instruction conducted in a language other than English and includes English as a second language;
- (o) **“low-cost disabled pupil”** means a pupil who is:
- (i) a low-cost disabled pupil as defined in section 48 of *The Education Regulations, 1986*; and
  - (ii) in kindergarten or Division I, II or III;
- (p) **“net recognized expenditure”** means the difference between a school division’s total recognized expenditure and tuition fee revenue;
- (q) **“non-city school division”** means a school division that does not include a city wholly or substantially within its boundaries;
- (r) **“northern differential”** means the northern differential per pupil as specified in Table 12;
- (s) **“northern factor”** means the northern factor specified in Table 1 or 2;
- (t) **“northern school division”** means a school division located in the Northern Saskatchewan Administration District;
- (u) **“parent-management board”** means a recognized agency that is incorporated pursuant to *The Non-profit Corporations Act*;
- (v) **“recognized”** means:
- (i) recognized by the minister; or
  - (ii) deemed or required by these regulations to be recognized by the minister;
- (w) **“total approved cost”** means the sum of the construction cost, any consultants’ fees and any other costs that may be approved by the department on a project-by-project basis.
- (2) For the purposes of determining enrolment, a high-cost disabled pupil who is between the ages of:
- (a) three years zero months and 11 years seven months is deemed to be enrolled in Divisions I and II;
  - (b) 11 years eight months and 14 years seven months is deemed to be enrolled in Division III; and

- (c) 14 years eight months and 21 years is deemed to be enrolled in Division IV.
- (3) The number of full-time equivalent pupils in a program is equal to the number of pupils enrolled in the program:
- (a) where:
    - (i) the pupils are enrolled in kindergarten to year 12 and the program is not a language program; and
    - (ii) the ratio of instructional time is equal to or greater than .75;
  - (b) where:
    - (i) the pupils are enrolled in kindergarten to year 6 and the program is a language program; and
    - (ii) the ratio of instructional time is equal to or greater than .75; and
  - (c) where:
    - (i) the pupils are enrolled in years 7 to 12 and the program is a language program; and
    - (ii) the ratio of instructional time is equal to or greater than .6.
- (4) In any case other than one described in clauses (3)(a) to (c), the number of full-time equivalent pupils in a program is equal to the product of:
- (i) the number of pupils enrolled in the program; and
  - (ii) the ratio of instructional time.
- (5) In subsections (3) and (4), “ratio of instructional time” means the ratio of instructional time devoted to instruction and the total available instructional time per week for the pupil.

## OPERATING GRANTS

**Application**

- 3 These regulations apply only to grants made in the year 1988.

**Recognized expenditures**

- 4 Recognized expenditures in school divisions consist of:
- (a) with respect to expenditures for administration, instruction, non-capital furniture and equipment, non-capital renovations and repairs:
    - (i) current interest expenses;
    - (ii) bank charges;
    - (iii) special events transportation; and

(iv) either:

(A) with respect to Regina, Saskatoon, Prince Albert and Moose Jaw school divisions with enrolments in excess of 2,000 pupils, for plant operation and maintenance, the basic rate per pupil enrolled as determined in accordance with Table 4; or

(B) in the case of a school division other than one mentioned in clause (a), for 30% of plant operation and maintenance, the basic rate per pupil as determined in accordance with Table 4;

(b) with respect to expenditures for pupils enrolled in special programs, recognized incremental rates as determined in accordance with Table 5;

(c) with respect to expenditures for Established Program Fund Pupils, the rates determined in accordance with Table 6;

(d) with respect to expenditures:

(i) for transportation in city school divisions and other approved school divisions in which transportation expenditures are declared by the minister to be eligible for grant support, transportation allowances equal to the total actual costs to a maximum of:

(A) the amount specified in Table 7 with respect to the type of pupil per year; or

(B) in the case of approved transportation for pupils other than high-cost disabled pupils to whom transportation is provided for less than a full school year, the actual costs to a maximum of the amount specified in Table 7 per pupil per day;

(ii) for transportation in approved non-city school divisions, the amount specified in Table 7 for each recognized pupil for whom regular transportation services are provided and per kilometre of recognized daily bus travel;

(iii) in lieu of the amounts described in subclause (i) or (ii), transportation allowances to parents equal to the total actual costs to a maximum of the amount per vehicle per kilometre of approved travel specified in Table 7;

(iv) for local transportation in northern school divisions, the sum of:

(A) the product of:

(I) the amount specified in Table 7 for each recognized pupil for whom regular transportation services are provided; and

(II) the northern factor for that northern school division; and

(B) the product of:

(I) an amount specified in Table 7 per kilometre of recognized daily bus travel; and

(II) the northern factor for that northern school division;

- (v) for other than local transportation in northern school divisions in which transportation expenditures are declared by the minister to be eligible for grant support, transportation allowances equal to the total actual costs to a maximum of:
  - (A) in the case of high-cost disabled pupils boarding away from home, the actual and approved travel costs to and from the home and the place of boarding; and
  - (B) for pupils other than high-cost disabled pupils, the total actual costs to a maximum of the amount specified in Table 7 per pupil per day for approved transportation;
- (e) with respect to expenditures of additional amounts for room and board and transportation services, where a pupil resides elsewhere than at home or receives educational services outside the home attendance area and where the school division in the home attendance area pays allowances:
  - (i) for school divisions other than northern school divisions:
    - (A) with respect to expenditures for room and board, the total actual costs to a maximum of the amount specified in Table 8 with respect to the type of pupil per month; and
    - (B) with respect to:
      - (I) northern school divisions other than the Northern Lights School Division, the northern factor for that northern school division; and
      - (II) the Northern Lights School Division, the community northern factor set out in Table 2 for the community in which the pupil attends school; and
  - (ii) for northern school divisions, the total actual cost to a maximum of the product of:
    - (A) the amount described in paragraph (i)(A) or (B); and
    - (B) the northern factor for the community in which the pupil attends school;
- (f) with respect to expenditures for an approved program offering second language instruction:
  - (i) the amounts specified in Table 9 for each full-time equivalent pupil; and
  - (ii) a one-time expenditure for the purchase of instructional resource material needed for implementation of the program in the amount specified in Table 9;
- (g) with respect to expenditures for rental of facilities required for school activities:
  - (i) for classroom rentals, the total actual costs to a maximum of the amount specified in Table 10 per approved classroom per month; and

- (ii) for gymnasias and halls, the total actual approved costs to a maximum for each school of the lesser of the amounts specified in Table 10;
- (h) the total actual costs of employing substitute teachers for a maximum of five consecutive days when the regular teacher is granted leave with full pay for the purpose of attending a seminar or workshop which has received the prior approval of the minister;
- (i) that portion of the previous school year's costs of employing substitute or temporary teachers in place of regular teachers who were absent on sick leave which is in excess of the equivalent of two mills calculated on the total equalized assessment for that year of the school division and that is approved by the minister;
- (j) in the case of a non-city school division where the total number of pupils enrolled in a grade in Divisions I, II, III or IV in any school in the school division is less than 20, the sum of:
  - (i) the basic rate per pupil enrolled as determined in accordance with Table 4; and
  - (ii) the product of:
    - (A) the amount specified in Table 11; and
    - (B) an amount equal to the lesser of:
      - (I) the difference between 20 and the number of pupils enrolled in that grade; and
      - (II) 10;
- (k) with respect to expenditures for northern school divisions where the enrolment is:
  - (i) less than 400 pupils, the per pupil amount specified in Table 12 per pupil; and
  - (ii) 400 or more pupils, the amount specified in Table 12 reduced by the product of the per pupil amount described in subclause (i) and the number of pupils in excess of 400;
- (l) with respect to expenditures for plant operation and maintenance for northern school divisions, the sum of:
  - (i) 70% of the previous year's actual expenditure for plant operation and maintenance increased by an amount that is determined jointly by the minister and the northern school division, but, where the auditor's financial statement for that year differs from the estimated expenditures, the appropriate adjustment is to be added to or recovered from the subsequent year's grant; and
  - (ii) any additional amounts that may be approved by the minister for plant operation and maintenance of new schools or major emergency plant repairs or both;

- (m) for each northern school division, the product of:
  - (i) the amount specified in Table 12 as the northern differential;
  - (ii) the number of recognized full-time equivalent pupils; and
  - (iii) the northern factor for the school division;
- (n) payments to other school divisions, approved agencies or individuals, other than private high schools, for the purchase of educational services in the amount equal to the sum of:
  - (i) the application of the basic rate as set out in Table 4 to the actual number of pupils for whom educational services are purchased;
  - (ii) the application of the appropriate incremental rate as set out in Table 5 to the actual number of high-cost disabled pupils, other than Established Program Fund Pupils, for whom educational services are purchased; and
  - (iii) the actual number of pupils when comprehensive education services are purchased;
- (o) payments to approved private high schools that meet the requirements of subsection 15(2), for the purchase of educational services:
  - (i) before September 1, 1987, in an amount equal to the application of the difference between:
    - (A) the basic rate as set out in Table 4; and
    - (B) the amount paid to private high schools as set out in Table 14;to the number of pupils for whom educational services are purchased; and
  - (ii) on or after September 1, 1987, in an amount equal to the application of the basic rate as set out in Table 4 to the actual number of pupils for whom educational services are purchased; and
- (p) payments by a northern school division to other school divisions, individuals, governments or institutions, and, on and after September 1, 1987, private high schools that meet the requirements of subsection 15(2), with respect to the purchase of educational services in an amount equal to the sum of:
  - (i) an amount equal to the total of the amounts determined in accordance with subclauses (n)(i) and (ii) and (o)(i) and (ii);
  - (ii) the application of the product of the northern differential per pupil and the northern factor to the actual number of pupils for whom educational services are purchased by a northern school division from:
    - (A) another northern school division; or
    - (B) an approved educational institution in the Northern Saskatchewan Administration District; and

(iii) the application of a recognized per pupil amount for the northern school division plant operation and maintenance expenditure to the actual number of pupils for whom educational services are provided to a northern school division by:

- (A) another northern school division; or
- (B) an approved educational institution in the Northern Saskatchewan Administration District.

#### **Enrolment**

5(1) Subject to section 7, unless otherwise determined by the minister, the numbers of pupils recognized in each category of recognized enrolment are those which are determined in accordance with the other provisions of this section.

(2) The minister shall add to the appropriate Divisions I and II, Division III and Division IV enrolments the number of pupils reported the minister on the Principal's September Statistical Report in "other" or "special" Divisions I and II, Division III or Division IV programs.

(3) The number of low-cost disabled pupils recognized is the sum of:

- (a) 3% of the sum of the enrolments in Divisions I, II and III determined in accordance with subsection (2) after deleting the number of high-cost disabled pupils as determined in accordance with subsection (5); and
- (b) 1.5% of the recognized kindergarten enrolment as determined in accordance with subsection (1).

(4) The number of Established Program Fund Pupils recognized is the sum of the previous year's enrolments for:

- (a) Established Program Fund Pupils that are low-cost disabled pupils calculated in accordance with subsection (3); and
- (b) Established Program Fund Pupils that are high-cost disabled pupils.

(5) The number of high-cost disabled pupils recognized is the number of pupils, other than Established Program Fund Pupils, determined by the special education branch of the department for recognition in each category.

#### **Pupils deemed not enrolled**

6 Where a board of education:

- (a) enrolls a pupil to whom subsection 20(8) of *The Education Regulations, 1986* applies; and
- (b) does not charge the tuition fee mentioned in that subsection;

the pupil is deemed not to have been enrolled for the purpose of calculating the enrolment pursuant to section 5.

**Increased enrolment**

7(1) Subject to subsection (2), where the total enrolment as at:

- (a) March 1 of the 1987-88 school year; or
- (b) September 30 following the 1987-88 school year;

increases by more than 1% in relation to the total enrolment as set out in the Principal's September Statistical Report of the 1987-88 school year, the board may notify the minister of the increase and have its grant recalculated with respect to any increases in total enrolment that are in excess of 1%.

(2) Where the increases in total enrolment mentioned in subsection (1) are calculated for the September 30 following the 1987-88 school year, only 40% of the increase is recognized.

**Declining enrolment**

8(1) Subject to subsection (2), the minister shall take into account the declining enrolment in a school division by increasing the basic program by the sum of:

- (a) 60% of the percentage drop in enrolment between the 1987-88 school year and the 1986-87 school year; and
- (b) 40% of the percentage drop in enrolment between the 1985-86 year and the 1986-87 school year.

(2) When including or excluding enrolments for the purpose of arriving at the amount of decline in enrolment pursuant to this section, the minister may take into account special factors, including a major shift in attendance of pupils from one school division to another or the withdrawal of a significant number of pupils sponsored by another department or agency.

(3) Comprehensive school pupils for whom services are directly purchased from a comprehensive school operated by a joint board are to be included in their home school division for the purposes of computations pursuant to this section.

**Sparsity factor**

9 The minister shall increase the basic program and the recognized tuition fees for all non-city school divisions on the basis of the ratio of pupils per square kilometre by the percentage determined in accordance with Table 13.

**Additional recognized expenditures**

10 The minister may recognize any amounts of expenditures, in addition to those described in sections 4 to 9, that the minister considers appropriate.

**Recognized local revenue**

11(1) Recognized local revenue is to be determined in accordance with subsections (2) to (7).

(2) The assessment to be used in the calculation of grants for a year is that amount determined jointly by the minister and the school division, but, where the final equalized assessment differs from the estimated equalized assessment, the appropriate adjustment is to be added to or recovered from the subsequent year's grant.

(3) Where a municipality has exempted property from the property tax roll pursuant to:

- (a) subsection 275(2) or (3) of *The Urban Municipality Act, 1984*; or
- (b) subsection 331(3) of *The Rural Municipality Act, 1989*;

the assessed value of that property is to be added to the estimated equalized assessment.

(4) Revenue from trailer fees and from grants in lieu of taxes received on account of exempt assessments are to be converted to an equivalent assessment, and those assessments are to be added to the equalized assessment of the school division for the purpose of calculating grants.

(5) Fee revenue received by a school division other than a northern school division from other school divisions, individuals, governments or institutions with respect to the provision of educational services for pupils is recognized in the amount equal to the sum of:

- (a) the application of the basic rates set out in Table 4 to the actual number of pupils for whom educational services are provided; and
- (b) the application of the incremental rate as set out in Table 5 to:
  - (i) the actual number of high-cost disabled pupils, other than Established Program Fund Pupils, for whom educational services are provided; and
  - (ii) the actual number of pupils for whom comprehensive educational services are provided.

(6) Fee revenue received by a northern school division from other school divisions, individuals, governments or institutions, with respect to the provision of educational services for pupils, is recognized local revenue in the amount equal to the sum of:

- (a) an amount equal to the total of the amounts determined in accordance with clauses (5)(a) and (b);
- (b) the application of the product of the northern differential per pupil and the northern factor to the actual number of pupils for whom educational services are provided by the division to:
  - (i) another northern school division; or
  - (ii) an approved educational institution in the Northern Saskatchewan Administration District; and
- (c) the application of a recognized per pupil amount for the northern school division's plant operation and maintenance expenditure to the actual number of pupils for whom educational services are provided.

(7) The minister may recognize any amounts of revenue, in addition to those described in subsections (2) to (6), that the minister considers appropriate.

## CAPITAL FUNDING

### Recognized capital expenditures

**12** Recognized capital expenditures in school divisions consist of:

(a) with respect to expenditures for recognized debt retirement for school facilities and, in the case of a school division located in the Northern Saskatchewan Administration District, teachers' residences, the sum of:

- (i) actual payments of principal and interest for approved capital loans and debentures; and
- (ii) actual payments made to other school divisions in lieu of direct debt retirement;

less any payments received from other school divisions, government, Indian bands within the meaning of the *Indian Act* (Canada), as amended from time to time, or institutions with respect to capital debt retirement; and

(b) the replenishment of any cash reserve funds recognized by the minister:

- (i) in equal annual instalments, including principal and interest, for a term agreed on by a board of education and the minister where those cash reserve funds are utilized by the board of education with the minister's approval for approved capital projects; and
- (ii) at an interest rate approved by the minister at the time the funding arrangement is completed.

### Capital funding

**13(1)** Building grants are payable to a board of education for capital projects approved before April 1, 1987 in an amount equal to the sum of:

(a) the difference between:

(i) subject to subsection (4), the product of:

- (A) the recognized cost of the project; and
- (B) 45% of the ratio of operating grants to recognized expenditures for the previous year for that board of education; and

(ii) any revenue earned as interest on moneys received from the sale of debentures before the issuance of the final approval of the capital project which may be recognized by the minister; and

- (b) with respect to expenditures for capital projects that receive the preliminary approval of the minister:
- (i) on or before April 30, 1985, that portion of the total downpayment of all approved projects which exceeds the equivalent of four mills applied to the total equalized assessment of the school division;
  - (ii) after April 30, 1985 and before April 1, 1986, that portion of the total downpayment of each capital project that exceeds the equivalent of five mills applied to the total equalized assessment of the school division; or
  - (iii) on or after April 1, 1986 and before April 1, 1987, that portion of the total downpayment of each capital project that exceeds the equivalent of two and one-half mills applied to the total equalized assessment of the school division.
- (2) Subject to subsection (3), in the case of capital projects approved on or after April 1, 1987, the downpayment of the school division is an amount equal to 40% of the product of:
- (a) the total approved cost; and
  - (b) the sum of:
    - (i) the product of the ability to pay factor and 0.50; and
    - (ii) 0.25.
- (3) For the purposes of subsection (2), the minimum value of the downpayment is the lesser of one-half mill applied to the total equalized assessment of the school division and:
- (a) with respect to roof projects, \$25,000; and
  - (b) with respect to all other capital projects, \$50,000.
- (4) The product calculated pursuant to subclause (1)(a)(i) shall be not less than 15% nor more than 30% of the approved cost of the project based on the cost calculations at the preliminary approval stage.
- (5) For dental facilities approved before April 1, 1987, building grants are payable to a board of education in an amount equal to the actual approved cost.
- (6) Where an approved project for a school division consists of the repair or replacement of laminated wood beams and associated work, the minister will pay an amount to the board of education in each year equal to the cost of expenditures for debt retirement recognized pursuant to section 12 in connection with 50% of the approved cost of the project.
- (7) Where an approved project involves accessibility and emergency safety repairs, the provisions of subsection (2) apply.

**Northern teacherage operating allowance**

**14** Northern teacherage allowances are payable to a northern school division to the amount of the difference between:

- (a) the previous year's actual teacherage expenditure; and
- (b) the previous year's actual teacherage expenditure divided by the northern factor.

**Private school capital funding**

**15(1)** Subject to subsection (2), the replenishment of cash reserves within the meaning of clause 12(b) is payable to assist private high schools, that are considered by the minister to be eligible for assistance, for capital construction in an amount equal to 20% of the recognized costs of the facilities, including architect's fees.

(2) A private high school is eligible for the replenishment of cash reserves pursuant to this section only where it:

- (a) has been in operation for a period of not less than five years;
- (b) has had an enrolment during each of the preceding two years of operation of not less than 60 pupils in Grades 9 to 12;
- (c) meets the requirements of the minister and the regulations with respect to courses of study, qualifications of teachers, operating schedules and supervision;
- (d) furnishes the minister with any information that the minister may require with respect to finances, structure and administration of the school; and
- (e) with respect to capital projects, submits preliminary drawings and cost estimates of proposed projects to the minister.

**Interest relief program**

**16(1)** Where:

- (a) the minister gives final approval to a board of education with respect to a project between April 1, 1987 and March 31, 1990; and
- (b) the board's annual interest payments on its share of the project's debt retirement exceeds a one-mill levy by the board in the year in which the project is approved;

the minister may make an interest relief payment to the board in an amount equal to 75% of the difference between:

- (c) the annual interest payments; and
- (d) an amount equal to a one-mill levy.

(2) Where:

- (a) the minister gives final approval to a board of education with respect to a project between April 1, 1990 and March 31, 1992; and
- (b) the board's annual interest payments on its share of the project's debt retirement exceeds a two-mill levy by the board in the year in which the project is approved;

the minister may make an interest relief payment to the board in an amount equal to 75% of the difference between:

- (c) the annual interest payments; and
- (d) an amount equal to a two-mill levy.

(3) The interest relief payment described in subsections (1) and (2) is to be made with respect to each year during the term of the loans or debentures negotiated by the board for purposes of the project.

## OTHER GRANTS

### Private schools

**17** Grants to assist in the operation of private schools with respect to Saskatchewan residents are payable for each year:

- (a) subject to subsection 15(2):
  - (i) before September 1, 1987, in an amount equal to the amount specified in Table 14 per pupil enrolled in Grades 9 to 12 in a private high school; and
  - (ii) on or after September 1, 1987, in an amount equal to the amount specified in Table 14 per pupil enrolled in Grades 9 to 12 in a private high school for those pupils who are not sponsored by a Saskatchewan Board of Education; and
- (b) notwithstanding subsection 15(2) and with respect to approved special program schools established in Saskatchewan, in an amount specified in Table 14 per year.

### Grants to parent-management boards

**18** Grants are payable to parent-management boards with respect to approved classes established for the instruction of pre-school and school-age high-cost disabled pupils in an amount equal to the total of:

- (a) the basic rates and recognized incremental rates per pupil enrolled determined in accordance with Tables 4 and 5; and

(b) expenditures for transportation determined in accordance with clause 4(e).
