CHAPTER G-5.1 REG 70

The Government Organization Act

Title

1 These regulations may be cited as *The Department of Intergovernmental Relations Regulations, 1995*.

Department established

2 A department of the Government of Saskatchewan to be called the Department of Intergovernmental Relations is established.

Objects and purposes

3 The objects and purposes of the Department of Intergovernmental Relations are:

- (a) to provide the structure wherein and whereby the powers, responsibilities and functions of the Minister of Intergovernmental Relations may be exercised and carried out;
- (b) to co-ordinate, develop, promote and implement policies and programs of the Government of Saskatchewan relating to the management of the Legislative and Executive Building in the City of Regina and the land on which it is situated, including any land used primarily for parking motor vehicles in connection with the use of that building;
- (c) to co-ordinate, develop and implement policies and programs of the Government of Saskatchewan relating to matters of protocol;
- (d) to co-ordinate, develop and implement policies and programs of the Government of Saskatchewan relating to French language services;
- (e) to co-ordinate, develop and implement policies and programs of the Government of Saskatchewan relating to relations between the Government of Saskatchewan and the following:
 - (i) the Government of Canada;
 - (ii) the governments of other provinces and territories of Canada;
 - (iii) the governments of foreign jurisdictions;
 - (iv) the governing bodies of international organizations of states or their institutions;
- (f) to co-ordinate, develop and implement policies and programs of the Government of Saskatchewan relating to telecommunications, broadcasting and cable services;

(g) to co-ordinate, develop and implement policies and programs of the Government of Saskatchewan relating to the infrastructure program of the Government of Canada.
