CHAPTER W-13.1 REG 61

The Wildlife Act

Title

1 These regulations may be cited as *The Archery and Muzzle-loading Firearm Big Game Open Seasons Regulations, 1994*.

Interpretation

2 In these regulations:

- (a) “**Act**” means *The Wildlife Act*;
- (b) “**Cypress Hills Provincial Park (West Block)**” means the portion of Cypress Hills Provincial Park adjoining the Alberta-Saskatchewan boundary;
- (c) “**Indian reserve**” means a reserve as defined in the *Indian Act* (Canada);
- (d) “**muzzle-loading firearm**” means a firearm that is loaded through the front opening of the barrel;
- (e) “**non-trophy mule deer**” means a female mule deer or a mule deer born during the year in which hunting is taking place;
- (f) “**non-trophy white-tailed deer**” means a female white-tailed deer or a white-tailed deer born during the year in which hunting is taking place;
- (g) “**open season**” means an open season established pursuant to any regulations passed pursuant to the Act during which it is lawful to hunt a particular species of wildlife;
- (h) “**protected area**” means a protected area constituted pursuant to *The Parks Act*;
- (i) “**provincial park**” means a provincial park constituted pursuant to *The Parks Act*;
- (j) “**recreation site**” means a recreation site constituted pursuant to *The Recreation Sites Regulations, 1991*;
- (k) “**Saskatchewan resident**” means a person who:
 - (i) is a Canadian resident, has his or her principal residence in Saskatchewan and has resided in Saskatchewan for the three months preceding the date of his or her application for a licence; or
 - (ii) is a member of the regular force of the Canadian Armed Forces or of the Royal Canadian Mounted Police and is stationed and residing in the province;
- (l) “**wildlife management unit**” means any area constituted as a wildlife management unit by *The Wildlife Management Zones and Special Areas Boundaries Regulations, 1990*;

(m) “**wildlife management zone**” means any area constituted as a wildlife management zone by *The Wildlife Management Zones and Special Areas Boundaries Regulations, 1990*.

- (b) references to wildlife management zones by number are inclusive;
- (c) references to licences are to licences issued pursuant to the Act and *The Wildlife Regulations, 1981*.

General restrictions on hunting

4 These regulations are subject to any restrictions on and conditions relating to hunting contained:

- (a) in the Act;
- (b) in these regulations; or
- (c) in any other regulations made pursuant to the Act or specified on the big game licence.

Archery seasons

5(1) Subject to subsection (2), no person shall hunt by any means other than a bow and arrow during any open season established pursuant to sections 6 to 10.

(2) It is lawful for a person to hunt with a muzzle-loading firearm during the open seasons established pursuant to sections 6 to 10 where the open seasons overlap with open seasons for muzzle-loading firearms established pursuant to sections 12 to 16.

White-tailed deer

6(1) It is lawful for a person who is the holder of a First Saskatchewan Resident White-tailed Deer Licence to hunt a total of one white-tailed deer of either sex:

- (a) on Labour Day and the following consecutive 54 days in Wildlife Management Zones 1 to 55, including Brokenshell No. 1, Brokenshell No. 2, Buckland, Elbow, Fort-a-la-Corne, Great Bend and Horsehide Lake Wildlife Management Units; or
- (b) on the Wednesday following Labour Day and the following consecutive 52 days in Cypress Hills (West Block), Duck Mountain, Greenwater Lake, Meadow Lake, Moose Mountain and Saskatchewan Landing Provincial Parks and that portion of Douglas Provincial Park that lies west of Diefenbaker Lake (Gordon Mackenzie Arm).

(2) It is lawful for a person who is the holder of a First Saskatchewan Resident White-tailed Deer Licence, a Second Saskatchewan Resident White-tailed Deer Licence, a First Canadian Resident White-tailed Deer Licence, a Second Canadian Resident White-tailed Deer Licence, a First Non-resident White-tailed Deer Licence or a Second Non-resident White-tailed Deer Licence to hunt a total of one white-tailed deer of either sex:

- (a) on the Monday closest to August 31, or August 31 if it falls on a Monday, and the following consecutive 61 days in Wildlife Management Zones 56 to 69, including Narrow Hills and Wildcat Hill Provincial Parks and that portion of Clarence-Steepbank Lakes Provincial Park lying outside of the Candle Lake Game Preserve; or
- (b) on the Wednesday following Labour Day and the following consecutive 59 days in Greenwater Lake and Meadow Lake Provincial Parks.

(3) It is lawful for a person who is the holder of a First Saskatchewan Resident White-tailed Deer Licence, a First Canadian Resident White-tailed Deer Licence or a First Non-resident White-tailed Deer Licence to hunt a total of one white-tailed deer of either sex on the Monday closest to August 24, or August 24 if it falls on a Monday, and the following consecutive 103 days in Wildlife Management Zones 70 to 76, including Clearwater River and Lac La Ronge Provincial Parks.

(4) It is lawful for a person who is a Saskatchewan resident and who holds a First Saskatchewan Non-trophy White-tailed Deer Licence to hunt a total of one non-trophy white-tailed deer:

- (a) on Labour Day and the following consecutive 54 days in Wildlife Management Zones 1 to 5, 7 to 21, 30 to 39, 48 and 49, including Brokenshell No. 1 and Brokenshell No. 2 Wildlife Management Units; or
- (b) on the Wednesday following Labour Day and the following consecutive 52 days in Cypress Hills (West Block), Duck Mountain, Moose Mountain and Saskatchewan Landing Provincial Parks.

(5) It is lawful for a person who is a Saskatchewan resident and who holds a Second Saskatchewan Non-trophy White-tailed Deer Licence to hunt a total of one non-trophy white-tailed deer:

- (a) on Labour Day and the following consecutive 54 days in:
 - (i) Wildlife Management Zones 4, 20, 32, 33 and 35;
 - (ii) that portion of Wildlife Management Zone 1, west of Provincial Highway No. 34;
 - (iii) those portions of Wildlife Management Zones 31 and 34 lying east of Provincial Highway No. 9; and
 - (iv) that portion of Wildlife Management Zone 30 that comprises the Shotgun-Archery/Muzzleloader Area; or
- (b) on the Wednesday following Labour Day and the following consecutive 52 days in Moose Mountain Provincial Park.

(6) It is lawful during the period specified in subsection 7(1) for a person who is the holder of a Saskatchewan Resident Elk Licence and who also holds a First Saskatchewan Resident White-tailed Deer Licence or a Second Saskatchewan Resident White-tailed Deer Licence to hunt a total of one white-tailed deer of either sex in Wildlife Management Zones 56 to 66 and 69, including Meadow Lake, Wildcat Hill and Narrow Hills Provincial Parks and that portion of Clarence-Steepbank Lakes Provincial Park lying outside of the Candle Lake Game Preserve.

Elk

7(1) It is lawful for a person who is the holder of a Saskatchewan Resident Regular Elk Licence to hunt a total of one elk of either sex on the Monday closest to August 24, or August 24 if it falls on a Monday, and the following consecutive 12 days in:

- (a) Wildlife Management Zones 48, 49, 53, 56 to 66, and 69, including Meadow Lake, Wildcat Hill and Narrow Hills Provincial Parks, and that portion of Clarence-Steepbank Lakes Provincial Park lying outside of the Candle Lake Game Preserve;
 - (b) that portion of Wildlife Management Zone 47 that lies north of Provincial Highway No. 3 and west of Provincial Highway No. 26;
 - (c) that portion of Wildlife Management Zone 47 that lies north of Provincial Highway No. 3, east of Provincial Highway No. 4 and west of Grid Road No. 696;
 - (d) that portion of Wildlife Management Zone 50 that lies north of Provincial Highway No. 55;
 - (e) that portion of Wildlife Management Zone 67 that lies east of Provincial Highway No. 4 and Grid Road No. 696 and south of the Fourteenth Baseline; or
 - (f) that portion of Wildlife Management Zone 68 that lies south of the south boundary of Township 59, Provincial Highway No. 21 and Grid Road No. 699.
- (2) It is lawful for a person who is the holder of a Saskatchewan Resident Special Elk Licence to hunt a total of one elk of either sex:
- (a) on the seventh day after Labour Day and the following consecutive five days in Wildlife Management Zones 33, 37, 40, 42 and 43, including Duck Mountain and Moose Mountain Provincial Parks;
 - (b) on the Monday closest to August 31, or August 31 if it falls on a Monday, and the following consecutive 19 days in:
 - (i) that portion of Wildlife Management Zone 50 south of Provincial Highway No. 55, including Fort-a-la-Corne Wildlife Management Unit; and
 - (ii) Wildlife Management Zone 52.

Moose

8(1) It is lawful for a person who is the holder of a Saskatchewan Resident Moose Licence to hunt a total of one moose of either sex on the Monday closest to September 20, or September 20 if it falls on Monday, and the following consecutive 12 days in:

- (a) Wildlife Management Zones 37, 43, 48, 49 and 53;
- (b) that portion of Wildlife Management Zone 54 that lies north of Provincial Highway No. 3, including Clearwater River, Duck Mountain, Lac La Ronge, Meadow Lake, Narrow Hills and Wildcat Hill Provincial Parks, and that portion of Clarence-Steepbank Lakes Provincial Park lying outside of the Candle Lake Game Preserve; and
- (c) Wildlife Management Zones 55 to 73.

(2) It is lawful for a person who is the holder of a Saskatchewan Resident Special Moose Licence to hunt a total of one moose of either sex on the Monday closest to September 20, or September 20 if it falls on a Monday, and the following consecutive 12 days in:

- (a) Wildlife Management Zone 37;
- (b) that portion of Wildlife Management Zone 47 that lies north of Provincial Highway No. 3 and west of Provincial Highway No. 26;
- (c) Wildlife Management Zones 48 to 50;
- (d) that portion of Wildlife Management Zone 54 that lies north of Provincial Highway No. 3, including Fort-a-la-Corne Wildlife Management Unit and Duck Mountain, Greenwater Lake, Narrow Hills and Wildcat Hill Provincial Parks, and that portion of Clarence-Steepbank Lakes Provincial Park lying outside of the Candle Lake Game Preserve; and
- (e) Wildlife Management Zones 55 to 68.

Antelope

9 It is lawful for a person who is the holder of a Saskatchewan Resident Antelope Licence to hunt a total of one antelope of either sex:

- (a) on Labour Day and the following consecutive 40 days in Wildlife Management Zones 1 to 15, 18, 19, 25 and 26; or
- (b) on the Wednesday following Labour Day and the following consecutive 38 days in Saskatchewan Landing Provincial Park.

Mule Deer

10(1) It is lawful for a person who is the holder of a Saskatchewan Resident Mule Deer Archery Licence to hunt a total of one mule deer of either sex:

- (a) on Labour Day and the following consecutive 40 days in Wildlife Management Zones 1 to 8, 13 to 31, 33, 36, 41 and 44 to 47, including Brokenshell No. 1, Brokenshell No. 2, Elbow and Great Bend Wildlife Management Units; or

- (b) on the Wednesday following Labour Day and the following consecutive 38 days in Cypress Hills (West Block) and Saskatchewan Landing Provincial Parks and that portion of Douglas Provincial Park that lies west of Diefenbaker Lake (Gordon Mackenzie Arm).
- (2) It is lawful for a person who is the holder of a Saskatchewan Resident Special Mule Deer Licence to hunt a total of one mule deer of either sex:
 - (a) on Labour Day and the following consecutive 40 days in Wildlife Management Zones 1 to 15, 17 to 31, 33, 41 and 44 to 47, including Elbow and Great Bend Wildlife Management Units; or
 - (b) on the Wednesday following Labour Day and the following consecutive 38 days in Cypress Hills (West Block) and Saskatchewan Landing Provincial Parks and that portion of Douglas Provincial Park that lies west of Diefenbaker Lake (Gordon Mackenzie Arm).
- (3) It is lawful for a person who is the holder of one or two Saskatchewan Resident Special Non-trophy Mule Deer Licences to hunt a total of one non-trophy mule deer per licence:
 - (a) on Labour Day and the following consecutive 40 days in Wildlife Management Zones 1 to 14, 19, 20, 23 to 30, 45 and 46, including Elbow Wildlife Management Unit; or
 - (b) on the Wednesday following Labour Day and the following consecutive 38 days in Saskatchewan Landing and Cypress Hills (West Block) Provincial Parks and that portion of Douglas Provincial Park that lies west of Diefenbaker Lake (Gordon Mackenzie Arm).

Muzzle-loading firearm seasons

- 11** No person shall hunt by any means other than a muzzle-loading firearm during any open season established pursuant to sections 12 to 16.

- 12(1)** It is lawful for a person who is the holder of a First Saskatchewan Resident White-tailed Deer Licence to hunt a total of one white-tailed deer of either sex on the twenty-eighth day following Labour Day and the following consecutive 26 days in:
- (a) Wildlife Management Zones 1 to 55, including Brokenshell No. 1, Brokenshell No. 2, Elbow, Fort-a-la-Corne, Great Bend and Horsehide Lake Wildlife Management Units; and
 - (b) Cypress Hills (West Block), Duck Mountain, Moose Mountain and Saskatchewan Landing Provincial Parks and that portion of Douglas Provincial Park that lies west of Diefenbaker Lake (Gordon Mackenzie Arm).

(2) It is lawful for a person who is the holder of a First Saskatchewan Resident White-tailed Deer Licence, a Second Saskatchewan Resident White-tailed Deer Licence, a First Canadian Resident White-tailed Deer Licence, a Second Canadian Resident White-tailed Deer Licence, a First Non-resident White-tailed Deer Licence or a Second Non-resident White-tailed Deer Licence to hunt a total of one white-tailed deer of either sex on the seventh day following Labour Day and the following consecutive 47 days in Wildlife Management Zones 56 to 69, including Greenwater Lake, Meadow Lake, Narrow Hills and Wildcat Hill Provincial Parks, and that portion of Clarence-Steepbank Lakes Provincial Park lying outside of the Candle Lake Game Preserve.

(3) It is lawful for a person who is the holder of First Saskatchewan Resident White-tailed Deer Licence, a First Canadian Resident White-tailed Deer Licence or a First Non-resident White-tailed Deer Licence to hunt a total of one white-tailed deer of either sex on the Monday closest to August 24, or August 24 if it falls on a Monday, and the following consecutive 103 days in Wildlife Management Zones 70 to 76, including Clearwater River and Lac La Ronge Provincial Parks.

(4) It is lawful for a person who is a Saskatchewan resident and holds a First Saskatchewan Non-trophy White-tailed Deer Licence to hunt a total of one non-trophy white-tailed deer on the twenty-eighth day following Labour Day and the following consecutive 26 days in:

- (a) Wildlife Management Zones 1 to 5, 7 to 21, 30 to 39, 48 and 49, including Brokenshell No. 1 and Brokenshell No. 2 Wildlife Management Units; and
- (b) Cypress Hills (West Block), Duck Mountain, Moose Mountain and Saskatchewan Landing Provincial Parks.

(5) It is lawful for a person who is a Saskatchewan resident and holds a Second Saskatchewan Non-trophy White-tailed Deer Licence to hunt a total of one non-trophy white-tailed deer on the twenty-eighth day following Labour Day and the following consecutive 26 days in:

- (a) Wildlife Management Zones 4, 20, 32, 33 and 35, including Moose Mountain Provincial Park;
- (b) that portion of Wildlife Management Zone 1 west of Provincial Highway No. 34;
- (c) those portions of Wildlife Management Zones 31 and 34 lying east of Provincial Highway No. 9; and
- (d) that portion of Wildlife Management Zone 30 that comprises the Shotgun-Archery/Muzzleloader Area.

Elk

13 It is lawful for a person who is the holder of a Saskatchewan Resident Special Elk Licence to hunt a total of one elk of either sex:

- (a) on the twenty-eighth day following Labour Day and the following consecutive five days in Wildlife Management Zones 33, 37, 40, 42 and 43, including Duck Mountain and Moose Mountain Provincial Parks; or

(b) on the Monday closest to August 31, or August 31 if it falls on a Monday, and the following consecutive 19 days in:

(i) that portion of Wildlife Management Zone 50 that lies south of Provincial Highway No. 55, including Fort-a-la-Corne Wildlife Management Unit; and

(ii) Wildlife Management Zone 52.

Moose

14 It is lawful for a person who is the holder of a Saskatchewan Resident Special Moose Licence to hunt a total of one moose of either sex on the Monday closest to September 20, or September 20 if it falls on a Monday, and the following consecutive 12 days in:

(a) Wildlife Management Zone 37;

(b) that portion of Wildlife Management Zone 47 that lies north of Provincial Highway No. 3 and west of Provincial Highway No. 26;

(c) Wildlife Management Zones 48, 49 and 50;

(d) that portion of Wildlife Management Zone 54 that lies north of Provincial Highway No. 3, including Fort-a-la-Corne Wildlife Management Unit and Duck Mountain, Greenwater Lake, Narrow Hills and Wildcat Hill Provincial Parks; and

(e) Wildlife Management Zones 55 to 68.

Antelope

15 It is lawful for a person who is the holder of a Saskatchewan Resident Special Antelope Licence to hunt a total of one antelope of either sex on the twenty-eighth day following Labour Day and the following consecutive 12 days in Wildlife Management Zones 1, 2, 4 to 15, 18, 19, 25 and 26, including Saskatchewan Landing Provincial Park.

Mule Deer

16(1) It is lawful for a person who is the holder of a Saskatchewan Resident Special Mule Deer Licence to hunt a total of one mule deer of either sex on the twenty-eighth day following Labour Day and the following consecutive 12 days in Wildlife Management Zones 1 to 31, 33, 36, 40, 41 and 44 to 47, including Elbow and Great Bend Wildlife Management Units and Cypress Hills (West Block) and Saskatchewan Landing Provincial Parks and that portion of Douglas Provincial Park that lies west of Diefenbaker Lake (Gordon Mackenzie Arm).

(2) It is lawful for a person who is the holder of a Saskatchewan Resident Special Non-trophy Mule Deer Licence to hunt a total of one non-trophy mule deer on the twenty-eighth day following Labour Day and the following consecutive 12 days in Wildlife Management Zones 1 to 14, 19, 20, 23 to 30, 45 and 46, including Elbow Wildlife Management Unit and Cypress Hills (West Block) and Saskatchewan Landing Provincial Parks and that portion of Douglas Provincial Park that lies west of Diefenbaker Lake (Gordon Mackenzie Arm).

Protected areas and recreational sites

17 Where a wildlife management zone is opened for hunting a species of big game by clause 6(2)(a), section 7, section 8, subsection 12(2), section 13 or section 14, the following protected areas and recreation sites lying within that wildlife management zone are deemed to be open for hunting that species on the Wednesday following Labour Day and closed on the last day of the season for that species:

- (a) Anderson Island Protected Area;
- (b) Bronson Forest Recreation Site;
- (c) Round Lake Recreation Site;
- (d) Waskwei River Protected Area;
- (e) Wildcat Hill Protected Area.
