CHAPTER W-13.1 REG 64

The Wildlife Act, 1997

Title

1 These regulations may be cited as *The Big Game Open Seasons Regulations, 1995*.

Interpretation

2 In these regulations:

- (a) “**Act**” means *The Wildlife Act, 1997*;
- (b) “**antlered elk**” means an elk having an antler at least 15 centimetres in length as measured on the outside curve of the antler from the skull to the tip;
- (c) “**assigned operating area**” means the area of land defined in an outfitter’s licence issued pursuant to *The Outfitter and Guide Regulations, 1988* where an outfitter is authorized to provide an outfitting service to hunt wildlife;
- (d) “**bull moose**” means a male moose that is at least one year old;
- (e) “**calf moose**” means any moose born during the year in which hunting is taking place;
- (f) “**Canadian resident**” means a person who has his or her principal residence in Canada and who is a Canadian citizen or has resided in Canada for the 12 months preceding the date of his or her application for a licence;
- (g) “**Cypress Hills Provincial Park (West Block)**” means that portion of Cypress Hills Provincial Park adjoining the Alberta-Saskatchewan boundary;
- (h) “**Indian Band**” means a band as defined in the *Indian Act* (Canada) and includes the council of a band;
- (i) “**Indian reserve**” means a reserve as defined in the *Indian Act* (Canada);
- (j) “**muzzle-loading firearm**” means a firearm that is loaded through the front opening of the barrel;
- (k) “**non-resident**” means a person who is neither a Saskatchewan resident nor a Canadian resident;
- (l) “**non-trophy elk**” means a female elk or an elk born during the year in which hunting is taking place;
- (m) “**non-trophy mule deer**” means a female mule deer or a mule deer born during the year in which hunting is taking place;
- (n) “**non-trophy white-tailed deer**” means a female white-tailed deer or a white-tailed deer born during the year in which hunting is taking place;
- (o) “**open season**” means an open season established pursuant to any regulations made pursuant to the Act during which it is lawful to hunt a particular species of wildlife;
- (p) “**protected area**” means a protected area constituted pursuant to *The Parks Act*;

- (q) “**provincial park**” means a provincial park constituted pursuant to *The Parks Act*;
- (r) “**recreation site**” means a recreation site constituted pursuant to *The Recreation Sites Regulations, 1991*;
- (s) “**Saskatchewan resident**” means a person who:
 - (i) is a Canadian resident, has his or her principal residence in Saskatchewan and has resided in Saskatchewan for the three months preceding the date of his or her application for a licence; or
 - (ii) is a member of the regular force of the Canadian Armed Forces or of the Royal Canadian Mounted Police and is stationed and residing in Saskatchewan;
- (t) “**special**” means, with respect to a licence, a big game computer draw licence issued in accordance with Part IX of *The Wildlife Regulations, 1981* and these regulations;
- (u) “**wildlife management unit**” means a wildlife management unit constituted by *The Wildlife Management Zones and Special Areas Boundaries Regulations, 1990*;
- (v) “**wildlife management zone**” means a wildlife management zone constituted by *The Wildlife Management Zones and Special Areas Boundaries Regulations, 1990*.

Validity of licence

4 A licence permits its holder to hunt pursuant to these regulations only during the year in which it is issued.

Restrictions and conditions re hunting

5 Every person who hunts pursuant to the authority of these regulations shall comply with any restrictions on and conditions relating to hunting contained in the Act, in these regulations and in any other regulations made pursuant to the Act, or specified on the person’s licence.

SASKATCHEWAN RESIDENT BIG GAME OPEN SEASONS

White-tailed deer**6(1)** Subject to subsection (2):

(a) a holder of a First Saskatchewan Resident White-tailed Deer Licence may hunt white-tailed deer of either sex in:

(i) Wildlife Management Zones 1 to 19, 21 to 41 and 44 to 46, including Brokenshell No. 1, Brokenshell No. 2, Elbow, Estevan-Cambria and Lomond Wildlife Management Units, Cypress Hills (West Block), Duck Mountain, Moose Mountain and Saskatchewan Landing Provincial Parks and that portion of Douglas Provincial Park lying west of Lake Diefenbaker (Gordon MacKenzie Arm), from:

(A) November 18 to December 7 in 1996;

(B) November 17 to December 6 in 1997;

(C) November 16 to December 5 in 1998;

(ii) Wildlife Management Zones 56 to 66 and 69, including Greenwater Lake, Meadow Lake, Narrow Hills, Wildcat Hill and Clarence-Steepbank Lakes Provincial Parks, from:

(A) September 30 to October 26 in 1996;

(B) September 29 to October 25 in 1997;

(C) September 28 to October 24 in 1998;

(iii) Wildlife Management Zones 42, 43 and 47 to 69 and Regina-Moose Jaw, Saskatoon and Prince Albert Wildlife Management Zones, including Fort-a-la-Corne, Great Bend and Horsehide Lake Wildlife Management Units, and Greenwater Lake, Meadow Lake, Narrow Hills, Wildcat Hill and Clarence-Steepbank Lakes Provincial Parks, from:

(A) November 4 to December 7 in 1996;

(B) November 3 to December 6 in 1997;

(C) November 2 to December 5 in 1998;

(iv) Wildlife Management Zones 70 to 76, including Clearwater River and Lac La Ronge Provincial Parks, from:

(A) August 26 to December 7 in 1996;

(B) August 25 to December 6 in 1997;

(C) August 24 to December 5 in 1998;

(b) a Saskatchewan resident who holds a First Saskatchewan Non-trophy White-tailed Deer Licence may hunt non-trophy white-tailed deer in:

(i) Wildlife Management Zones 1, 4, 15 to 22 and 30 to 40, including Brokenshell No.1, Brokenshell No.2, Estevan-Cambria, Lomond and Great Bend Wildlife Management Units and Duck Mountain and Moose Mountain Provincial Parks, from:

(A) November 18 to December 7 in 1996;

(B) November 17 to December 6 in 1997;

(C) November 16 to December 5 in 1998;

(ii) Wildlife Management Zones 42, 43, 47 to 55 and Prince Albert, Regina-Moose Jaw and Saskatoon Wildlife Management Zones, including Fort-à-la-Corne and Horsehide Lake Wildlife Management Units, from:

- (A) November 4 to December 7 in 1996;
- (B) November 3 to December 6 in 1997;
- (C) November 2 to December 5 in 1998;

(c) a Saskatchewan resident who holds a Second Saskatchewan Non-trophy White-tailed Deer Licence may hunt non-trophy white-tailed deer in Prince Albert Wildlife Management Zone from September 7 to December 5 in 1998;

(e) a holder of a Saskatchewan Resident Special Moose Licence who also holds a First Saskatchewan Resident White-tailed Deer Licence may hunt white-tailed deer of either sex in one of the following zones specified on the moose licence, namely, Wildlife Management Zones 40, 42, 48, 49, 56 to 59 and 62 to 66, including Greenwater Lake, Narrow Hills, Wildcat Hill and Clarence-Steepbank Lakes Provincial Parks, from:

- (i) September 23 to September 28 in 1996;
- (ii) September 22 to September 27 in 1997;
- (iii) September 21 to September 26 in 1998;

(f) a holder of a Saskatchewan Resident Special Moose Licence valid to hunt in Fort-a-la-Corne Wildlife Management Unit who also holds a First Saskatchewan Resident White-tailed Deer Licence may hunt white-tailed deer of either sex in Fort-a-la-Corne Wildlife Management Unit, from:

- (i) September 23 to October 5 in 1996;
- (ii) September 22 to October 4 in 1997;
- (iii) September 21 to October 3 in 1998;

(g) a holder of a Saskatchewan Resident Elk Licence who also holds a First Saskatchewan Resident White-tailed Deer Licence may hunt white-tailed deer of either sex in Wildlife Management Zones 56 to 66 and 69, including Meadow Lake and Clarence-Steepbank Lakes Provincial Parks, from:

- (i) September 16 to September 28 in 1996;
- (ii) September 15 to September 27 in 1997;
- (iii) September 14 to September 26 in 1998;

(h) a holder of a Saskatchewan Resident Special Elk Licence who also holds a First Saskatchewan Resident White-tailed Deer Licence may hunt white-tailed deer of either sex in one of the following zones specified on the elk licence, namely, in:

- (i) Wildlife Management Zone 52 and that portion of Wildlife Management Zone 54 lying east of Provincial Highway No. 40 and in Fort-a-la-Corne Wildlife Management Unit, from:
 - (A) September 2 to September 21 in 1996;
 - (B) September 1 to September 20 in 1997;

- (C) August 31 to September 19 in 1998;
 - (ii) Greenwater Lake Provincial Park from September 9 to September 26 in 1998.
- (2) No person who hunts white-tailed deer during any open season established by subsection (1) shall hunt any white-tailed deer:
- (a) in Prince Albert Wildlife Management Zone, except by means of a bow and arrow; or
 - (b) in Great Bend Wildlife Management Unit and Saskatchewan Landing Provincial Park, except by means of a muzzle-loading firearm or a bow and arrow.

 - (ii) that portion of Wildlife Management Zone 47 lying north of Provincial Highway No. 3 and west of Provincial Highway No. 26 from:

8(1) A holder of a Saskatchewan Resident Moose Licence may hunt bull moose or calf moose in:

(a) Wildlife Management Zones 43, 48 to 50, 53, 56 to 67 and 69, including Meadow Lake, Narrow Hills, Wildcat Hill and Clarence-Steepbank Lakes Provincial Parks, from:

- (i) October 2 to October 7 in 1995;
- (ii) October 7 to October 12 in 1996;
- (iii) October 13 to October 18 in 1997;
- (iv) October 12 to October 17 in 1998;

(b) Wildlife Management Zones 70 to 73, including Lac La Ronge Provincial Park and that portion of Clearwater River Provincial Park lying south of 57° latitude, from:

- (i) September 4 to September 16 and October 2 to November 25 in 1995;
- (ii) September 9 to September 21 and October 7 to November 30 in 1996;
