**CHAPTER 93**

**An Act to provide for the Exemption from Taxation of certain Property  
of La Corporation Episcopale Catholique Romaine de Prince Albert**

(Assented to March 29, 1969)

**Preamble**

WHEREAS a petition has been presented praying for an Act of the Legislative Assembly of Saskatchewan to provide for exemption of the property hereinafter mentioned from all taxes, rates, levies and assessments save and except local improvement levies, frontage taxes and special assessments, levies or taxes; and

Whereas it is expedient to grant the prayer of the said petition:

Therefore Her Majesty, by and with the advice and consent of the Legislative Assembly of Saskatchewan, enacts as follows:

**Exemption from taxation**

**1** The real property of La Corporation Episcopale Catholique Romaine de Prince Albert, being a corporation established by chapter 9 of the *Ordinances of the North West Territories, 1892*, as amended by chapter 59 of the *Statutes of Saskatchewan 1910-11*, situated in the Village of St. Louis, in the Province of Saskatchewan and composed of:

Parcels "H" and "J", both in the Village of St. Louis, in the Province of Saskatchewan, in the Dominion of Canada, according to a Plan of Record in the Land Titles Office for the Prince Albert Land Registration District as No. 64 PA 12916. Subject to the minerals, exceptions, reservations and conditions contained in instrument registered as No. 61 PA 08110 as to portion of Parcel "J", formerly in Original Road Allowance. Excepting thereout and therefrom: All mines and minerals by virtue of registration of Plan 64 PA 12916 — as to balance;

while used by Le College Catholique Romaine de Prince Albert, being a corporation established by chapter 78 of the *Statutes of Saskatchewan, 1956*, for the purposes of that corporation as set out in the said chapter, are exempt from all taxes, rates, levies and assessments of every nature and kind and except local improvement levies, frontage taxes and special assessments, levies or taxes.
