CHAPTER 99

**An Act to provide for Partial Exemption from Taxation of Certain
Lands of The Free Methodist Church in Canada**

(Assented to March 31, 1954)

Preamble

WHEREAS The Free Methodist Church in Canada was incorporated by chapter 107 of the Statutes of Canada, 1926-27, 17 George V, having as its objects religious training and instruction and the conduct of places of worship; and

Whereas the said corporation has by petition prayed for a partial exemption from taxes as hereinafter set forth of certain lands and buildings in the City of Moose Jaw registered under the name of The Board of Home Missions and Evangelism of The Free Methodist Church in Canada, a Board appointed and controlled by the said corporation; and

Whereas the City of Moose Jaw has by resolution consented to such exemption; and

Whereas it is expedient to grant the prayer of the said petition:

Therefore Her Majesty, by and with the advice and consent of the Legislative Assembly of Saskatchewan, enacts as follows:

Partial exemption from taxation

1 All that portion of the north-east quarter of section twenty-eight (28) in township sixteen (16) in range twenty-six (26) west of the second meridian in the Province of Saskatchewan which lies east of a line parallel with and eight hundred and twenty-five (825) feet perpendicularly distant from the west boundary of the said quarter section, excepting thereout all that portion thereof included in Rothesay Park Addition to the City of Moose Jaw as the same is shown upon a plan of record in the land titles office for the Moose Jaw Land Registration District as No. S.3865, together with all buildings erect or to be erected thereon, is hereby declared to be subject to taxation by the City of Moose Jaw as follows:

(a) All local improvement taxes and special rates levied by the City of Moose Jaw thereon shall be paid in full by the said corporation or the said board;

(b) The said land and buildings shall be assessed annually by the City of Moose Jaw according to the provisions of *The City Act* and the said corporation and board shall be exempt from payment of two-thirds of the taxes levied annually on such land and buildings on the basis of the annual assessment and mill rate, such exemption to apply and be effective only so long as said land and buildings are used to religious, educational and moral training purposes by the said corporation or the said board.
