CHAPTER 89

An Act to confirm a Certain Agreement entered into between the City
of Saskatoon and His Majesty the King and to authorise the Purchase
of Certain Property for the Purpose of an Interior Terminal Elevator

(Assented to December 19, 1913)

Preamble

WHEREAS by resolution of the council of the city of Saskatoon, dated the twenty eighth day of July, 1913, it was decided that the city of Saskatoon should enter into an agreement with the government of the Dominion of Canada for the sale to the said government of certain land near the said city for the purpose of an interior terminal elevator for the sum of one dollar (\$1.00); and

Whereas on the twenty-eighth day of July, 1913, the city of Saskatoon, pursuant to the said resolution of council, did give the said government an option irrevocable until the twenty-seventh day of October, A.D. 1913, to purchase for the sum of one dollar (\$1.00), free from incumbrances, all that certain parcel of land situate, lying and being in section twenty-five (25) township thirty-six (36) range six (6) west of the third principal meridian in the Province of Saskatchewan, and being composed of all that portion of the south-west quarter of section twenty-five (25) township thirty-six (36) range six (6) aforesaid lying south of the right of way of the Canadian Pacific Railway, for the purpose of an interior terminal elevator; and

Whereas the said option, under the terms thereof, was made acceptable by a letter delivered to the mayor or city clerk of the said corporation, or mailed, postage prepaid, and registered, addressed to either the mayor or city clerk of the said corporation, and upon such acceptance was to constitute a binding contract of purchase and sale; and

Whereas the said option was accepted by the said government by registered letter mailed to the city clerk on the seventeenth day of September, 1913, according to the terms of the said option; and

Whereas the city of Saskatoon has presented a petition to the Legislature of the Province of Saskatchewan praying for the ratification, confirmation and validation of the said agreement between the city of Saskatoon and the government of the Dominion of Canada, and authorising the said city to transfer the said land to the said government for the sum of one dollar (\$1.00) for the purpose of an interior terminal elevator; and

Whereas it is expedient to grant the prayer of the said petition:

Now therefore His Majesty by and with the advice and consent of the Legislative Assembly of Saskatchewan enacts as follows:

Agreement ratified

1 The said agreement as contained in the said option given by the said city on the twenty-eighth day of July, 1913, and acceptance by the said government by letter dated the seventeenth day of September, 1913, for the purchase by the said government for the sum of one dollar (\$1.00) free from all incumbrances, of all that certain parcel of land situate, lying and being in section twenty-five (25) township thirty-six (36) range six (6) west of the third principal meridian in the Province of Saskatchewan, and being composed of all that portion of the south-west quarter of section twenty-five (25) township thirty-six (36) range six (6) aforesaid, lying south of the right of way of the Canadian Pacific Railway comprising forty-five acres more or less for the purpose of an interior terminal elevator, is hereby ratified, confirmed and validated and the parties thereto are hereby authorised to carry out the provisions thereof; and the said city shall be deemed to have had power to enter into the said agreement notwithstanding anything contained in *The City Act*.

Authority to transfer land

2 The said city is hereby authorised to transfer the said land to the said government, for the sum of one dollar (\$1.00); and the said city shall be deemed to have power to transfer the said land to the said government notwithstanding anything contained in *The City Act*.
