**CHAPTER 104**

An Act respecting St. Peter's Hospital, Melville, being An Act to amend  
and consolidate An Act to incorporate St. Peter's Hospital, Melville

(Assented to May 19, 1981)

**Preamble**

WHEREAS St. Peter's Hospital, Melville, was incorporated by *An Act to incorporate St. Peter's Hospital, Melville*, being chapter 97 of the *Statutes of Saskatchewan, 1968*; and

Whereas the Sisters of St. Martha have by petition prayed to further amend and consolidate *An Act to incorporate St. Peter's Hospital, Melville*; and

Whereas it is expedient to grant the prayer of the said petition:

Therefore Her Majesty, by and with the advice and consent of the Legislative Assembly of Saskatchewan, enacts as follows:

**Interpretation**

**1** In this Act:

- (a) “**corporation**” means St. Peter's Hospital, Melville, continued under subsection 2(1);
- (b) “**Council**” means the Catholic Health Council of Saskatchewan;
- (c) “**directors**” means the directors of the corporation.

**Corporation continued**

**2(1)** St. Peter's Hospital, Melville, is continued as a body corporate.

**(2)** One or more persons who are appointed by the Council constitute the corporation.

**Objects**

**3** The objects of the corporation are to care for the aged, the ill and the infirm through charitable and benevolent activities, including the operation of hospitals, orphanages, schools of nursing and other institutions.

**Head office**

**4(1)** The head office of the corporation is to be at the City of Melville or at any other place in the province that may be determined by the bylaws of the corporation.

(2) The directors of the corporation may establish branch offices at any place in the province.

#### **Powers**

5(1) Subject to the other provisions of this Act, the corporation has the capacity, rights, powers and privileges of a natural person.

(2) The corporation may:

- (a) invest all or a portion of its funds in any property or security;
- (b) borrow or raise money and may secure its repayment by issuing bonds, debentures, bills of exchange, promissory notes, mortgages or any other instrument that the directors may consider necessary;
- (c) fix fees for any services rendered by the corporation and for the board and lodging of students and patients;
- (d) enter into a contract or any other arrangement to affiliate the corporation with any other corporation which has similar objects;
- (e) erect, construct, equip and maintain any buildings that the directors consider necessary;
- (f) operate any industry that, in the opinion of the directors, will help to maintain its institutions.

#### **Use of revenues**

6 The corporation shall apply any rents, revenues and profits from its property or from any of its industries:

- (a) to maintain its institutions;
- (b) to construct and repair its buildings;
- (c) to acquire any property that, in the opinion of the directors, is required to advance its objects; or
- (d) for any other purpose that the directors consider expedient.

#### **Bylaws**

7 The corporation may make, repeal and amend bylaws:

- (a) for the government and proper administration of its property, affairs and interests;
- (b) in matters of discipline, admission, retirement, appointment and removal of its members, directors and officers of the corporation;
- (c) for the distribution of its assets upon any winding up;
- (d) for the internal government of its affairs.

**Execution of instruments**

**8** The corporation shall execute all instruments relating to real property under its seal and all such instruments must be attested in accordance with any procedure that the bylaws of the corporation may provide.

**Directors and officers**

**9** Unless otherwise directed by the bylaws, all persons appointed pursuant to subsection 2(2) are the directors and officers of the corporation.

**Attorneys**

**10** The corporation may appoint one or more persons as attorneys to transact the business of the corporation.

**Transfer of real property**

**11** Where any interest in real property is transferred from the Sisters of St. Martha to the corporation, the registrar of the land registration district in which the real property lies shall, without fee or charge, cancel, correct, substitute or issue any certificate of title, make any memorandum or entry on a certificate of title or do any other act necessary to vest the interest in real property in the name of the corporation.

**Accounting**

**12** When directed to do so by the Lieutenant Governor in Council, the corporation shall provide an account in writing of its property and affairs.
