CHAPTER 98

An Act to provide for Exemption from Taxation of certain Property of The Ukrainian Greek Orthodox Church of Canada

(Assented to March 29, 1968)

Preamble

WHEREAS The Ukrainian Greek Orthodox Church of Canada has presented a petition praying for an Act of the Legislative Assembly of Saskatchewan to provide for exemption, effective from the first day of January, 1968, of the property hereinafter mentioned from all taxes, rates, levies and assessments; and

Whereas it is expedient to grant the prayer of the said petition:

Therefore Her Majesty, by and with the advice and consent of the Legislative Assembly of Saskatchewan, enacts as follows:

Exemption from taxation

1 The real property of The Ukrainian Greek Orthodox Church of Canada, known as Green Grove Camp, in the district of Wakaw, in the Province of Saskatchewan, and being:

(a) Block One (1), in the Hamlet of Wakaw Beach, according to a Plan of Record in the Land Titles Office for the Prince Albert Land Registration District as No. A.E. 3030, as amended by Master of Titles Order registered as No. 63 PA 01686, Minerals in the Crown; and

(b) All that portion of the South East Quarter (S.E.¼) of Section Thirty-two (32), in Township Forty-two (42), in Range Twenty-six (26), West of the Second (2nd) Meridian, in the Province of Saskatchewan, in the Dominion of Canada, which lies Southerly of the South limit of Block One (1), and East of the Southerly production of the West limit of Block One (1), as the said Block is shown on a Plan of Wakaw Beach, of record in the Land Titles Office for the Prince Albert Land Registration District as No. A.E. 3030, as amended by Master of Titles Orders registered as Nos. 62 PA 02541 and 63 PA 01686;

together with all the buildings erected or to be erected thereon, shall, while owned by the said The Ukrainian Greek Orthodox Church of Canada and used for religious and educational purposes, be exempt from all taxation, except for local improvement taxes, which the Rural Municipality of Hoodoo No. 401 has the power to impose, with effect from the first day of January, A.D. 1968.

Coming into force

2 This Act comes into force on the day of assent, but it is retroactive and shall be deemed to have been in force on, from and after the first day of January, 1968.
