CHAPTER 77

An Act respecting the Consequential Amendments to Certain Acts
resulting from the enactment of *The Northern Municipalities Act*

(Assented to June 17, 1983)

Short title

1 This Act may be cited as *The Northern Municipalities Consequential Amendment Act*.
