CERTIFIED COPY OF RESOLUTION OF THE BOARD OF GOVERNORS OF THE UNIVERSITY OF REGINA (the "University")

BE IT RESOLVED:

WHEREAS:

A By virtue of *The University of Regina Amendment Act, 1999* and section 90.2 of *The University of Regina Act* the Board of Governors of the University (the "Board") may make Bylaws, *inter alia*, regulating, governing, and controlling parking and signage on the University campus, and other ancillary related matters:

NOW THEREFORE BE IT RESOLVED THAT:

1 The University does hereby approve that fines for parking violations and certain other infractions on campus be brought into line with those of the City of Regina by replacing the existing Appendix A of the University's parking bylaws with the attached revised version of that appendix.

I HEREBY CERTIFY the above resolution to be a true and exact copy of the resolution passed by all of the members of the Board of the University to be effective on the 1st of September 2003, and that this resolution remains in full force and effect as of this date.

** Pursuant to section 8.6.1 of the Bylaws, the Board of Governors authorizes the parking clerks, Security Patrol Persons, or other persons in charge of the Parking Office, of any other persons who are authorized to collect payment in respect of Violation Tickets to accept the amount of \$25.00 in respect of penalties listed as \$60.00 in Appendix "A", provided that payment is made within 14 days of the issuance of the Violation Ticket.

*** Pursuant to section 8.6.1 of the Bylaws, the Board of Governors authorizes the parking clerks, Security Patrol Persons, or other persons in charge of the Parking Office, of any other persons who are authorized to collect payment in respect of Violation Tickets to accept the amount of \$15.00 in respect of penalties listed as \$50.00 in Appendix "A", provided that payment is made within 14 days of the issuance of the Violation Ticket.

**** Pursuant to section 8.6.1 of the Bylaws, the Board of Governors authorizes the parking clerks, Security Patrol Persons, or other persons in charge of the Parking Office, of any other persons who are authorized to collect payment in respect of Violation Tickets to accept the amount of \$10.00 in respect of penalties listed as \$45.00 in Appendix "A", provided that payment is made within 14 days of the issuance of the Violation Ticket.
