## CHAPTER R-20.4

### An Act respecting Representation in the Legislative Assembly

#### Short title

- 1 This Act may be cited as *The Representation Act, 2002*.

#### Composition of Legislative Assembly

- 2 Notwithstanding subsection 23(1) of *The Constituency Boundaries Act, 1993*, the Legislative Assembly shall consist of 58 members to be elected to represent the constituencies described in the Schedule.

- 3 *The Representation Act, 1994* is repealed.

#### Coming into force

- 4 Notwithstanding subsection 23(2) of *The Constituency Boundaries Act, 1993*, this Act comes into force on the day following the day the twenty-fourth Legislative Assembly is dissolved or is determined by effluxion of time.

## Schedule

### Interpretation of Constituency Boundaries

#### Boundaries of constituencies

- 1 In the following descriptions, where “**meridians**” and “**boundaries of townships**” or “**boundaries of sections**” are referred to as the boundaries of constituencies, these expressions mean the meridians, boundaries of townships or boundaries of sections, as the case may be, in accordance with the dominion land survey system and include the extensions of the meridians, boundaries of townships or boundaries of sections in accordance with that system.

#### Dividing line

- 2 If a dividing line between two ranges is mentioned as the boundary of a constituency, the expression means the surveyed line on the east boundary of the west range and the extension of that line southerly to intersect the north boundary of each township that lies to the south of a correction line and thence easterly along the north boundary of that township to the east boundary of that township.

#### North boundary

- 3 If the north boundary of a township is mentioned as the boundary of a constituency and a jog exists between the north boundaries of a township on either side of a dividing line, the expression means that the boundary of the constituency follows along the portion of the dividing line that extends between the respective north boundaries of the township.

#### Section boundaries

4 If boundaries of sections are mentioned as the boundary of a constituency and a correction line or jog exists between two section boundaries described, the expression means that the boundary of the constituency follows along the portion of the north boundary of a township or dividing line that extends between the respective section boundaries described.

#### Left bank boundary

5 If the left bank of any river or creek is mentioned as the boundary of a constituency, the expression means the bank of that river or creek on the left side of a person going in the direction in which the water flows.

#### References as defined in *The Land Surveys Act, 2000*

6 If reference is made to “**meridian**”, “**township**” or “**range**” in the following descriptions, and the meridian, township or range lies outside the portion of Saskatchewan that is subdivided in accordance with *The Land Surveys Act, 2000* and the regulations made pursuant to that Act, the reference is taken to be in accordance with the projection of the meridian, township or range within the meaning of *The Land Surveys Act, 2000* and in the regulations made pursuant to that Act.

#### Inclusion of hamlet, village or town cut by constituency boundary

7 If a constituency boundary cuts through a hamlet, village or town, and that hamlet, village or town has not been specifically mentioned in the constituency description, the boundary is to include the area of lesser population as lying within the constituency in which the part with the greater population lies.

#### References to limits of village, town or city

8 If reference in descriptions of boundaries is made to limits or incorporated limits of any village, town or city, the reference means those limits defined as of April 1, 2002.

### ARM RIVER-WATROUS

The constituency of Arm River-Watrous is bounded as follows: Commencing at the intersection of the dividing line between ranges fifteen and sixteen, west of the second meridian and the north boundary of township twenty-seven; thence westerly along the north boundary of township twenty-seven, range sixteen and continuing westerly along the north boundary of sections twelve, eleven, ten, nine, eight and seven in township twenty-eight, range seventeen, all west of the second meridian to the dividing line between ranges seventeen and eighteen, west of the second meridian; thence southerly along the said dividing line between ranges seventeen and eighteen to the north boundary of section thirteen, township twenty-five, range eighteen, west of the second meridian; thence westerly along the north boundary of sections thirteen, fourteen, fifteen, sixteen, seventeen and eighteen in township twenty-five, ranges eighteen, nineteen, twenty, twenty-one, twenty-two, twenty-three, twenty-four, twenty-five, twenty-six, twenty-seven and twenty-eight and continuing westerly along the north boundary of sections thirteen, fourteen, fifteen and sixteen in township twenty-five, range twenty-nine, all west of the second meridian to the third meridian; thence westerly along the north boundary of sections thirteen, fourteen, fifteen, sixteen, seventeen and eighteen in township twenty-five, ranges one, two, three, four and five, west of the third meridian to the dividing line between ranges five and six, west of the

third meridian; thence northerly along the said dividing line between ranges five and six to the north boundary of section eighteen, township thirty-three, range five, west of the third meridian; thence easterly along the north boundary of sections eighteen, seventeen, sixteen, fifteen, fourteen and thirteen in township thirty-three, ranges five, four, three, two and one, west of the third meridian to the third meridian; thence easterly along the north boundary of sections fourteen and thirteen in township thirty-three, range twenty-nine and continuing easterly along the north boundary of sections eighteen, seventeen, sixteen, fifteen, fourteen and thirteen in ranges twenty-eight, twenty-seven, twenty-six, twenty-five, twenty-four, twenty-three, twenty-two, twenty-one, twenty, nineteen, eighteen, seventeen and sixteen, all west of the second meridian to the dividing line between ranges fifteen and sixteen, west of the second meridian; thence southerly along the said dividing line between ranges fifteen and sixteen to the point of commencement.

### ATHABASCA

The constituency of Athabasca is bounded as follows: Commencing at the intersection of the north boundary of Meadow Lake Provincial Park and the west boundary of the province; thence northerly along the west boundary of the province to the north boundary of the province; thence easterly along the north boundary of the province to the meridian through the one hundred and fifth degree of west longitude; thence southerly along the said meridian of longitude to the fifty-ninth parallel of north latitude; thence westerly along the fifty-ninth parallel of north latitude to the third meridian; thence southerly along the third meridian to the north boundary of Prince Albert National Park; thence westerly and southerly along the north and west boundaries of Prince Albert National Park to the north boundary of township sixty; thence westerly along the north boundary of township sixty to the dividing line between ranges thirteen and fourteen, west of the third meridian; thence northerly along the said dividing line between ranges thirteen and fourteen to the north boundary of township sixty-four; thence westerly along the north boundary of township sixty-four to the east boundary of Meadow Lake Provincial Park; thence northerly and westerly along the east and north boundaries of Meadow Lake Provincial Park to the point of commencement.

### BATOCHE

The constituency of Batoche is bounded as follows: Commencing at the intersection of the dividing line between ranges twenty and twenty-one, west of the second meridian and the north boundary of section thirteen, township thirty-nine, range twenty-one, west of the second meridian; thence westerly along the north boundary of sections thirteen, fourteen, fifteen, sixteen, seventeen and eighteen in township thirty-nine, ranges twenty-one, twenty-two, twenty-three, twenty-four, twenty-five, twenty-six and twenty-seven and continuing westerly along the north boundary of sections thirteen, fourteen, fifteen, sixteen and seventeen in township thirty-nine, range twenty-eight, all west of the second meridian to the third meridian; thence westerly along the north boundary of sections thirteen, fourteen, fifteen, sixteen, seventeen and eighteen in township thirty-nine, ranges one and two and continuing westerly along the north boundary of sections thirteen, fourteen, fifteen, sixteen and seventeen in township thirty-nine, range three, all west of the third meridian to the left bank of the South Saskatchewan River; thence northeasterly along the left bank of the South Saskatchewan River to the dividing line between ranges two and three, west of the third meridian; thence northerly along the

said dividing line between ranges two and three to the south boundary of Okemasis and Beardy's Indian Reserve No. 96 and 97, being in township forty-three, range two, west of the third meridian; thence easterly, northerly and westerly along the south, east and north boundaries of Okemasis and Beardy's Indian Reserve No. 96 and 97 to the dividing line between ranges two and three, west of the third meridian; thence northerly along the said dividing line between ranges two and three to the left bank of the North Saskatchewan River; thence northeasterly and easterly along the left bank of the North Saskatchewan River to the west corporate limit of the City of Prince Albert; thence southerly, easterly, northerly and northeasterly along the west, south and east corporate limits of the City of Prince Albert to the left bank of the North Saskatchewan River; thence easterly along the left bank of the North Saskatchewan River and continuing along the left bank of the Saskatchewan River to the dividing line between ranges twenty and twenty-one, west of the second meridian; thence southerly along the said dividing line between ranges twenty and twenty-one to the point of commencement.

### **BIGGAR**

The constituency of Biggar is bounded as follows: Commencing at the intersection of the dividing line between ranges six and seven, west of the third meridian and the north boundary of section thirteen, township thirty-three, range seven, west of the third meridian; thence westerly along the north boundary of sections thirteen, fourteen, fifteen, sixteen, seventeen and eighteen in township thirty-three, ranges seven, eight, nine, ten, eleven, twelve, thirteen, fourteen, fifteen, sixteen, seventeen, eighteen and nineteen and continuing westerly along the north boundary of sections thirteen, fourteen and fifteen in township thirty-three, range twenty, all west of the third meridian to the east boundary of section twenty-one, township thirty-three, range twenty, west of the third meridian; thence northerly along the east boundary of sections twenty-one, twenty-eight and thirty-three in township thirty-three and continuing northerly along the east boundary of sections four, nine, sixteen, twenty-one, twenty-eight and thirty-three in township thirty-four, all in range twenty, west of the third meridian to the west bank of Tramping Lake; thence northerly along the west bank of Tramping Lake to the east boundary of section twenty, township thirty-eight, range twenty, west of the third meridian; thence northerly along the east boundary of sections twenty, twenty-nine and thirty-two in township thirty-eight, range twenty, west of the third meridian to the north boundary of township thirty-eight; thence easterly along the north boundary of township thirty-eight to the east boundary of section four, township thirty-nine, range twenty, west of the third meridian; thence northerly along the east boundary of sections four, nine, sixteen, twenty-one, twenty-eight and thirty-three in township thirty-nine and continuing northerly along the east boundary of sections four, nine, and sixteen in township forty, all in range twenty, west of the third meridian to the north boundary of section fifteen, township forty, range twenty, west of the third meridian; thence easterly along the north boundary of sections fifteen, fourteen and thirteen in township forty, range twenty and continuing easterly along the north boundary of sections eighteen, seventeen, sixteen, fifteen, fourteen and thirteen in township forty, ranges nineteen, eighteen and seventeen and continuing easterly along the north boundary of sections eighteen, seventeen, sixteen, fifteen and fourteen in township forty, range sixteen, all west of the third meridian to the west boundary of Red Pheasant Indian Reserve No. 108; thence southerly, easterly, northerly and westerly along the west, south, east and north boundaries of Red Pheasant Indian Reserve No. 108 to the dividing line between ranges fifteen and sixteen, west of the third meridian; thence northerly along the said

dividing line between ranges fifteen and sixteen to the north boundary of township forty-two; thence easterly along the north boundary of township forty-two to the west bank of Redberry Lake; thence southerly and easterly along the west and south banks of Redberry Lake to the east boundary of section twenty-nine, township forty-two, range eight, west of the third meridian; thence southerly along the east boundary of section twenty-nine, township forty-two to the north boundary of section twenty-one in township forty-two, range eight, west of the third meridian; thence easterly along the north boundary of sections twenty-one, twenty-two, twenty-three and twenty-four in township forty-two and continuing easterly along the north boundary of sections nineteen, twenty, twenty-one, twenty-two, twenty-three and twenty-four in township forty-two, range seven and continuing easterly along the north boundary of section nineteen in township forty-two, range six, all west of the third meridian to the left bank of the North Saskatchewan River; thence southwesterly along the left bank of the North Saskatchewan River to the dividing line between ranges six and seven, west of the third meridian; thence southerly along the said dividing line between ranges six and seven to the point of commencement.

### **CANNINGTON**

The constituency of Cannington is bounded as follows: Commencing at the southeast corner of the province; thence westerly along the south boundary of the province to the dividing line between ranges four and five, west of the second meridian; thence northerly along the said dividing line between ranges four and five to the north boundary of township three; thence westerly along the north boundary of township three to the dividing line between ranges seven and eight, west of the second meridian; thence northerly along the said dividing line between ranges seven and eight to the north boundary of township six; thence westerly along the north boundary of township six to the dividing line between ranges eleven and twelve, west of the second meridian; thence northerly along the said dividing line between ranges eleven and twelve to the north boundary of township eleven; thence easterly along the north boundary of township eleven to the dividing line between range thirty-four, west of the first meridian and range one, west of the second meridian; thence southerly along the said dividing line between range thirty-four and range one to the north boundary of township ten; thence easterly along the north boundary of township ten to the east boundary of the province; thence southerly along the east boundary of the province to the point of commencement.

### **CANORA-PELLY**

The constituency of Canora-Pelly is bounded as follows: Commencing at the intersection of the east boundary of the province and the north boundary of township twenty-six; thence westerly along the north boundary of township twenty-six to the dividing line between ranges six and seven, west of the second meridian; thence northerly along the said dividing line between ranges six and seven to the north boundary of township forty-four; thence easterly along the north boundary of township forty-four to the east boundary of the province; thence southerly along the east boundary of the province to the point of commencement.

### **CARROT RIVER VALLEY**

The constituency of Carrot River Valley is bounded as follows: Commencing at the intersection of the east boundary of the province and the north boundary of township forty-four; thence westerly along the north boundary of township forty-four to the dividing line between ranges fifteen and sixteen, west of the second meridian; thence northerly along the said dividing line between ranges fifteen and sixteen to the left

bank of the Saskatchewan River; thence northeasterly along the left bank of the Saskatchewan River to the reservoir known as Tobin Lake; thence northeasterly along the northwest limit of the full supply level of the reservoir known as Tobin Lake and continuing northeasterly along the right bank of the Saskatchewan River to the dividing line between ranges seven and eight, west of the second meridian; thence southerly along the said dividing line between ranges seven and eight to the north boundary of township fifty-four; thence easterly along the north boundary of township fifty-four to the east boundary of the province; thence southerly along the east boundary of the province to the point of commencement.

### CUMBERLAND

The constituency of Cumberland is bounded as follows: Commencing at the intersection of the east boundary of the province and the north boundary of township fifty-four; thence westerly along the north boundary of township fifty-four to the dividing line between ranges seven and eight, west of the second meridian; thence northerly along the said dividing line between ranges seven and eight to the right bank of the Saskatchewan River; thence westerly along the right bank of the Saskatchewan River and continuing westerly along the north limit of the full supply level of the reservoir known as Tobin Lake to the dividing line between ranges eleven and twelve, west of the second meridian; thence northerly along the said dividing line between ranges eleven and twelve to the north boundary of township fifty-five; thence westerly along the north boundary of township fifty-five to the dividing line between ranges twenty-one and twenty-two, west of the second meridian; thence northerly along the said dividing line between ranges twenty-one and twenty-two to the north boundary of township fifty-seven; thence westerly along the north boundary of township fifty-seven to the third meridian; thence northerly along the third meridian to the fifty-ninth parallel of north latitude; thence easterly along the fifty-ninth parallel of north latitude to the meridian through the one hundred and fifth degree of west longitude; thence northerly along the said meridian of longitude to the north boundary of the province; thence easterly along the north boundary of the province to the east boundary of the province; thence southerly along the east boundary of the province to the point of commencement; and including therein that part of the Montreal Lake Indian Reserve No. 106 lying south of the north boundary of township fifty-seven.

### CUT KNIFE-TURTLEFORD

The constituency of Cut Knife-Turtleford is bounded as follows: Commencing at the intersection of the west boundary of Red Pheasant Indian Reserve No. 108 and the north boundary of section fourteen, township forty, range sixteen, west of the third meridian; thence westerly along the north boundary of sections fourteen, fifteen, sixteen, seventeen and eighteen in township forty, range sixteen and continuing westerly along the north boundary of sections thirteen, fourteen, fifteen, sixteen, seventeen and eighteen in township forty, ranges seventeen, eighteen, nineteen, twenty, twenty-one, twenty-two, twenty-three, twenty-four, twenty-five, twenty-six and twenty-seven and continuing westerly along the north boundary of sections thirteen, fourteen, fifteen, sixteen and seventeen in township forty, range twenty-eight, all west of the third meridian to the west boundary of the province; thence northerly along the west boundary of the province to the north boundary of township forty-eight; thence easterly along the north boundary of township forty-eight to the dividing line between ranges twenty-two and twenty-three, west of the third meridian; thence northerly along the said dividing line between

ranges twenty-two and twenty-three to the north boundary of section eighteen, township fifty-one, range twenty-two, west of the third meridian; thence easterly along the north boundary of sections eighteen, seventeen, sixteen, fifteen, fourteen and thirteen in township fifty-one, ranges twenty-two, twenty-one, twenty, nineteen, eighteen, seventeen and sixteen, all west of the third meridian to the dividing line between ranges fifteen and sixteen, west of the third meridian; thence southerly along the said dividing line between ranges fifteen and sixteen to the north boundary of Moosomin Indian Reserve No. 112B; thence easterly, southerly and westerly along the north, east and south boundaries of Moosomin Indian Reserve No. 112B to the dividing line between ranges fifteen and sixteen, west of the third meridian; thence southerly along the said dividing line between ranges fifteen and sixteen to the north boundary of Red Pheasant Indian Reserve No. 108; thence easterly, southerly, westerly and northerly along the north, east, south and west boundaries of Red Pheasant Indian Reserve No. 108 to the point of commencement; excluding the constituency of The Battlefords.

### **CYPRESS HILLS**

The constituency of Cypress Hills is bounded as follows: Commencing at the southwest corner of the province; thence northerly along the west boundary of the province to the left bank of the Red Deer River; thence southeasterly along the left bank of the Red Deer River to its confluence with the South Saskatchewan River; thence easterly along the left bank of the South Saskatchewan River and continuing southeasterly along the north limit of the full supply level of the reservoir known as Lake Diefenbaker to the dividing line between ranges seventeen and eighteen, west of the third meridian; thence southerly along the said dividing line between ranges seventeen and eighteen to the north boundary of township fifteen; thence easterly along the north boundary of township fifteen to the dividing line between ranges fifteen and sixteen, west of the third meridian; thence southerly along the said dividing line between ranges fifteen and sixteen to the north boundary of township eleven; thence westerly along the north boundary of township eleven to the east boundary of section thirty-three, township eleven, range eighteen, west of the third meridian; thence southerly along the east boundary of sections thirty-three, twenty-eight, twenty-one, sixteen, nine and four in townships eleven, ten, nine, eight, seven, six, five, four, three, two and one, all in range eighteen, west of the third meridian to the south boundary of the province; thence westerly along the south boundary of the province to the point of commencement.

### **ESTEVAN**

The constituency of Estevan is bounded as follows: Commencing at the dividing line between ranges four and five, west of the second meridian and the south boundary of the province; thence westerly along the south boundary of the province to the dividing line between ranges eighteen and nineteen, west of the second meridian; thence northerly along the said dividing line between ranges eighteen and nineteen to the north boundary of township six; thence easterly along the north boundary of township six to the dividing line between ranges seven and eight, west of the second meridian; thence southerly along the said dividing line between ranges seven and eight to the north boundary of township three; thence easterly along the north boundary of township three to the dividing line between ranges four and five, west of the second meridian; thence southerly along the said dividing line between ranges four and five to the point of commencement.

### **HUMBOLDT**

The constituency of Humboldt is bounded as follows: Commencing at the intersection of the dividing line between ranges twenty and twenty-one, west of the second meridian and the north boundary of section thirteen, township thirty-three, range twenty-one, west of the second meridian; thence westerly along the north boundary of sections thirteen, fourteen, fifteen, sixteen, seventeen and eighteen in township thirty-three, ranges twenty-one, twenty-two, twenty-three, twenty-four, twenty-five, twenty-six, twenty-seven and twenty-eight and continuing westerly along the north boundary of sections thirteen and fourteen in township thirty-three, range twenty-nine, all west of the second meridian to the third meridian; thence westerly along the north boundary of sections thirteen, fourteen, fifteen, sixteen, seventeen and eighteen in township thirty-three, ranges one, two and three and continuing westerly along the north boundary of sections thirteen, fourteen and fifteen in township thirty-three, range four, all west of the third meridian to the east boundary of section twenty-one, township thirty-three, range four, west of the third meridian; thence northerly along the east boundary of sections twenty-one, twenty-eight and thirty-three in township thirty-three and continuing northerly along the east boundary of sections four, nine, sixteen, twenty-one, twenty-eight and thirty-three in townships thirty-four, thirty-five, thirty-six and thirty-seven and continuing northerly along the east boundary of sections four and nine in township thirty-eight, all in range four, west of the third meridian to the north boundary of section nine, township thirty-eight, range four, west of the third meridian; thence westerly along the north boundary of section nine, township thirty-eight, range four, west of the third meridian to the left bank of the South Saskatchewan River; thence northeasterly along the left bank of the South Saskatchewan River to the north boundary of section seventeen, township thirty-nine, range three, west of the third meridian; thence easterly along the north boundary of sections seventeen, sixteen, fifteen, fourteen and thirteen in township thirty-nine, range three and continuing easterly along the north boundary of sections eighteen, seventeen, sixteen, fifteen, fourteen and thirteen in township thirty-nine, ranges two and one, all west of the third meridian to the third meridian; thence easterly along the north boundary of sections seventeen, sixteen, fifteen, fourteen and thirteen in township thirty-nine, range twenty-eight and continuing easterly along the north boundary of sections eighteen, seventeen, sixteen, fifteen, fourteen and thirteen in township thirty-nine, ranges twenty-seven, twenty-six, twenty-five, twenty-four, twenty-three, twenty-two and twenty-one, all west of the second meridian to the dividing line between ranges twenty and twenty-one, west of the second meridian; thence southerly along the said dividing line between ranges twenty and twenty-one to the point of commencement.

#### INDIAN HEAD-MILESTONE

The constituency of Indian Head-Milestone is bounded as follows: Commencing at the intersection of the dividing line between ranges eleven and twelve, west of the second meridian and the north boundary of section twelve, township eleven, range twelve, west of the second meridian; thence westerly along the north boundary of sections twelve, eleven, ten, nine, eight and seven in township eleven, ranges twelve, thirteen, fourteen, fifteen, sixteen, seventeen, eighteen, nineteen, twenty, twenty-one, twenty-two, twenty-three and twenty-four, west of the second meridian to the dividing line between ranges twenty-four and twenty-five, west of the second meridian; thence northerly along the

The constituency of Swift Current is bounded as follow: Commencing at the intersection of the dividing line between ranges twelve and thirteen, west of the third meridian and the north boundary of township fourteen; thence westerly along the north boundary of township fourteen to the dividing line between ranges fifteen and sixteen, west of the third meridian; thence northerly along the said dividing line between ranges fifteen and sixteen to the north boundary of township fifteen; thence westerly along the north boundary of township fifteen to the dividing line between ranges seventeen and eighteen, west of the third meridian; thence northerly along the said dividing line between ranges seventeen and eighteen to the north limit of the full supply level of the reservoir known as Lake Diefenbaker; thence southeasterly and easterly along the north limit of the full supply level of the reservoir known as Lake Diefenbaker to the left bank of Swift

Current Creek; thence southerly along the left bank of Swift Current Creek to the east boundary of section twenty-five, township seventeen, range thirteen, west of the third meridian (being the dividing line between ranges twelve and thirteen, west of the third meridian); thence southerly along the said dividing line between ranges twelve and thirteen to the point of commencement.

### **THE BATTLEFORDS**

The constituency of The Battlefords consists of all those portions contained within the corporate limits of the City of North Battleford and within the corporate limits of the Town of Battleford.

### **THUNDER CREEK**

The constituency of Thunder Creek is bounded as follows: Commencing at the intersection of the dividing line between ranges twenty-seven and twenty-eight, west of the second meridian and the north boundary of township fourteen; thence westerly along the north boundary of township fourteen to the dividing line between ranges twelve and thirteen, west of the third meridian; thence northerly along the said dividing line between ranges twelve and thirteen to the left bank of Swift Current Creek in section twenty-five, township seventeen, range thirteen, west of the third meridian; thence northerly along the left bank of Swift Current Creek to the north limit of the full supply level of the reservoir known as Lake Diefenbaker; thence northeasterly and westerly along the north, west and south limits of the full supply level of the reservoir known as Lake Diefenbaker to the dividing line between ranges five and six, west of the third meridian; thence northerly along the said dividing line between ranges five and six to the north boundary of section eighteen, township twenty-five, range five, west of the third meridian; thence easterly along the north boundary of sections eighteen, seventeen, sixteen, fifteen, fourteen and thirteen in township twenty-five, ranges five, four, three, two and one, west of the third meridian to the third meridian; thence easterly along the north boundary of sections sixteen, fifteen, fourteen and thirteen in township twenty-five, range twenty-nine and continuing easterly along the north boundary of sections eighteen, seventeen, sixteen, fifteen, fourteen and thirteen, in township twenty-five, ranges twenty-eight, twenty-seven, twenty-six and twenty-five and continuing easterly along the north boundary of sections eighteen, seventeen, sixteen, fifteen and fourteen in township twenty-five, range twenty-four, all west of the second meridian to the east bank of Last Mountain Lake; thence southeasterly along the east and north banks of Last Mountain Lake and continuing southeasterly along the left bank of Last Mountain Creek to the east boundary of section twenty-eight, township twenty, range twenty-one, west of the second meridian; thence southerly along the east boundary of sections twenty-eight, twenty-one, sixteen, nine and four in township twenty and continuing southerly along the east boundary of sections thirty-three, twenty-eight, twenty-one, sixteen, nine and four in township nineteen, range twenty-one, west of the second meridian to the most northerly intersection of the left bank of Wascana Creek; thence

westerly along the left bank of Wascana Creek to its confluence with Cottonwood Creek; thence southerly along the left bank of Cottonwood Creek to the north boundary of township sixteen; thence easterly along the north boundary of township sixteen to the dividing line between ranges twenty-one and twenty-two, west of the second meridian; thence southerly along the said dividing line between ranges twenty-one and twenty-two to the north boundary of township fifteen; thence westerly along the north boundary of township fifteen to the dividing line between ranges twenty-four and twenty-five, west of the second meridian; thence northerly along the said dividing line between ranges twenty-four and twenty-five to the north boundary of township sixteen; thence westerly along the north boundary of township sixteen to the dividing line between ranges twenty-seven and twenty-eight, west of the second meridian; thence southerly along the said dividing line between ranges twenty-seven and twenty-eight to the point of commencement; excluding the constituency of Moose Jaw North.

#### **WEYBURN-BIG MUDDY**

The constituency of Weyburn-Big Muddy is bounded as follows: Commencing at the dividing line between ranges eighteen and nineteen, west of the second meridian and the south boundary of the province; thence westerly along the south boundary of the province to the dividing line between ranges twenty-seven and twenty-eight, west of the second meridian; thence northerly along the said dividing line between ranges twenty-seven and twenty-eight to the north boundary of section seven, township eleven, range twenty-seven, west of the second meridian; thence easterly along the north boundary of sections seven, eight, nine, ten, eleven and twelve in township eleven, ranges twenty-seven, twenty-six, twenty-five, twenty-four, twenty-three, twenty-two, twenty-one, twenty, nineteen, eighteen, seventeen, sixteen, fifteen, fourteen, thirteen and twelve, all west of the second meridian to the dividing line between ranges eleven and twelve, west of the second meridian; thence southerly along the said dividing line between ranges eleven and twelve to the north boundary of township six; thence westerly along the north boundary of township six to the dividing line between ranges eighteen and nineteen, west of the second meridian; thence southerly along the said dividing line between ranges eighteen and nineteen to the point of commencement.

#### **WOOD RIVER**

The constituency of Wood River is bounded as follows: Commencing at the intersection of the dividing line between ranges twenty-seven and twenty-eight, west of the second meridian and the south boundary of the province; thence westerly along the south boundary of the province to the east boundary of section four, township one, range eighteen, west of the third meridian; thence northerly along the east boundary of sections four, nine, sixteen, twenty-one, twenty-eight and thirty-three in townships one, two, three, four, five, six, seven, eight, nine, ten and eleven, all in range eighteen, west of the third meridian to the north boundary of township eleven; thence easterly along the north boundary of township eleven to the dividing line between ranges fifteen and sixteen, west of the third meridian; thence northerly along the said dividing line between ranges fifteen and sixteen to the north boundary of township fourteen; thence easterly along the north boundary of township fourteen to the dividing line between

ranges twenty-seven and twenty-eight, west of the second meridian; thence southerly along the said dividing line between ranges twenty-seven and twenty-eight to the point of commencement.

### YORKTON

The constituency of Yorkton is bounded as follows: Commencing at the intersection of the dividing line between ranges two and three, west of the second meridian and the north boundary of township twenty-four; thence westerly along the north boundary of township twenty-four to the dividing line between ranges six and seven, west of the second meridian; thence northerly along the said dividing line between ranges six and seven to the north boundary of township twenty-six, thence easterly along the north boundary of township twenty-six to the dividing line between ranges two and three, west of the second meridian; thence southerly along the said dividing line between ranges two and three to the point of commencement.
