## CHAPTER Q-1.1

### An Act to enact *The Queen's Bench Act, 1998*, *The Administration of Estates Act, The Interpretation Amendment Act, 1998* and *The Queen's Bench Consequential Amendment Act, 1998*

#### Short title

1 This Act may be cited as *The Queen's Bench Revision Act*.

#### *Queen's Bench Act*

2(1) *The Queen's Bench Act* is repealed.

(2) *The Queen's Bench Act, 1998* as set out in Schedule A is enacted.

#### Transitional

3(1) Certificates of *lis pendens* granted pursuant to *The Queen's Bench Act* that have not been vacated before the coming into force of *The Queen's Bench Act, 1998* are deemed to be certificates of pending litigation granted pursuant to *The Queen's Bench Act, 1998*.

(2) Notwithstanding the repeal of *The Queen's Bench Act*, any applications to vacate a certificate of *lis pendens* and any appeal of an order vacating a certificate of *lis pendens* that is commenced but not completed prior to the coming into force of *The Queen's Bench Act, 1998* is continued pursuant to *The Queen's Bench Act, 1998*.

#### *Administration of Estates Act*

4 *The Administration of Estates Act* as set out in Schedule B is enacted.

#### *Interpretation Amendment Act*

5 *The Interpretation Amendment Act, 1998* as set out in Schedule C is enacted.

#### *Queen's Bench Consequential Amendment Act*
