Foreword



Saskatchewan has faced a turbulent world economy in recent years. We have been buffeted by high interest and exchange rates, faced depressed commodity prices, and endured the drought and protectionist actions facing our farmers. Notwithstanding these circumstances, the Saskatchewan economy showed signs of recovery and growth in 1989.

The world is experiencing rapid and extensive changes which will require a fundamental re-examination of the economic opportunities and choices facing all of us. New trading arrangements, which we thought impossible just a few years ago, are emerging. Western Europe is gearing up towards 1992, the East Bloc is seeking radical changes in their economic and political structures and the Pacific Rim is now a major trading area with exceptional economic growth. Closer to home, the Free Trade Agreement is now in place and the federal government is introducing major new long-term measures including tax changes. The Saskatchewan economy must be positioned to meet these challenges.

Our people have responded to many challenges and continue to build and invest in our economy. This resilience has been enhanced by an economic development strategy that has emphasized our greatest resource — the people of Saskatchewan. Enabling individuals to participate in their local and provincial economy is the foundation of the new direction of economic diversification in Saskatchewan. The success of the SaskTel and Potash bonds is ample evidence that individuals are seeking and claiming means of participating in and developing the economy.

This partnership has seen the construction of the NewGrade Energy/Co-op Heavy Oil Upgrader, the expansion of Saskoil into a national oil and gas company and the successful expansion of the Meadow Lake sawmill. The Husky heavy oil upgrader, the Shand coal-fired power station, the proposed nitrogen fertilizer plant at Belle Plaine and our irrigation development will provide significant benefits to the people of Saskatchewan. These are already evident in the emergence of manufacturing and processing in many areas of the province.


Our communities are benefiting from a significant expansion in small business activity as increasing numbers of people exploit the opportunities created by the changes in our economy. Rural service centres, Rural Development Corporations and the revitalized Agricultural Development and Diversification Boards, will focus these activities on community development. Buy Saskatchewan has provided the lead to local manufacturers to capitalize on major opportunities and to penetrate new markets in Canada.

As we look beyond the accomplishments and challenges of this decade, we can see that a new vitality is taking shape — a desire and a capacity to compete in new markets and to take an active role in building our economy. To maintain our economy's competitiveness and enrich the well-being of our people, we must continue to seek new opportunities. I am confident that in partnership with our people, we will continue to build a vibrant and resilient economy that will allow for increased prosperity and opportunity in the decades to come.


World Economic Developments

Saskatchewan, which is heavily dependent upon domestic and international trade, is significantly influenced by world and domestic events. Economic prospects for the province can be altered by exchange and interest rate movements, developments in world commodity prices, and changing trade flows.

After two years of very rapid growth in the major industrialized countries in 1987 and 1988, there are now signs that the economic expansion is slowing. Building inflationary pressures have led to policies which will diminish the risk of inflation, but at the price of slowing output growth.

In 1988 non-fuel commodity prices rose substantially reflecting both cyclical and supply-related factors. In 1989 commodity prices for most Saskatchewan exports softened from the previous year's level. With the low levels of inventories the outlook for prices of food is uncertain, as even small changes in supply and demand expectations could trigger significant price movements.

The strong growth of economic activity in the major industrialized countries and the Asian developing countries has been accompanied by a rapid expansion of world trade. The process of narrowing trade imbalances among the largest industrial countries now appears to have slowed, raising the prospect of continued exchange rate volatility.




In Canada monetary policy remains highly restrictive reflecting the Bank of Canada's continued concerns over inflationary pressures in central Canada. Over the January to November period the bank rate rose from 11.54% to 12.49%. This monetary stance continued to support an appreciating Canadian dollar, dramatically affecting the competitiveness of Canadian exporters. The Canada-United States exchange rate established a ten-year high with the Canadian dollar moving above 86 cents U.S.

The Saskatchewan Economy in 1989

Provincial economic growth rebounded in 1989 in response to generally improved agricultural production, large increases in natural gas production, and improvements in the manufacturing sector. Pockets of weakness, however, remain. Construction activity declined this year because of the completion of manufacturing facilities and weak housing demand. Consumer price inflation accelerated through the latter half of the year, but this was largely due to federal tax increases.

Total employment for the January to November period averaged 447,000 persons, down 5,000 from the equivalent period last year. Strong employment growth was registered in the mining and forestry, finance, insurance and real estate business and community services and public administration sectors. While agricultural employment declined modestly over this period, since July it has been strengthening relative to the previous year. Employment in the construction and manufacturing sectors were, in aggregate, down an average of 3,000 persons, compared to the first eleven months of 1988. This reflected a reduction in spin-off and construction activity following the completion of such major projects as the NewGrade Energy/Co-op Upgrader and the Weyerhaeuser paper mill.

The total number of unemployed persons increased by 1,000 from last year to average 36,000 persons over the



January to November period. The average unemployment rate for year-to-date 1989 was 7.4%, down 0.2% from the same period in 1988. Saskatchewan consistently maintained the third lowest unemployment rate in Canada during 1989.

The provincial population was 1,003,600 as of October 1, 1989, down 5,300 from the previous year. Interprovincial and international migration statistics indicate that 10,968 more people left the province in the first three quarters of 1989 than entered, up from a net out-migration of 10,902 people in 1988.

Agriculture


The 1989 crop year brought with it mixed success. Drought conditions continued to plague regions across the province and a wet harvest reduced the crop quality. However, production was substantially better than the drought ravaged 1988 crop.

Production of the major grains, oilseeds and specialty crops in 1989 is estimated at 18.7 million tonnes, up 58.8% from the scant 11.7 million tonne harvest in 1988, but still 3% below the ten-year average. Relative to 1988, production was up for all crops except canola and field peas.

Spring wheat production improved dramatically with 9.3 million tonnes harvested, up 71.5% from 1988. Durum production more than doubled over last year due to the record seeded acres. Oats, barley and rye production also showed strong improvements. A reduction in seeded acres and extreme heat at the flowering stage led to a 24% decline in canola production. Increased acreage led to specialty crops production being above the ten-year average.

World crop inventories declined significantly in 1988 and although 1989 stocks continued to decrease, consumption demand remained stagnant. As a result prices were below the 1988/1989 crop year averages.

Statistics Canada's semi-annual livestock survey estimates that there were 2.13 million cattle and calves on Saskatchewan farms on July 1, 1989 down slightly from the previous year. Hog numbers decreased from the 1988 cyclical peak but were well above the average over the 1980s. Cattle prices remained strong in 1989 and hog prices remained weak. The United States Department of Commerce imposed a countervailing duty on Canadian pork exports in 1989. The duty of 3.6 cents per pound was in addition to the duty on live hogs implemented in 1985.



Total farm cash receipts for 1989 are forecast at \$4.64 billion, 27% of which will come from safety net and other emergency assistance programs. Canada and Saskatchewan shared the cost of a \$450 million payment in 1989 for the 1988 crop shortfall due to drought. After staying relatively constant over the past five years, production expenses increased in 1989 and will result in a decrease in realized net farm income. The long-term structural problems facing agriculture persist.

The Saskatchewan Crop Insurance Program was enhanced for 1989 to allow greater program flexibility, including the Livestock Feed Insurance Program.

The high national interest rate policy is apparent in the increasing financial difficulties faced by farmers with debt. In order to deal with farm financing needs, the Government of Saskatchewan implemented new initiatives in 1989. These included home quarter financing, a guaranteed vendor mortgage program and refinancing for qualifying farmers who reach settlements with their former lenders through a formal debt review process.

The Government of Saskatchewan remains committed to the protection of Saskatchewan farmers faced with subsidy wars, natural disasters and high interest rates. The commitment to longer term development was strengthened by initiatives such as the Canada-Saskatchewan Soil Conservation Program, the extension of the government's focus upon diversification in agriculture and food and implementation of the federal-provincial Farm Management Initiatives Agreement.

Natural Resources

World oil markets firmed considerably in 1989 reflecting continued demand growth and accident-related supply disruptions in Alaska and the North Sea. This resulted in almost a 27% increase in average Saskatchewan oil prices, rising from \$13.37 to \$16.94 per barrel. In spite of stronger prices, the total number of wells drilled across the country declined as federal drilling incentives were decreased and producers expected future oil price declines. Drilling of completed oil wells in Saskatchewan is forecast to be 450 wells versus 1298 for 1988. For the most part, activity shifted from finding and developing heavy oil reserves, to expending effort on those reserves that appear to have promise of higher producibility than the Saskatchewan norm. Energy companies, however, continued to probe heavy oil areas such as Hoosier, Marsden and Smiley. Construction of the Bi-Provincial heavy oil upgrader in Lloyminster began in mid-1989 and is forecast for completion by the end of 1992.

The policy adopted in 1987 of allowing the removal of natural gas from the province along with pipeline expansion undertaken by provincially owned Transgas

Limited in 1988, continued to encourage drilling activity for natural gas. Investment in 1989 is estimated at \$194 million, reflecting a 32% increase in drilling activity over 1988 levels to 980 completed gas wells drilled. Finding and developing gas has resulted in dramatic growth in activity in areas such as Crane Lake, Hatton and Bigstick. Gas sales are forecast at a 32% increase over 1988 levels, with most new production earmarked for out-of-province sales.

The five year suspension agreement signed by the Canadian potash industry and the U.S. Department of Commerce back in January of 1988 has laid the foundation for sustained price recovery. The recovery from the severe drought in North America was expected to translate into significant increases in fertilizer consumption. However, a poor spring planting season in the United States coupled with a reduction in sales to China led to unanticipated reduction in potash sales to the end of October by 13% relative to 1988. Year-to-date potash production was 5.4 million tonnes, down 12% from the same time period in 1988. Potash prices stayed relatively constant in 1989.

The potash mine owned by the Potash Company of America returned to production in 1989 as a solution mine. The mine closed in February 1987 when a brine inflow flooded the mine and forced the layoff of over 300 workers.

During the year the first steps towards increasing public participation in the Potash Corporation of Saskatchewan were put into place. The offering of ownership bonds to Saskatchewan residents as well as a block of shares on Canadian and international stock markets to all investors, transformed it into the largest privately owned potash company in the world.

Uranium production over the first three quarters of 1989 was 7.3 million kg U₃O₈, up from the 6.8 million kg produced over the same period last year. However, production over the year is expected to be down about 10% with the shut down of the Cluff Lake and Collins Bay mines since mid-year. Sales are also down about 15% over the first three quarters of the year, as Saskatchewan producers have effectively withdrawn from the depressed spot market to concentrate on meeting their long-term contracts.

Coal production in Saskatchewan declined 4.7 million tonnes from record levels of 12.1 million tonnes in 1988. This 39% decline reflects an increase in 1989 water levels for hydro-electric power generation, reducing coal demand for thermal electricity generation in Saskatchewan and export markets.

Canadian wood producers have diversified their export trade in the past few years, but exports remain critically dependent on the U.S. market. Housing starts are expected to decline by around 7% in the U.S. Canadian exports of newsprint to our southern neighbour have been declining on a year-over-year basis since February of this year, partly due to the strength of the Canadian dollar. The proposed pulp mill at Meadow Lake will strengthen the industry by adding capacity directed towards a diversified export market.

Gold exploration expenditures in Saskatchewan for 1989 are forecast to be about \$30 million as compared to \$55 million in 1988. This decline is consistent with, but not as severe, as the national trend. The Star Lake orebody was depleted in April, but production from the nearby Jolu Mine, which commenced in late 1988, has consistently exceeded capacity. Several other properties in the La Ronge belt are in advanced exploration or feasibility stages and more producers are anticipated in the next few years.

The Saskatchewan diamond play is just over a year old, and already nine bodies of kimberlite, some with micro-diamonds, have been reported by the industry. Staking for diamonds now covers more than one million acres, mostly in a belt north of Prince Albert and extending about 100 km east to Chocicland.

Construction

The lagged effect of last year's drought and high interest rates slowed building activity in 1989. The total value of building permits issued in Saskatchewan during the first six months of 1989 declined by 20.8%. The value of industrial permits increased over fivefold, largely on expansion and modernization activity in Saskatoon.

To the third quarter of 1989, Saskatchewan recorded combined urban and rural housing starts of 1,564 units. This represents a 50% decline over that recorded for the same period last year. In spite of this reduced construction activity, the Saskatchewan housing market remains affordable. The average house price is just over \$71,000 and the Mortgage Protection Plan has sheltered homeowners from high interest rates. Commercial building permits for the first six months were valued at \$44.4 million, representing a 30.3% decline from 1988.

Manufacturing and Technology

1989 marked the first year under the historic Canada-United States Free Trade Agreement. Although the Agreement brings significant benefits to Saskatchewan, increases in both interest and exchange rates made it difficult for businesses to take full advantage of this opportunity.

Still, the value of Saskatchewan's manufacturing shipments increased in the first eight months of the year by 8.4%, compared to the same period last year. Shipments increased by 5.5% in the food and beverage sector, 5.2% in the wood products sector and 6.4% in the electrical and electronics products sector. Shipments from the chemicals and chemical products industry rose by 25.2% as new capacity in the sector came on stream. Declines were recorded in the metal fabrication and non-metallic minerals.

The Shand power facility is set to open in 1992. This mega-project was broken down into more than 300 contracts to provide more opportunity for Saskatchewan suppliers and contractors to participate. These opportunities included the establishment of a new facility employing 35 people in Melville to manufacture pressure parts. Other projects under construction or in the planning stage include modernization and expansion in meat processing facilities, plant expansion of farm implement manufacturers and a proposed \$350 million nitrogen fertilizer manufacturing plant at Belle Plaine.

The advanced technology industry is beginning to emerge from a period of consolidation and is now entering a period of market expansion as many of Saskatchewan's firms have established an international reputation for quality and excellence. This restructuring is anticipated to translate into increased sales and employment in 1990 from their current levels of \$500 million and 3000 persons, respectively.

The agriculture biotechnology, computer software, electronics/instrumentation and aerospace sectors experienced the greatest degree of activity in 1989. The biotechnology industry continues to promise the development of new products and technologies which bring increased safety and efficiencies in pest control management and nutrient systems. Ag-West Biotech Inc. has supported the growth of this sector by assisting in commercial research and development and in attracting new investment.

The software sector continues to receive world attention for its innovative approaches. Co-operators Data System Ltd. developed the world's first point of sale health card and the application of computer software developed by the Saskatchewan company Generation 5 assisted in the clean-up of the Valdez oil spill off the Alaskan coast. The electronics/instrumentation sector also made notable advances. Sci-Tech Instruments experienced increased demand for its atmospheric ozone measuring instrument and its petro-tag instrument for measuring the fuel levels in underground storage tanks.

The aerospace sector is entering a new phase of growth with Canada's nearly \$1 billion commitment to space technologies. As well, the recent commitment by the Canadian and Saskatchewan governments to build the \$441 million remote sensing satellite, RADARSAT is expected to generate approximately \$20 million in contracts and over \$11 million in additional spin-offs in Saskatchewan over the next six years.

Prices and Incomes

Consumer price inflation remained moderate over the year. The overall index of consumer prices in Regina rose an average of 4.4% in the first 10 months of 1989, compared with a 4.3% annual rise in 1988. Saskatoon prices rose 3.9%, slower than the 4.5% increase in 1988. Federal indirect tax increases put upward pressure on consumer prices though the latter half of the year. The slow rise in consumer prices was comforting news to workers whose value of average weekly wages and salaries rose a modest 1.4% for the first eight months of 1989.

Prospects for the 1990s

Saskatchewan will face a number of challenges in the decade to come. To meet these challenges the future of Saskatchewan's economy lies in a diversification and development strategy that empowers individuals to build upon the opportunities and take an active role in our economy. The Canada-U.S. Free Trade Agreement is already improving access to the U.S. market and the Uruguay round of GATT negotiations should further lower multilateral trade barriers. This will be advantageous to our manufacturers, farmers and other exporters, encouraging greater export market penetration.

The challenge of diversification has been taken up in many parts of our economy. Mega-projects such as the Shand coal-fire-power plant, the Bi-Provincial heavy oil upgrader and the nitrogen fertilizer plant at Belle Plaine will provide lasting benefits not only through increased employment at these plants but also in the spin-offs they will generate.


New firms in industries such as manufacturing, biotechnology, and food processing have, and are, being established across the province. Rural service centres have been established to promote and encourage agricultural and economic development and diversification in rural communities. Through co-operation and initiative the essential layers to strengthen communities and build a stronger and more vibrant economy will continue to be put in place. New opportunities are on the horizon.

























































Table 57: Provincial Highways by Surface Type, Saskatchewan¹





Table 60: Number of Locations and Total Receipts for Major Accommodation Groups, Saskatchewan








Table 59: Gross Fixed Capital Formation, by Industry, on a GDP Basis, Saskatchewan







Saskatchewan Economic Accounts

The Saskatchewan Bureau of Statistics has developed a set of economic accounts which can be used to trace the development and growth of the Saskatchewan economy.

The purpose of the accounts is to measure the value of economic activity in each sector of the economy. This is done by means of a balancing set of accounts similar to the annual income and expenditure statements of a commercial enterprise.

The Accounts have many useful functions. They consolidate information which is now provided through a number of scattered sources and organize it into a central framework. This allows many kinds of economic analysis to be performed ranging from monitoring current economic performance to analysis of structural change in the economy.

The Saskatchewan Bureau of Statistics has available upon request, many more detailed tables and other information concerning the Saskatchewan Economic Accounts.

Saskatchewan Economic Accounts

Saskatchewan Gross Domestic Product (GDP) measures the total value of goods and services produced in the province. By removing the effects of inflation (or deflation) it is possible to measure the volume of output.

In 1988 the Saskatchewan economy grew by 9.6%. After adjusting for price changes, Saskatchewan's real Gross Domestic Product fell by 4.5%. Domestic Demand for goods and services by individuals, the government and for investment purposes rose 1.9% in 1988 after adjustment for inflation.

This document presents an update to the economic accounts since the release of the government's annual Economic and Financial Position of November 1989. Periodic revisions are common to all series to improve the accuracy, reliability and consistency of the data. There were two major historical data revisions conducted in the latter part of 1989: adjustments to investment income of individuals and governments, and a revision to farm income. Improved data on deposits, bond holdings, and trading profits of government businesses resulted in revisions back to 1985 for a number of interest and investment income series.

This year Statistics Canada and other statistical agencies conducted an intercensal revision to a number of agricultural series over the 1971-1987 period. Net farm income and its component series were revised to conform

to conceptual changes and to the 1986 Census of Agriculture.

The net farm income series is intended to measure the net business income generated from agricultural production. Changes to the treatment of advance payments and business insurance were made to more closely align the measurement of net farm income with its conceptual framework. Advances are now considered to be a type of loan to the producer. Accordingly, they have been removed from cash receipts and added to the farm debt outstanding. There was no impact on total net income as inventories were adjusted to offset the amounts advanced. Business insurance, formerly estimated as the difference between premiums and claims now reflects only premiums.

The 1986 Census indicated that a major revision was necessary to a number of farm expenditure series. These changes can have a significant effect on net farm income because it is derived by subtracting expenses from receipts. A 1.0% change to total expenses will affect realized and total net income by about 4.0%.

The farm income estimates for the 1971 to 1987 period have been adjusted downwards. The magnitude of these changes diminishes over time to zero in 1971. It is also considerably smaller in 1986 and 1987 as changes for this period have previously been incorporated.
