# Statement from the Minister

I am pleased to present the Ministry of Advanced Education Plan for 2016-17.

This plan details how our Ministry will support the Government's direction.

The 2016-17 Budget will keep Saskatchewan strong. We need to keep building the province. We also need to responsibly manage the peoples' money.

Though challenges exist, our priority continues to be investing in people and infrastructure.

Government Direction and Budget for 2016-17 invests in people and infrastructure to *Keep Saskatchewan Strong*, and initiates a government wide exercise of transformational change to ensure the sustainability of high quality public services delivered in the most effective and efficient way possible.

Post-secondary education develops our province's most precious resource - our people. Education supports economic growth. It helps employers find the workers they need to prosper. A strong post-secondary system is vital. It ensures Saskatchewan remains the best place in Canada to live and get an education.

The Ministry of Advanced Education will keep our post-secondary system strong. We will provide operating dollars to our post-secondary institutions. We will support students from cradle to career. The Ministry will assist parents saving for their children's education. We will provide students with loans, grants, and scholarships.

We will continue to offer a generous program of tax credits to keep our graduates.

I have five expectations for everyone involved in post-secondary education. Saskatchewan's post-secondary system must be accessible, responsive, sustainable, accountable and high quality. I will hold myself and everyone else to these expectations.

I will ensure the Ministry of Advanced Education meets these commitments. I will manage taxpayers' resources with integrity.

The Ministry will report on progress made toward this plan in the 2016-17 Annual Report.

  - 🔖 Encourage the development of options to give credit for both high school and post-secondary education
  - 🔖 Support further work on enhancing credit transfer with Saskatchewan's post-secondary institutions
  - Uncrease global engagement through Saskatchewan students studying abroad
- $\Rightarrow$  Develop and encourage services to meet the diverse needs of students
  - 🖔 Encourage institutions to increase the participation and success of First Nations and Métis students

This measure changes slowly over time. The 2016-17 target is to maintain the current level. Over time the target is to match the attainment level of the overall Saskatchewan population.

Number of Saskatchewan students studying abroad

By 2020, increase the number of Saskatchewan students studying abroad by 50 per cent over the 2011 baseline.

- ⇒ Provide operational and capital funding for post-secondary institutions:
  - Provide capital funding including support for major capital projects as well as repairs and maintenance (i.e. Preventative Maintenance and Renewal)
  - ☼ Develop and implement a sector-wide capital plan
  - ♥ Work with institutions to develop a consistent definition of deferred maintenance and current replacement value
  - ∜ Work with the public post-secondary institutions to inventory the deferred maintenance backlog

#### **Key Actions**

- ⇒ Encourage post-secondary sector collaboration
- ⇒ Encourage efficiencies within the sector including collaborative teaching and sharing library resources

- $\Rightarrow$  Continue continuous improvement and innovation initiatives, including Lean
- ⇒ Conduct and implement the recommendations from core program reviews and evaluations

# Highlights

#### 2016-17 Budget Highlights:

- ⇒ Strong support for Saskatchewan's post-secondary institutions with a consistent funding level of \$686 million including:
  - 🔖 \$475 million to operate the Universities of Saskatchewan and Regina and their affiliated and federated colleges.
  - \$ \$156 million to operate Saskatchewan Polytechnic, Saskatchewan Indian Institute of Technologies and Gabriel Dumont Institute.
  - 🔖 \$29 million to operate Saskatchewan's regional colleges.
- ⇒ \$25.8 million for infrastructure, that includes:
  - \$ \$23.6 million for Preventative Maintenance and Renewal (i.e. repairs and maintenance).
  - 🔖 \$2.2 million to complete the Southeast Regional College campus in Weyburn.
- ⇒ Key financial supports for students are continued, with over \$53 million in direct support to students, including:
  - \$\$ \$32.5 million for the Student Aid Fund to provide student grants, bursaries and loans.
  - \$ \$14.3 million for scholarships, including the Saskatchewan Advantage Scholarship.
  - 🔖 \$6.5 million for the Saskatchewan Advantage Grant for Education Savings.
- ⇒ Over the past nine years, the Province has invested more than \$7.3 billion in post-secondary institutions and student supports.
- ⇒ In recognition of the fiscal challenges facing the Province, overall spending at the Ministry of Advanced Education will decline by \$22.3 million, or 2.9 per cent. The majority of this decline stems from fewer capital ventures in 2016-17. This is not unusual. The Ministry completed the Trades and Technology Centre at Parkland College in the previous fiscal year and an expansion at Southeast Regional College has \$2.2 million remaining this year. The Ministry also deferred capital spending at the University of Saskatchewan Health Sciences Building. Capital spending can vary significantly from year to year depending on the size and nature of the projects.


