Section 4: Application Requirements

1. **Photograph:** a recent photograph of the person to be licensed.

- (a) Photograph must have been taken within 90 days before the application and must be in colour.
- (b) Photograph must show a full front view of head and shoulders taken against a plain background.
- (c) If submitted online, it has to be in JPEG Format. Email: pisg@gov.sk.ca
- (d) Do not pin, staple or glue photograph to the application.

Applicants are not required to send a new photograph if they apply for the 30-Day Extension.

Please note that Applicants are required to submit an updated photograph every time they apply for a licence or renewal.

2. **Two pieces of identification:** two pieces of government issued identification are required when submitting all applications. If the Applicant is not a Canadian citizen and born out of the country – a visa, passport, or an immigration, work or study permit must be included as one of the pieces of identification.

3. **Criminal Record Check including Vulnerable Sector Check:** if this is an application for a new licence, a copy of a criminal record check dated not more than 30 days before the date the application is submitted. Applicants are not required to send a new criminal record check if they apply for the 30-Day Extension.

4. **Payment of Application Fee:** The fee for this application is dependent on the licence type. Please include with this Application a cheque in the amount identified in Section 1 of this Form, payable to the **“Minister of Finance”**.

Payment of application: Money Orders, Cheques, Visa & Mastercard are accepted.

Do not staple or glue the cheque to this Form.
