MINISTER'S ORDERS

The Education Act

M.O. 177/91. Pursuant to the powers vested in me by subsection 27(1) and section 364 of *The Education Act*, I hereby amend Minister's Order 169/91, dated October 11, 1991, which amended Minister's Order No. 87/91, dated July 8, 1991, and described the lands in each sub-division in the Wood River School Division No. 70, in the following manner.

The description under Sub-division No. 4, in Township 9, in Range 6, should read as follows:

"Sections 1 to 5 inclusive, the south half and north-east quarter of Section 6, the east half of Section 7, Sections 8 to 17 inclusive, the east halves of Sections 18 and 19, Sections 20 to 29 inclusive, the east halves of Sections 30 and 31, Sections 32 to 36 inclusive;"

The Oil and Gas Conservation Act

SENLAC WASECA SAND POOL

MRO 380/91 PO 51. Pursuant to section 17 of *The Oil and Gas Conservation Act*, MRO 15/91 PO 1, published in *The Saskatchewan Gazette* on February 15, 1991, is rescinded and the pool pro-

visions set forth in the following schedule shall apply to the drilling of and production from vertical oil wells in the Senlac Waseca Sand Poll effective on December 1, 1991.

Dated at Regina, Sask., November 29, 1991.

Schedule

Pool provisions applicable to the drilling of and production from vertical oil wells in the Senlac Waseca Sand Pool.

Interpretation

1 These provisions shall be construed with reference to the terms and expressions contained in *The Oil and Gas Conservation Act* and the regulations made pursuant to the Act, as amended from time to time.

Drainage Unit

2 The drainage unit shall be one legal sub-division.

Target Area

3 The location of an oil well within a drainage unit shall be within the target area prescribed in section 4 or such other location within the drainage unit as may be approved by the minister.

4 The south-east corner of the rectangular target area shall be the south-east corner of the drainage unit. The north and west sides of the target area shall be parallel to the corresponding sides of the drainage unit. The north side of the target area shall be 200 m from the south side of the drainage unit and the west side of the target area shall be 200 m from the east side of the drainage unit.

Maximum Allowable Rate of Production
— Oil Wells

5 The maximum allowable rate of production (MARP) for a drainage unit shall be based on an area of one legal subdivision provided that if a well is not completed within the target area as prescribed by section 4, the minister may prescribe the area to be used as a factor in determining the MARP and may vary the prescribed area.

Samples

6 Samples of drill cuttings from formations below the top of the Devonian Shield shall be taken and delivered to the department.

Deviation Tests or Surveys

7 Deviation tests or surveys are required in respect of any wells drilled in the following circumstances:

- (a) where the well is to be drilled to a depth greater than the top of the Devonian Carbonate; or
- (b) where the department requires proof that the well has been completed within its target area.

Logs

8 As a minimum requirement, the operator shall run a resistivity log and either a sonic log or an approved radioactivity log from total depth to surface casing shoe for each well drilled.

Lubricators

9 Lubricators shall be used during every perforating and swabbing operation.

Special Provisions

10 These pool provisions shall be subject to such special provisions as may be established by order of the minister.

OTHER AREAS — SALT WATER DISPOSAL

MRO 381/91. Minister's Order MRO 296/91 dated September 26, 1991 is rescinded and replaced by the following Order.

Pursuant to section 17.1 of *The Oil and Gas Conservation Act*, the application submitted by Trans-Gas Limited for disposing of salt water recovered from solution mining of natural gas salt cavern storage facilities by injection into the Interlake, Stonewall, Stony Mountain and Red River formations through two wells located in legal subdivisions 1 and 9 of Section 32, in Township 14, in Range 30, West of the First Meridian, is approved all in accordance with plans and specifications filed with the Department as S.W.D. 344 and subject to the following conditions:

1 Installations shall be subject to the approval of a field representative of the Department prior to the commencement of salt water injection and subsequent to any modifications to such installations.

2 The wellhead injection pressure shall be limited to a maximum of 13 000 kilopascals.

3 All injection volumes shall be metered with a Department approved method.

This approval does not authorize the applicant to dispose of salt water without the consent of all

the mineral owners, other than the Crown, that might reasonably be adversely affected by such disposal.

EXTRACTS FROM THE RULES AND PROCEDURES OF THE LEGISLATIVE ASSEMBLY OF SASKATCHEWAN RELATING TO PRIVATE BILLS

PETITIONS

11.—(1) A petition to the Assembly may be presented by a Member at any time during the sit-

ting of the Assembly by filing the same with the Clerk.

(6) Petitions may be either written or printed; provided always that when there are three or more petitioners, the signatures of at least three petitioners shall be subscribed on the sheet containing the prayer of the petition.

(9) No petition can be received which prays for any expenditure, grant or charge on the public revenue, whether payable out of the Consolidated Fund or out of moneys to be provided by the Assembly.

NOTE — *A form of Petition can be obtained on application to the Clerk of the Legislative Assembly.*

PRIVATE BILLS

56.—(1) All petitions for Private Bills shall be in duplicate and shall be filed with the Clerk of the Assembly not later than the twentieth sitting day of the Session.

(2) No petition for any Private Bill shall be received by the Assembly if presented after the first twenty-five sitting days of the Session.

(3) No Private Bill may be introduced in the Assembly after the first thirty sitting days of the Session.

57.—(1) Every applicant for a Private Bill shall deposit with the Clerk of the Assembly along with the Petition for same, two copies of the Bill, with marginal notes inserted, and an accepted cheque payable to the Minister of Finance for the sum of two hundred and fifty dollars, if the said Bill does not exceed ten pages, and fifteen dollars additional for each page over that number; four hundred and fifty words shall be held to constitute a page.

(2) In the case of a bill incorporating a company a receipt from the Registrar of Joint Stock Companies for any statutory fees required shall also be deposited with the Clerk.

58. No remittance of a deposit on account of a Private Bill or any portion thereof shall be ordered by the Assembly unless the same has been recommended by the Committee charged with its consideration, or unless the Bill has been withdrawn, rejected or not reported upon, in which case the actual expenses incurred shall be deducted from the deposit received before making such remittance.

(3) A copy of the notice with a statutory declaration of the several publications of advertisement shall be filed with the Clerk of the Assembly along with the petition and bill.

In cases where the proposed Bill provides that the property to be used or occupied by the petitioner be exempt from taxation, either in whole or in part, the petitioner must file with the Clerk of the Assembly, along with the petition, a written statement from the local municipal authority in which the said property is situated approving the intent of the provisions of the proposed Bill which provide for the exemption from taxation.

The name of the Member who is to present the Petition and Private Bill must be furnished to the Clerk of the Assembly at the time of filing the Petition. Such member should not, of course, be a member of the Cabinet.
