- **1**(1) Subject to section 4, every cattle producer shall:

  - (b) for every head of cattle raised or fed in Saskatchewan that the cattle producer delivers for sale outside Saskatchewan;

pay to the Commission a levy in the amount of \$4.50 per head of cattle made up of a \$2.00 refundable levy and a \$2.50 non-refundable levy.

- (2) If the levy is not deducted and remitted by a buyer pursuant to section 2 the cattle producer shall:
  - (a) pay the levy to the Commission; and
  - (b) account to the Commission for the levy, in the form prescribed by the Commission by the 25th day of the month next following the month in which the cattle were sold in Saskatchewan or delivered for sale outside of Saskatchewan.
- 2 Subject to section 4, when cattle are sold in Saskatchewan, the buyer:
  - (a) shall deduct the levy from the proceeds of the sale for each head of cattle sold;
  - (b) remit the levy to the Commission, in the form prescribed by the Commission, by the 25th day of the month next following the month in which the cattle were sold; and
  - (c) provide to the cattle producer a document that clearly shows:
    - (i) the number of head of cattle sold;
    - (ii) the amount of the levy that was deducted;
    - (iii) the name, address and phone number of the buyer; and
    - (iv) the date of the transaction in respect of which the deduction was made.
- **3** Subject to section 4, when cattle raised or fed in Saskatchewan are delivered to a livestock dealer or livestock agent for sale outside Saskatchewan, the livestock dealer or livestock agent shall:
  - (a) deduct the levy from the proceeds of the sale for each head of cattle sold outside of Saskatchewan;
  - (b) remit the levy to the Commission, in the form prescribed by the Commission, by the 25th day of the month next following the month in which the cattle were sold outside of Saskatchewan; and
  - (c) provide to the cattle producer a document that clearly shows:
    - (i) the number of head of cattle sold;
    - (ii) the amount of the levy that was deducted;
    - (iii) the name, address and phone number of the buyer; and
    - (iv) the date of the transaction in respect of which the deduction was made.

- 4 This Order does not apply to any sale of cattle for which a levy is to be paid pursuant to the federal levies order
- **5** Every buyer is entitled to receive an amount of five cents per head of cattle for which a levy is deducted and remitted in accordance with this Order.
  - 6 Order No. 05/12 Levy Collection is hereby wholly revoked.
- 7 This Order will remain in effect for a period no longer than ten years from the date this Order is approved by the Agri-Food Council.
