CERTIFICATE OF EXEMPTION – KAMBEITZ AGRI INC. (PORT LAJORD TERMINAL)

Pursuant to the authority vested in the minister by section 3.1 of *The Railway Act* (the Act), the minister hereby exempts Kambeitz Agri Inc. (Port Lajord Terminal) (the Company), except where otherwise stated, from the Act with respect to its industrial rail operations (herein the Rail Operations) that it operates on the property located near Lajord Saskatchewan subject to the following terms and conditions:

1 Term

3 Operating Authority Certificate (OAC)

The Company shall apply for and obtain an OAC from the Highway Traffic Board (the Board). The Company shall comply with the terms and conditions of the OAC issued by the Board. The Company shall file with the Board any insurance policies or bonds and certificates of insurances that may be required by the Board.

4 Safety, Inspection and Orders

Section 5, subsection 23(3), section 23.1, subsection 25(1), and sections 26, 28 and 34 of the Act shall continue to apply to the Rail Operations.

5 Accidents and Reports

Sections 31 and 32 of the Act shall continue to apply to the Rail Operations.

6 Offence and Penalty

Section 52 of the Act shall continue to apply to the Rail Operations with respect to a violation of any provision of the Act referred to in clauses 52(1)(c) and (d) thereof.

SASKATCHEWAN COLLEGE OF PHYSICIANS AND SURGEONS —
REGULATORY BYLAW AMENDMENTS

The Regulatory Bylaws of the Saskatchewan College of Physicians and Surgeons are hereby amended as follows:

(1) Regulatory Bylaw 8.1(a) is amended by adding the following definition:

“(v) In this bylaw ‘**health care organization**’ has the meaning in *The Provincial Health Authority Act*.

‘Retaliating or discriminating against a person for taking part in regulatory proceedings’ includes any action taken by a physician against a person which has the effect of intimidating, retaliating against, coercing or imposing any loss or disadvantage against that person, or which may dissuade a reasonable person from taking part in proceedings under *The Medical Profession Act, 1981*, or from taking part in a physician regulatory activity of the provincial health authority or health care organization, which action was significantly influenced by the fact that the person has, or may:

- (i) make a complaint to the College, the provincial health authority or health care organization;
- (ii) provide information to the College, the provincial health authority or health care organization related to its regulatory activities;
- (iii) provide opinions or recommendations related to the regulatory activities of the College, the provincial health authority or a health care organization;
- (iv) participate in any other way in matters related to the regulatory activities of the College, the provincial health authority or a health care organization”.

(2) Regulatory Bylaw 8.1(b) is amended by adding the following paragraph after (xxi):

“(xxii) Retaliating or discriminating against a person for taking part in regulatory proceedings;”.
