Under authority of clauses 14(2)(i) and 23(3)(a), and in accordance with section 15(1) of *The Pharmacy and Pharmacy Disciplines Act*, the regulatory bylaws of the Saskatchewan College of Pharmacy Professionals are amended as follows:

Part N, section 11(2) of the Regulatory Bylaws which states: “Upon having received training as approved by Council, a licensed pharmacist may prescribe and a member may sell a Schedule I drug to a member of the public, in the absence of a prescription from a medical practitioner, when under emergency or urgent circumstances the pharmacist deems it to be in the best interests of the patient to provide a reasonable quantity of an oral contraceptive sufficient to meet the patient’s needs and a diagnosis or assessment by a practitioner for emergency contraception is not required, as the pharmacist is able to assess the patient’s needs for emergency contraception.” **is repealed.**
