FREE FISHING WEEKEND

WHEREAS many Saskatchewan citizens of all ages and from all walks of life enjoy fishing in Saskatchewan's 94,000 lakes, ponds, streams and rivers; and

WHEREAS the quality of fishing attracts anglers from far beyond our borders; and

WHEREAS programs are available to conserve and enhance fishing opportunities throughout Saskatchewan; and

WHEREAS angling contributes to the economic well being and the quality of life in Saskatchewan; and

WHEREAS the government wishes to ensure its citizens have an opportunity to learn about the traditional, recreational, social, cultural and economic benefits of angling.

NOW, THEREFORE, I, Dustin Duncan, Minister of Environment, do hereby issue a complimentary angling licence to every person present in Saskatchewan on July 14 and 15, 2018, and on February 16, 17 and 18, 2019, decreed as Free Fishing Weekends in the Province of Saskatchewan, where all may fish without charge.

ALTERATION OF BOUNDARIES – WAPITI REGIONAL LIBRARY

M.O. ED 02/2018-19. WHEREAS the City Council of Prince Albert, on March 26, 2018, passed Bylaw 10/2018 establishing the City of Prince Albert Municipal Library;

AND WHEREAS the Minister of Education wishes to exercise the authority pursuant to clause 4.3(4)(b) of *The Public Libraries Act, 1996* to change the boundaries of the Wapiti Regional Library by excluding the City of Prince Albert from the geographic area served by the Wapiti Regional Library Board;

AND WHEREAS the Minister has consulted with the parties affected by the within boundary change and the boards of the Wapiti Regional Library and the City of Prince Albert consent to the boundary alterations contained in this Order:

NOW THEREFORE, I, Gordon S. Wyant, Q.C., Minister of Education, pursuant to the authority vested in me by clause 4.3(4)(b) of *The Public Libraries Act, 1996*, do hereby order the following boundary changes, effective the date of this Order, in the manner set forth herein:
