SASKATCHEWAN COLLEGE OF RESPIRATORY THERAPISTS –  
REGULATORY BYLAW AMENDMENTS

**Pursuant to clause 16(1)(b) of *The Respiratory Therapists Act*, the regulatory bylaws of the Saskatchewan College of Respiratory Therapists are amended as follows:**

**Section 1 is amended to read:**

“1 These bylaws may be referred to as *The Respiratory Therapists Regulatory Bylaws 2018*”.

**Section 4 is amended to read:**

“4 An education program, approved by the council, at a respiratory therapy school accredited by the Council on Accreditation for Respiratory Therapy Education in Canada or by a similar organization approved by council, or a program deemed equivalent by the council, is prescribed for the purpose of clause 20(1)(c) of the Act”.

**Clause 6(b) is amended by repealing clause (b) and replacing it with “6(b) graduate practising membership”.**

**Section 9 is amended by repealing “Title” and replacing it with “Graduate Practising Membership”.**

**Subsection 9(1) is amended to read:**

“(1) Graduate practising membership is available to a person who meets the requirements of subsection 20(2) of the Act and the general requirements for membership set out in section 7 of these bylaws”.

**Subsection 9(2) is amended to read:**

“(2) Graduate practising membership entitles a person to the following privileges:”.

**Clause 9(2)(a) is amended to read:**

“(a) subject to obtaining a graduate practising licence, to practice respiratory therapy in Saskatchewan as a member in accordance with the conditions and restrictions attached to that licence and under the supervision of a full practising member;”.

**Clause 9(2)(b) is amended to read:**

“(b) to use the title “Graduate Respiratory Therapist” and the initials “GRT”;”.

“(a) is registered, or is eligible for registration, as a full practising member or graduate practising member; and”.

**Clause 11(2)(b) is amended to read:**

“(b) to have a voice, but no vote, at the meetings of the college”.

**Section 12 is amended to read “Honourary Membership”**



**Subsection 12(2) is amended and the spelling corrected to read:**

“(2) Honourary membership entitles a person to the following privileges:”

**Section 13 is repealed and replaced with:**

“13 For the purposes of subsection 21(4) of the Act, an applicant who wishes to appeal a decision of the registrar must apply in writing for a review by council within 30 days of receipt of the registrar’s decision”.

**Section 14 is amended to read:**

“14 Every practising member shall submit an application for a full practising licence or graduate practising licence to the college in accordance with these bylaws, together with the licence fee required pursuant to *The Respiratory Therapists Administrative Bylaws*”.

**Clause 15(1)(a) is repealed and replaced with:**

“(a) has worked in respiratory therapy activities approved by the council for at least 1,500 working hours during the previous four years; or”.

**Clause 15(1)(b) is amended to read:**

“(b) has graduated from an educational program described in section 4 within the previous three years”.

**Clause 15(2)(b) is repealed and replaced with:**

“(b) has worked in respiratory therapy activities approved by the council for at least 1,500 working hours during the previous four years or a prorated number of hours during the number of years since initial licensure”.

**Section 16 repealed and replaced with “Graduate practising licence”****Subsection 16(1) is repealed and replaced with:**

“(1) A graduate practising licence is available to a graduate member from the date of completion of the education program until the date when the member receives the results of the prescribed examination”.

**Subsection 16(2) is repealed and replaced with:**

“(2) If a member fails an examination, his or her graduate practising licence may be renewed for a period of time up to a maximum of two years after the initial date of issuance of the licence”.

**Section 19 is amended to read:**

“19 A member who does not qualify for continued licensure under subsection 15(2) may make an application for re-entry by providing the registration committee of the college with information sufficient for the committee to determine whether the member should be required to complete any academic upgrading, practical training, registration examination or another examination prior to obtaining a licence”.

**Section 20 is repealed and replaced with:**

“20 A practising member must be insured for at least \$2,000,000 against liability for professional negligence”.

**Section 21 is repealed and replaced with:**

“21 Every member shall comply with the most current version of the SCRT Code of Ethics as approved by the council and the membership”.

**Add new Section 22 - Standards of Practice**

“22 Every member shall comply with the most current version of the SCRT Standards of Practice as approved by council and the membership”.

**Subsection 22(1) is amended by repealing section 22(1) and replacing it with renumbered section 23(1):**

**“23(1)** A conflict of interest includes, but is not limited to, a situation in which:

**Clauses 22(1)(a) to (d) are renumbered as 23(1)(a) to (d) and amended to read:**

“(a) the member is involved in negotiating wages or employment contracts or completing performance appraisals for college staff who may be related to or practising with that member;

(b) the member is involved in determining or reviewing credentials and eligibility for registration or licensure of an applicant or another member who may be related to or practising with that member;

(c) the member is involved in the investigation or discipline process affecting another member who may be related to or who is, has been or may be practising with that member; and

(d) the member or their family member might personally or financially benefit from decisions or information gained from involvement on the council or committees”.

**Subsection 22(5) is renumbered and amended to read:**

**“23(5)** A member of the professional conduct committee or the discipline committee who has a conflict of interest in respect of a complaint shall recuse himself or herself from dealing with it, and the council may appoint a replacement to deal with the specific complaint with respect to which the conflict arose”.

**Subsection 22(6) is amended by repealing subsection 22(6) and replacing it with renumbered section 23(6):**

**“23 (6)** A member who has a conflict of interest must disclose the conflict but, if the member fails to disclose a conflict of interest, the conflict may be disclosed by anyone who has knowledge of it”.

**Subsection 23(1) is amended by repealing subsection 23(1) and replacing it with renumbered section 24(1):**

**“24(1)** On receipt of an allegation of professional incompetence or professional misconduct on the part of a member, the professional conduct committee shall.”

**Section 24 is renumbered and amended to read:**

**“25** Decisions of the discipline committee are matters of public interest and as such shall be reported in college publications and, where appropriate, to the member’s employer”.
